### **RECOMMENDED ACTION:**

Approve Ordinance 15-09 on First Reading and Schedule Second Reading on August 10, 2015.

### **Summary**

The City of Alachua establishes water, wastewater and reclaimed water rates to generate revenue sufficient to meet its operating expenses. The City of Alachua's water, wastewater, and reclaimed water rates were last modified in 2014 for the Fiscal Year 2015 budget process. Administration evaluates utility rates annually during the budget process and, if warranted, recommends rates be adjusted.

Staff utilizes models for developing water, wastewater and reclaimed water rates. The forecasts determine whether or not rates will produce revenues which are sufficient to meet the expenses associated with providing utility service to our residents.

Over the past five years, there has been a significant decrease in sales. The decrease is 15% water and 13% wastewater. Staff believes this can be attributed to the economic climate, efforts to heighten customer awareness of the need to conserve water as a resource, and the water conservation rate structure the City adopted in 2010.

Some of the City's costs for providing utility services have decreased as a result of decreasing sales. However, many of the City's costs to provide utility service are fixed, or have increases due to staffing, fuel, repair, etc. Debt service increased more than \$400,000 annually as a result of bringing the upgraded wastewater treatment facility on line. Staff proposes an increase in its water, wastewater, and reclaimed water rates to ensure the funds operate in a self-sustaining manner.

The Florida Public Service Commission (FPSC) publishes Water and Wastewater Price Index (attached). The prices establish a price increase or decrease for major categories of water and wastewater operating expenses. The intent of the price index is to identify the necessary adjustment that utility service providers should make to their rates to stay abreast of inflationary or deflationary pressures. The FY 2015-16 FPSC approved a water and wastewater price index of 1.57%.

Staff was not able to develop proposed water, wastewater, and reclaimed water rates by applying the FPSC Price Index. The proposed rate increase is 3%, to amend the water, wastewater, and reclaimed rates, which are identified in the attached ordinance. The proposed rates provide for changes to the customer charge and consumption charge as identified below:

### **ORDINANCE 15-09**

AN ORDINANCE OF THE CITY OF ALACHUA, FLORIDA; AMENDING THE FOLLOWING SECTIONS OF CHAPTER 38 OF THE CITY OF ALACHUA CODE OF ORDINANCES: SECTION 38-102{A)(1) INCREASING THE MONTHLY CUSTOMER CHARGE FOR EACH METERED POINT OF CONNECTION TO THE CITY WATER SYSTEM; SECTION 38-102(A)(3) INCREASING THE WATER CONSUMPTION CHARGE{S} FOR RESIDENTIAL, INCLUDING RESIDENTIAL IRRIGATION, AND NON-RESIDENTIAL (COMMERCIAL, INDUSTRIAL, FIRE LINE AND IRRIGATION) SERVICE; SECTION 38-140(A)(1) INCREASING THE MONTHLY CUSTOMER CHARGE FOR EACH METERED POINT OF CONNECTION TO THE CITY WATER SYSTEM; SECTION 38-140{A)(2) INCREASING THE WASTEWATER USAGE CHARGE{S}, TO INCREASE USAGE CHARGE(S) FOR THE RESIDENTIAL CUSTOMERS AND NON- RESIDENTIAL (COMMERCIAL AND INDUSTRIAL) CUSTOMERS; SECTION 38-141{A}(1) INCREASING THE MONTHLY CUSTOMER CHARGE FOR EACH METERED POINT OF CONNECTION TO THE CITY RECLAIMED WATER SYSTEM; SECTION 38-141(A){2} INCREASING THE RECLAIMED WATER USAGE CHARGE(S); PROVIDING FOR THE REPEAL OF ALL ORDINANCES IN CONFLICT; PROVIDING FOR INCLUSION IN THE CITY CODE; AND, PROVIDING AN EFFECTIVE DATE.

**WHEREAS**, the City of Alachua provides water, wastewater and reclaimed water services to residential and non-residential customers located within its water service territory; and,

**WHEREAS**, the current residential customer and non-residential charges for water, wastewater, and reclaimed water services are not adequate to cover the cost of providing such services, and,

**WHEREAS**, the City Commission, being fully advised of the facts and circumstances, hereby finds it necessary and in the interest of prudent management of public assets and business affairs to increase the current residential customer and non-residential charges for water, wastewater, and reclaimed water services in order to equitably and adequately fund the cost of such essential services, and,

**WHEREAS**, the City of Alachua Commission hereby amends Section 38-102(a)(1), Section 38-102(a)(2), Section 38-140(a)(1), Section 38-141(a)(1), and Section 38-141(a)(2) of the City of Alachua Code of Ordinances.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COMMISSION OF THE CITY OF ALACHUA, FLORIDA.

### SECTION 1. AMENDMENT OF CODE OF ORDINANCES

The following sections of Chapter 38 of the City of Alachua Code of Ordinances are hereby amended to read as follows:

### Section 38-102-Rates for Consumption of Water are hereby amended as set forth below.

(a) Rates. The rates to be assessed and collected from customers of water furnished by the City are hereby fixed as follows:

Water System Consumption Charges.

(1) Customer charge. Each customer must pay a customer charge for each metered point of connection to the City's water system.

(3) Water consumption charge(s). Each customer must pay for water consumed through each connection point based upon water service type:

### Section 38-140-Wastewater rates and charges are hereby amended as set forth below.

(a) Rates. There is hereby established a schedule of monthly rates and charges for the use of or availability for the use of wastewater collection, treatment, and disposal service which in part is based on the amount of water used from the City water system as measured by the customer water meter. Wastewater service charges shall be billed to and be the responsibility of the customer responsible for paying the water bill at any specific location. These rates will apply to all locations within the corporate City limits.

Wastewater system usage charges.

(1) Wastewater customer charge. Each customer must pay a wastewater customer charge for each metered (water meter) point of connection to the City water system.

### Section 38-141-Reclaimed water rates and charges are hereby amended as set forth below.

(a) Rates. There is hereby established a schedule of monthly rates and charges for the use of or availability for the use of reclaimed water. These rates will apply to all locations within the corporate City limits.

Reclaimed water system usage charges.

(1) Reclaimed water customer charge. Each customer must pay a reclaimed water customer charge for each metered point of connection to the City's reclaimed water system.

### SECTION 2. INCLUSION IN THE CODE

It is the intention of the City Commission of the City of Alachua, Florida, and it is hereby provided that the provisions of this ordinance shall become and be made a part of the Code of Ordinances of the City of Alachua, Florida; that the sections of this ordinance may be renumbered or relettered and that the word "ordinance" may be changed to "section", "article" or other appropriate designation to accomplish such intention.

#### **SECTION 3. REPEALING CLAUSE**

All ordinances or parts of ordinances in conflict with this ordinance are, to the extent they conflict with this ordinance, repealed.

### SECTION 4. PROVIDING FOR SEVERABILITY

It is the declared intent of the Alachua City Commission that, if any section, sentence, clause, phrase, or provision of this ordinance is for any reason held or declared to be unconstitutional, void, or inoperative by a court or agency of competent jurisdiction, such holding of invalidity or unconstitutionality shall not affect the remaining provisions of this ordinance and the remainder of this ordinance, after the exclusion of such part or parts, shall be deemed to be valid.







### SECTION 5-EFFECTIVE DATE

This Ordinance shall be effective on October 20, 2015.



**RECOMMENDED ACTION:** 

Adopt Ordinance 15-10 on First Reading

### **Summary**

The City of Alachua establishes electric rates to generate revenue sufficient to meet its operating expenses. These expenses include a monetary transfer to the City's general fund. Similar to most other electric utilities, the City of Alachua establishes base rates and an adjustment factor for each customer class – residential, general service (non-residential) non demand, and general service (non-residential) demand and large demand. The City of Alachua's electric rates were last modified in 2012. Staff now evaluates electric rates annually during the budget process and, if warranted, recommends that rates be adjusted. Staff maintains a computer model for developing its electric rates. The model forecasts bulk power costs, customers, and energy consumption to determine whether electric rates will produce revenues which are sufficient to meet the expenses associated with providing electric service to our residents. During the budget development process for the upcoming fiscal year, staff concluded that a slight increase in the energy charges is warranted for each customer class. Staff proposes a 1.5% increase for each rate class. The proposed, amended electric rates are identified in the attached ordinance.

An important part of rate making is ensuring that the City's utility rates are competitive with those of our peer groups. The State of Florida is served by nearly 50 electric service providers making establishment of an appropriate peer group challenging. Staff has selected the three (3) electric service providers that provide energy to City residents in its best peer group. They are Clay Electric Cooperative, Gainesville Regional Utilities (GRU), and Duke Energy . The Florida Municipal Electric Association (FMEA) maintains a comparison of all the municipally owned electric service providers in Florida and transmits it on a monthly basis. A copy of the May 2015 monthly residential electric rate comparison is attached. Note that the rate comparison utilizes the City's current electric rates.

On July 13, 2012 staff presented the proposed electric rate increases to the City Commission in a public workshop. The proposed FY 15-16 Electric System Budget reflects the projected revenues associated with the proposed rate increases. Additional background information related to the City of Alachua's electric rates and charges is discussed in the Electric Rate presentation.

AN ORDINANCE OF THE CITY OF ALACHUA, FLORIDA; AMENDING SECTION 38-170 RESIDENTIAL ELECTRIC SERVICE, SECTION 38-171 NON-RESIDENTIAL DEMAND SERVICE AND SECTION 38-172 NON-RESIDENTIAL, NON-DEMAND SERVICE; INCREASING THE BASE RATES FOR RESIDENTIAL ELECTRIC SERVICE, GENERAL SERVICE DEMAND, GENERAL SERVICE LARGE DEMAND AND GENERAL SERVICE NON-DEMAND; PROVIDING FOR THE REPEAL OF ALL ORDINANCES IN CONFLICT; PROVIDING FOR SEVERABILITY; PROVIDING FOR INCLUSION IN THE CODE; AND PROVIDING AN EFFECTIVE DATE.

NOW, THEREFORE, BE IT ORDAINED BY THE PEOPLE OF THE CITY OF ALACHUA, FLORIDA.


