7	WHEREAS, Section 12-22(d) of the Town Code of Ordinances (the "Town Code") sets		
8	forth the annual business tax due to the Town from businesses operating within the Town; and		
9	WHEREAS, Section 205.0535(5), Florida Statutes, provides that the governing body of a		
10	municipality may, by majority vote, adopt an ordinance establishing new rates that decrease local		
11	business taxes and do not result in an increase in local business taxes for a taxpayer; and		
12	WHEREAS, the Town desires to amend the business tax rate schedule in Section 12-22(d)		
13	of the Town Code to decrease business tax rates as set forth in the attached Exhibit "A".		
14 15 16	NOW THEREFORE, BE IT ORDAINED BY THE TOWN COMMISSION OF THE TOWN OF LAUDERDALE-BY-THE-SEA, FLORIDA, AS FOLLOWS:		
17	SECTION 1. Recitals. The foregoing "Whereas" clauses are ratified and confirmed as		
18	being true, correct and reflective of the legislative intent underlying this Ordinance and are hereby		
19	made a specific part of this Ordinance.		
20	SECTION 2. Approval of Business Tax Decreases. Section 12-22(d) of the Town Code		
21	is hereby amended by amending the business tax rate schedule to decrease business tax rates as set		
22	forth in the attached Exhibit "A".		
23	SECTION 3 . Conflicts. All sections or parts of sections of the Code of Ordinances, all		
24	ordinances or parts of ordinances and all resolutions or parts of resolutions in conflict herewith, be		
25	and the same, are hereby repealed to the extent of such conflict.		
26	SECTION 4. Severability. Should any section or provision of this Ordinance, or any		
27	paragraph, sentence or word, be declared by a Court of competent jurisdiction to be invalid, such

28	decision shall not affect the validity of the remainder hereof, as a whole or a part hereof, other than			
29	the part declared to be invalid.			
30	SECTION 5. Authority to Carry Out Business Tax Rate Changes. The appropriate			
31	Town officials are authorized to do all things necessary and expedient to carry out the aims of this			
32	Ordinance.
