The proposed rates for each of the street lighting classifications in the Hillsborough County Consolidated Street Lighting Special Purpose District (HCCSLSPD) are listed in the agenda material for Board consideration for the 2015 tax year. #### **Affordable Housing Services**

- A-1 A) Authorize Affordable Housing Services to provide the draft Substantial Amendment to the Program Years 2012, 2014 and 2015 Annual Action Plan for U. S. Department of Housing and Urban Development (HUD) funded programs for public comment and review. The required 30 day public comment period will be from September 7, 2015 to October 7, 2015; and B) Authorize Affordable Housing Services to schedule a public hearing on October 7, 2015 at 10:00 a.m. in order to receive additional public comments, close the public comment period, and adopt the Substantial Amendment for the PY 2012, 2014 and 2015 Annual Action Plan. There is no fiscal impact related to setting the public comment review dates and scheduling the Public Hearing.
- A-2 Realign \$4,797 within FY 12-13 and FY 13-14 Emergency Solutions Grant (ESG) Program of the U. S. Department of Housing and Urban Development in order to bring the budget in line with grant expenditures and to close out the grant. The realignment adjusts \$2,838 for administration and \$1,959 for the Rapid Re-Housing Program. This budget amendment realigns expenditures by \$4,797 within the Affordable Housing Services FY 12-13 and FY 13-14 ESG Program.
- A-3 A) Approve a Fourth Modification to HOME Investment Partnership Funding Agreement with Florida Home Partnership, Inc. for the Bayou Pass Phase IV & V Subdivision, an affordable housing development. (BOCC Doc 10-1016) This Modification reduces the number of HOME designated units in development to thirty (30) units. The total number of low income single family homes to be developed in the subdivision remains at 300 and will not change as a result of this modification. Approving this modification will allow the project to be successfully completed by the required deadline associated with the HOME Funding Agreement. B) Approve an Amended and Restated Land Use Restriction Agreement with Florida Home Partnership, Inc. for the Bayou Pass Phase IV & V Subdivision, an affordable housing development. This document ensures accuracy in the land use restrictions in accordance with the reduction of HOME designated units in the development from 100 to 30 homes. C) Approve a Second Modification to Mortgage and Note with Florida Home Partnership, Inc. for the Bayou Pass Phase IV & V Subdivision, an affordable housing development. This modification will ensure accuracy in repayment obligations based on the reduction of HOME designated units from 100 to 30 homes required to be constructed by December 31, 2015. There is no financial impact associated with this item.

#### **Aging Services**

- A-4 Approve the Nutrition Services Incentive Program (NSIP) Standard Contract #NSIP-15/16-HILL with the Senior Connection Center, Inc. which authorizes the Aging Services Department to receive cash, at the established rate of \$0.72 per meal, in lieu of commodities, for the grant period of October 1, 2015 through September 30, 2016. The total contract reimbursement amount is \$333,987.84 for a maximum of 463,872 meals. This contract begins October 1, 2015 and ends March 31, 2016. Funding for this contract is included in Aging Services' FY 16 tentative grants operating budget. No County funds are required.
- A-5 A) Approve Amendment 003 to the Home Care for the Elderly (HCE) Standard Contract # HCE 14/15-HILL with the Senior Connections Center, Inc. effective July 1, 2014 through September 30, 2015. The purpose of this amendment is as follows: 1) Increase Section 3, Contract Amount, by \$1,413; 2) Increase Section 5, Source of Funds, by \$1,413, and 3) Revise and replace Attachment III, Budget Summary. B) Approve FY 15 budget amendment to appropriate \$1,413 in State General Revenue grant funds in accordance with Amendment 003 of the HCE 14/15-HILL contract. This budget amendment will increase Aging Services' FY 15 grant operating budget by \$1,413 to align with the HCE total program budget of \$380,397 of which \$363,618 is State General Revenue grant funds and \$16,779 is additional County support. Of the \$363,618 in State General Revenue grant funds, \$59,502 is allocated to Hillsborough County to provide case management services and \$304,116 is allocated as a spending authority for subsidies for caregivers to continue in-home care.

- A-6 Approve FY 15 budget amendment to increase program income by \$3,000 within the Community Care for the Elderly Program to fully expend the funds and close out the grant. Program income was budgeted at \$73,579; however, the County collected \$76,579, resulting in a \$3,000 variance between what was collected for the program through contributions and donations and the amount that was budgeted. This FY 15 budget amendment will increase Aging Services' grant operating budget by \$3,000 to align with what was collected in contributions and donations, which will allow the County to fully expend the funds and close out the grant.
- A-7 Approve FY 15 budget amendment to increase program income by \$8,043 within the 2014 Older Americans Act Program to fully expend the funds and close out the grant. Program income was budgeted at \$12,136 for congregate meal services; however, the County collected \$20,179, resulting in an \$8,043 variance between what was collected for the program through contributions and donations and the amount that was budgeted. This FY 15 budget amendment will increase Aging Services' grant operating budget by \$8,043 to align with what was collected in contributions and donations for congregate meal services, which will allow the County to fully expend the funds and close out the grant.

#### **Code Enforcement**

A-8 Approve the release of the demolition lien assessed by Resolution #R14-030 in the amount of \$8,534.98 plus interest for a total of \$9,157.16 against the property located at 6910 Spencer Circle, Tampa FL 33610-5616, Folio #041411.0000 for the costs incurred by the County for the demolition and removal of a deteriorated structure and removal of trash, junk and debris. Property owner has paid in full all demolition costs incurred with removing the structure(s) and a release of lien is being requested.

#### **County Attorney's Office**

A-9 A) Authorize the Chair of the Hillsborough County Board of County Commissioners (BOCC) to sign the attached commitment to participate in the Welcoming Cities and Counties Project. B) Approve a Board Resolution that declares Hillsborough County to be a Welcoming Community. There are no anticipated current financial impacts from becoming a welcoming community as proposed. However, potential future program design/strategy changes could result in additional direct and indirect financial impacts.

#### **Economic Development**

- A-10 Adopt a resolution recommending that the Tampa Hillsborough Economic Development Corporation's (EDC) Prospect #15-273 (the 'Prospect') be approved as a Qualified Target Industry Business pursuant to Florida's Qualified Target Industries (QTI) Tax Refund Program, and providing up to \$44,800 of local financial support, a portion of which is a local match associated with the Prospect's eligibility for the State's QTI High Impact Sector Bonus under the headquarters sector classification, for the expansion of a headquarters operation in the City of Tampa which is expected to create 64 new, higher-wage, quality jobs. The maximum cost to the County for this QTI applicant is \$44,800 spread over a minimum of six years, beginning in FY 17. Funding for this initiative will be included in the Countywide Economic Development Activity Fund in the Economic Development Department's FY 17 planned budget. No additional County funds are required. Subject to approval of such budget and future budgets and appropriations, funding will be provided for this initiative through FY 24.
- A-11 Adopt a resolution which, among other things, (i)authorizes the conveyance of certain equipment acquired by the University of South Florida Research Foundation, Inc. (the 'Foundation') with proceeds of a County grant pursuant to the Bioscience Research and Development Institute Grant Disbursement Agreement with the Foundation for the Draper research and development project, to the Charles Stark Draper Laboratory, Inc. ('Draper') at the value of \$238,945.00, of which \$15,000.00 represents the fair market value of a portion of such equipment that is currently unaccounted for; (ii) authorizes the conveyance of the balance of the equipment acquired by the Foundation for the Draper research and development project to the Foundation absent monetary consideration to foster economic development and research activity on the Tampa campus of USF, and (iii)

- approves the termination of the Foundation Agreement upon the conveyance of all of the referenced equipment. Funding will increase the General Fund budget by \$238,945.00.
- A-12 Approve the Historic Preservation Challenge Grant Award Agreement with The Friends of Henry B. Plant Park, Inc. (Grantee) in the amount of \$25,000 for an upgraded irrigation system in the Henry B. Plant Park. The waterfront park is part of the Plant Hotel (University of Tampa, Plant Hall), listed on the National Register of Historic Places and a Local Historic Landmark. Funding for the Agreement, in the total amount of \$25,000, was approved by the Board on August 5, 2015, as part of the 2015 round of funding for the Historical Preservation Matching Fund Project which is included in the Adopted FY 15 FY 19 Capital Improvement Program. These funds are administered by the Economic Development Department. (C77796000, Historical Preservation Matching Fund Program)
- A-13 Approve the Historic Preservation Challenge Grant Award Agreement with The Tampa Crossroads, Inc. (Grantee) in the amount of \$83,500 for rehabilitation of Rose Manor in the Local Historic District of Tampa Heights. Funding for the Agreement, in the total amount of \$83,500, was approved by the Board on August 5, 2015, as part of the 2015 round of funding for the Historical Preservation Matching Fund Project, which is included in the Adopted FY 15 FY 19 Capital Improvement Program. These funds are administered by the Economic Development Department. (C77796000, Historical Preservation Matching Fund Program)
- A-14 Approve the Historic Preservation Challenge Grant Award Agreement with St. Paul Lutheran Church of Tampa Florida, Inc. (Grantee) in the amount of \$18,250 in FY 15 for the 'St. Paul Lutheran Church Restoration Project' Phase 2, to continue exterior restoration work. The property, located at 5103 North Central Avenue, Tampa, FL, is in the Local Historic District of Seminole Heights. Funding for the Agreement, in the total amount of \$18,250 was approved by the Board on August 5, 2015, as part of the 2015 round of funding for the Historical Preservation Matching Fund Program, which is included in the Adopted FY 15 FY 19 Capital Improvement Program. These funds are administered by the Economic Development Department. (C77796000 Historical Preservation Matching Fund Program)

#### **Fire Rescue**

- A-15 Appropriate \$254,580 from the FY 15 State of Florida, Division of Emergency Management in County in-kind matching funds within the Fire Rescue Department's State of Florida, Division of Emergency Management Performance Grant (EMPG). The Grant agreement was approved by the Board of County Commissioners on June 17, 2015. This appropriation increases the FY 15 Fire Rescue Department's EMPG budget by \$254,580 in state grant funds and \$254,580 in County in-kind matching funds.
- A-16 Appropriate \$105,806 from the FY 15 State of Florida, Division of Emergency Management, Emergency Management Preparedness and Assistance (EMPA) Grant agreement 16-BG-83-08-39-01-028, within the Fire Rescue Department's State of Florida, Division of Emergency Management EMPA grant budget. The Grant agreement was approved by the Board of County Commissioners on June 17, 2015. This appropriation increases the FY 15 Fire Rescue Department's EMPA budget by \$105,806 in state grant funds.
- A-17 Approve budget amendment to appropriate \$20,000 from the FY 14 Homeland Security Grant award from the State of Florida, Division of Emergency Management to purchase the renewal of the ETEAM software maintenance subscription. This software is used to help perform various situational awareness, planning, operational, logistical and financial functions for planning, training and exercises for local emergency management departments. The agreement shall begin upon execution by both parties and end on December 31, 2015. This budget amendment increases the Fire Rescue FY 15 Homeland Security Grant budget by \$20,000 (from \$-0- to \$20,000).

#### **Fleet Services**

A-18 Declare as surplus and authorize disposal of 13 items of vehicles and equipment, and further authorize the Clerk of the Circuit Court to remove the property on the attached list from the inventory asset record. Disposal of

- property will be offered for sale by public auction to the highest bidder or sold to another public entity or municipality in accordance with BOCC Policy 08.01.01.02 and Florida State Statute (Section 274.06).
- A-19 FY 15 Budget Amendment resolution to appropriate \$350,000 from the Fleet Operating Fund reserves to the Fleet Operating Fund to support Fiscal Year closure of payroll costs. This budget amendment appropriates \$350,000 from the current Fleet Operating Fund reserves to support: a) Approved FY 14 reclassifications of Fleet Service Advisors, Fleet Accounting Clerk III, creating a Fleet Technician Broad Band, reclassifying Fleet Senior Equipment Technicians, and reclassifying Fleet Technician Supervisors; b) projected FY 15 overtime expenses and related benefits to meet customer requirements; c) pay out of one retired Fleet employee, and d) hiring three qualified personnel above minimum and up to mid-point pay rate. The current Fleet Operating Fund Reserve balance will be reduced from \$2,109,928 to \$1,759,928 and will be readjusted after the FY 15 budget year close out. The remaining fund reserve balance of \$1,759,928 is adequate to support projected FY 16 and beyond requirements.

#### **Head Start/Early Head Start**

A-20 Approve a budget amendment to realign \$838,773 in personnel services and capital outlay expenditures within the FY 15 Head Start/Early Head Start grants in the Head Start Department's adopted FY 15 budget for replacement of seven (7) aged school transportation mini-buses and classroom computer learning centers, and to purchase additional computer learning centers and interactive whiteboards. No additional County funds are required.

#### **Management and Budget**

- A-21 Approve a budget amendment to increase the budget for Tax Collector commissions in the three Tourist Development Tax funds in order to pay projected final FY 15 invoices. The increases are required due to two factors: 1) A change in accrual accounting practices by the Clerk of the Circuit Court will result in 13 months of commissions being incurred in FY 15, rather than 12 months of commissions. This is anticipated to be a one-time occurrence; and 2) Actual FY 15 revenues are anticipated to be significantly higher than budget, resulting in projected Tax Collector commissions exceeding budget, despite the fact that the commission budget in each fund includes a cushion to account for higher than anticipated revenues. If approved, the budget for commissions in the 3 Cents Tourist Development Tax fund will increase by \$30,000 -from \$112,254 to \$142,254; the budget for commissions in the 4th Cent Tourist Development Tax fund will increase by \$10,000 from \$35,418 to \$45,418; and the budget for commissions in the 5th Cent Tourist Development Tax fund will increase by \$10,000 from \$35,418 to \$45,418. These increases will be offset by a corresponding decrease in each fund's reserve for contingency.
- A-22 Receive the report regarding the Status of Reserves for Contingency in the Tax Fund FY 15 as of August 20, 2015.

#### **Parks and Recreation Services**

A-23 Approve the dedication and naming of the back portion of Logan Gate Village Park for Mr. Don Hardy, former president of the Logan Gate Village Tax District. Local citizens presented the request to the Parks Advisory Board, which approved the request on May 29, 2015. There is no financial impact as a result of this action. Any cost associated with the dedication can be absorbed within the Parks and Recreation Department's FY 15 budget.

#### **Procurement Services**

A-24 Ratify the emergency procurement of supplemental stormwater infrastructure maintenance and construction services from QRC, Inc., QGS Development, Inc., and Pepper Contracting Services, Inc., at a not-to-exceed cost of \$250,000.00 each contract, effective August 19, 2015, and continuing through November 30, 2015, for the

Public Works Department. On August 19, 2015, the County Administrator approved an emergency award to three (3) experienced firms to expedite the remediation of critical stormwater structures and systems throughout the County. Due to the urgency of the work to be performed, services will be self-performed by the three (3) vendors; however, Disadvantaged Minority/Disadvantaged Women Business Enterprises firms will be used to the extent possible. The Public Works Department reviewed the offered rates of pay and finds them fair and equitable based on the most recent competitive bid pricing received with ITB-C-0089-0-2015/TJS and Florida Department of Transportation approved labor and equipment rates. Funding for these agreements is included in the requesting department's budget. Purchase order will only be issued against approved budgets.

- A-25 Award and execute an agreement with the lowest, responsive, and responsible bidder, Alpha Excavating & Equipment Rental, Inc., in the amount of \$207,153.00 to perform demolition services by a registered Hillsborough County Small Business Enterprise (SBE) (ITB-C-0150-0-2015/ST) for the Real Estate and Facilities Services Department. This agreement will be in effect for a two (2) year period beginning on the effective date shown on the purchase order. This project consist of general building demolition and site clearing to include, but not limited to, demolition and removal of existing structures, removal of residential and light commercial buildings, utilities, foundations, footers, steps, slabs, vegetation, sidewalks, entrance marquees, accessory structures, swimming pools, inoperable vehicles, trash, junk, debris, concrete and asphalt driveways, overgrowth, and all associated work. This agreement is an SBE Set-Aside and will be utilized on an as needed basis. Bids were received from four (4) different vendors. Funding will come from allocated R3M fund balance. Purchase orders will be issued only against approved budgets.
- A-26 Award and execute an agreement with the lowest, responsive, and responsible bidder, Cypress Construction and Coatings, Inc., (CCC) in the amount of \$416,169.70 for the cleaning, restoration, and seal coating of two primary wastewater settling tanks located at the River Oaks Wastewater Treatment Plant (ITB-C-0090-0-2015/JM) for the Public Utilities Department (PUD). The County's Disadvantaged Minority/Disadvantaged Women Business Enterprise (DM/DWBE) Goal Setting Committee did not establish a DM/DWBE participation goal for this project. There are a limited number of vendors that met PUD standards and are included on the Approved Products & Materials Applications List, none of which were certified DM/DWBE firms. This agreement involves the restoration of two primary wastewater settling tanks that perform the initial treatment of the wastewater intake at the River Oaks Plant. These two tanks must be repaired and restored in an effort to maintain the tanks' integrity in order to avoid the potential for violations and fines that could be levied by the Department of Environmental Protection. Bids were received from four (4) different vendors. There are sufficient funds in the department's Enterprise Fund made available through the project budget CIP No. 10745.

#### **Public Utilities**

A-27 Approve the First Modification to the contract with McKim & Creed, Inc. for DCP Services for the NWRWRF Expansion Project CIP No. 10239 to provide funding for additional master planning, permitting efforts and related DCP services in order to further mitigate County risk and expedite project delivery. This modification increases the Agreement limits by \$377,110.00 from \$1,494,160.00 to \$1,871,270. This modification does not increase the total budgeted project cost or affect the BOCC promise date.

#### **Public Works**

A-28 Approve Change Order No. One (1) Final to the construction contract with Florida Safety Contractors, Inc. for North West County Pedestrian Crossings & Intersection Signalization Upgrades Project, decreasing the contract amount by \$43,388.95, from \$487,506.80 to \$444,117.85 and extending the Final Completion milestones by sixty-eight (68) calendar days. The revised final completion milestone date is therefore May 15, 2015.

using the attached Bid Proposal document and Contract for Purchase and Sale. This property was formally the location of the Nine Eagles wastewater treatment plant. The existing improvements have been removed and the site is currently vacant. The Public Utilities Department has determined that the site is no longer necessary, useful or profitable to the operation of their system and requested that it be declared surplus. One time revenue in the approximate amount of \$20,000 is anticipated from this sale of County-owned surplus property.

B) Authorizing good faith presuit negotiations and the acquisition of such properties and associated property rights by eminent domain proceedings, if necessary, for the project. The purpose of these resolutions is to determine a reasonable necessity to acquire property for a public purpose and to authorize Hillsborough County to exercise the power of eminent domain. Acquisition of Parcels 103, 112R, 113, 114, 118/718, 119R, 121, 125R, 126 and 156/756 can be adequately accommodated within the currently approved FY 15 Capital Improvement Budget. All property owners for the referenced parcels have been notified about the proposed acquisitions.
- A-31 Approve an Amendment to License Agreement with TECO to expand the existing area used for the parking of vehicles and storage of construction materials on TECO property located at 520 TECO Road in the Ruskin/Sun City area. The area under license agreement will be used in support of the Public Utilities Department's (PUD) construction of wastewater treatment improvements for CIP# 10143 South County Advanced Wastewater Treatment Plant. The present \$3,000.00 annual license fee will be increased by \$1,708.00, bringing the combined license fee to \$4,708.00 annually, for the year ending February 29, 2016. #### **Development Services**

B-1 11:00 AM (Time Certain) Adopt a Resolution amending the fee schedule for Building and Construction Services in order to support economic development by providing for a limited duration 45% reduction in fees for building and construction-related permit applications and applications for service filed on or before December 31, 2015, and a limited duration reduction of 35% for applications filed between January 1, 2016 and December 31, 2016 and providing for amendments to the fee schedule for private provider fees for commercial projects. The Building Services Fund will close FY 15 with a projected fund balance of approximately \$2.3 million. Approval of this agenda item will result in a projected fund balance of approximately \$2 million by December 31, 2016. During the term of this fee reduction, the Building Services Fund will continue to maintain sufficient funds to cover operating expenses and maintain financial stability within the fund.

#### **Head Start/Early Head Start**

B-2 Approve the Head Start (HS) 2015-2016 State of Florida Statewide Voluntary Prekindergarten (VPK) Provider Contract with the Early Learning Coalition of Hillsborough County (ELCHC) for qualified children being served in the HS program during the 2015-2016 VPK School Program Year which begins July 29, 2015, or the executed agreement date, whichever occurs last, and expires upon completion or termination of all Provider's VPK program year programs eligible to be offered under this Agreement. Annual VPK revenue projections and program expenditures of \$1,180,000 are included in each year of the adopted FY 15 - FY 16 budget of the Head Start / Early Head Start Department based on estimated annual enrollment and attendance of approximately 500 VPK qualified HS children. No matching funds or increased County funds are required.

#### **Procurement Services**

B-3 Select and execute a negotiated Construction Manager At-Risk agreement with the highest ranked firm, Bandes Construction Company, Inc., in the amount of \$1,545,000.00 for expansion of the Town N' Country Recreation Center (RFP-C-0108-0-2015/DV) for the Real Estate and Facilities Services Department. The Town N' Country project involves construction of a 5,700 sq. ft. one-story recreation building adjacent to the existing gymnasium building and limited renovations within the existing building. The Disadvantaged Minority/Disadvantaged Women Business Enterprise/Small Business Enterprise (DM/DWBE/SBE) Goal Setting Committee established a DM/DWBE Program Participation Goal of 16%, and the recommended vendor has committed to achieving this goal. The Procurement Services Department further recommends rejecting the proposal submitted by R. Krueger Construction Inc. (R. Krueger), which is deemed non-responsive for failing to provide required pricing. Failing to provide required pricing is a material deviation that, if waived, would adversely impact both potential and competing vendors. Proposals were received from four (4) different vendors. Funds are available within the adopted FY 15-19 Capital Improvement Program (CIP No. C83224000).

#### **Public Utilities**

B-4 Realign \$3,620,030 within various Public Utilities Department project funds to provide adequate funding levels for Capital Improvement Projects for FY15 and to align budgets with projections and expenditures. This quarterly realignment process realigns \$3,620,030 within the Public Utilities Department Fund and is in the following four funds: 1) \$466,342 from 40104 Utility System Renewal and Replacement Account; 2) \$3,038,872 from 40105 Utility System General Revenue Capital Expenditures; 3) \$210 from 40123 Utility System Renewal and

Replacement Account B; and 4) \$114,606 from 40125 Series 10B Taxable Build America Bonds Revenue Bonds Project Fund.
