WHEN THE ITEM IS ADDRESSED, THE COUNCIL'S OPEN MEETING IN THESE CHAMBERS SHALL TEMPORARILY RECESS, AND THE ELECTED OFFICIALS SHALL CONVENE IN CLOSED SESSION IN THE MAYOR'S CONFERENCE ROOM UPSTAIRS FOR THE PURPOSE OF SUCH QUESTIONS OR PRESENTATIONS. THE ONLY PERSONS AUTHORIZED TO ATTEND THE CLOSED SESSION SHALL BE ELECTED OFFICIALS, THE CHIEF ADMINISTRATIVE OFFICER, THE CITY ATTORNEY, THE CITY CLERK, THE HEAD OF THE DEPARTMENT SPONSORING THE PROCUREMENT, AND THE PROSPECTIVE VENDOR. THE CLOSED SESSION SHALL BE RECORDED AND NOTHING WILL BE OFF THE RECORD.
