6 BUSINESS REGULATIONS; AMENDING CHAPTER 250
7 *ORDINANCE CODE*; AMENDING PART 12 (MOBILE FOOD
8 DISPENSING VENDOR); AMENDING SECTION 250.1201
9 (LICENSES AND PERMITS; MOBILE FOOD DISPENSING
10 VENDOR AREAS), SUBSECTION (E) (7), TO REQUIRE
11 THE WRITTEN CONSENT OF SIMILAR BUSINESSES
12 LOCATED WITHIN 50 FEET OF THE PROPOSED MOBILE
13 FOOD DISPENSING VENDOR; PROVIDING AN EFFECTIVE
14 DATE.

16 **BE IT ORDAINED** by the Council of the City of Jacksonville:

17 **Section 1. Chapter 250 (Miscellaneous Business**
18 **Regulations), Ordinance Code, amended.** Chapter 250 (Miscellaneous
19 Business Regulations), *Ordinance Code*, is hereby amended to read as
20 follows:

21 **CHAPTER 250 MISCELLANEOUS BUSINESS REGULATIONS**

23 **PART 12. - MOBILE FOOD DISPENSING VENDORS**

24 **Sec. 250.1201. - Licenses and permits; Mobile Food Dispensing**
25 **vending areas.**

27 (e) Except where already designated in the Downtown Area and City
28 Parks as set forth in Sections 250.1203 and 250.1204 of this
29 Part, a Mobile Food Dispensing Vendor is not allowed to
30 locate:

31 * * *

1 (7) Within 50 feet from a brick and mortar business or on any
2 property on which is located any established permanent
3 business which sells the same types of products or services as
4 requested to be sold by the Mobile Food Dispensing Vendor,
5 unless the property owner or business owner of the established
6 permanent business provides written consent to allow the
7 Mobile Food Dispensing Vendor to locate and operate on the
8 established permanent business(es)' property or unless all
9 similar businesses located within 50 feet of the proposed
10 Mobile Food Dispensing Vendor location provide written
11 consent.

13 **Section 2. Effective Date.** This ordinance shall become
14 effective upon signature by the Mayor or upon becoming effective
15 without the Mayor's signature.
