Affordable Housing Services

- A-1 Approve a Second Modification to CDBG Funding Agreement with The Housing Authority of the City of Tampa for the rehabilitation of Palm Terrace Apartments, a multi-unit residential assisted-living facility. The rehabilitation of this assisted living facility is being undertaken to provide suitable housing to low and moderate income persons 55 years of age and older. This modification is required in order to allow additional time for project completion. This modification will not increase the funding amount. There is no financial impact associated with this modification.
- A-2 Approve an Agreement with The Centre for Women, Inc., to provide housing rehabilitation assistance to very low, low and moderate income persons with special needs in Unincorporated Hillsborough County in the amount of \$150,000. The term of this agreement is from July 1, 2016 to August 15, 2017. Total funding of \$150,000 for this Agreement is available in the Affordable Housing Services adopted FY 16 State Housing Initiatives Partnership Program (SHIP) Grant Fund.
- A-3 Approve an Agreement with Rebuilding Together Tampa Bay, Inc., to provide housing rehabilitation assistance to very low, low and moderate income persons with special needs in Unincorporated Hillsborough County in the amount of \$150,000. The term of this agreement is from July 1, 2016 to August 15, 2017. Total funding of \$150,000 for this Agreement is available in the Affordable Housing Services adopted FY 16 State Housing Initiatives Partnership Program (SHIP) Grant Fund.
- A-4 Approve an Agreement with Self Reliance Inc., to provide housing rehabilitation assistance to very low, low and moderate income persons with special needs in Unincorporated Hillsborough County in the amount of \$150,000. The term of the agreement is from July 1, 2016 to August 15, 2017. Total funding of \$150,000 for the Self Reliance Inc. Agreement is available in the Affordable Housing Services adopted FY 16 State Housing Initiatives Partnership Program (SHIP) Grant Fund.
- A-5 Approve budget amendment to increase the FY 15-16 State Housing Initiative Program (SHIP) grant revenue and expenditures appropriations by \$556,177 in order to bring the budget in line with actual revenue received. This budget amendment increases the total FY 15-16 SHIP Grant by \$556,177 from \$4,800,840 to \$5,357,017. The State awarded \$75,415 to Hillsborough County from unused SHIP disaster funds. The remaining \$480,762 was collected from unanticipated program income to the County from interest income paid by approved SHIP funded multi-family affordable housing projects. The revenue collected will be allocated for multi-family rehabilitation construction.
- A-6 Partial Releases Approved by the Director of Affordable Housing Services, Third Quarter - 2016 Report.

Aging Services

- A-7 Approve FY 16 budget amendment to appropriate \$27,797 of state general revenue in the FY 14 Hillsborough County Summer Food Service Program to close out the grant. This grant is funded entirely by the Florida Department of Agriculture and Consumer Services and this appropriation is needed to carry forward funds into the current grant year to close out the grant. The Florida Department of Agriculture and Consumer Services provides funding for local governments to provide nutritious lunches and afternoon snacks to disadvantaged children during the summer months. This budget amendment increases Aging Services' FY 16 grant operating budget by \$27,797. No additional County funds are required.

Code Enforcement

- A-8 Approve the release of the demolition lien assessed by Resolution #R15-118 in the amount of \$3,603.34 against the property located at 19108 Livengood Rd., Lutz FL 33559, Folio #033538.0000 for the costs incurred by the County for the demolition and removal of a deteriorated structure and removal of trash, junk and debris. Property owner has paid in full all demolition costs incurred with removing the structure(s) and a release of lien is being requested.
- A-9 Approve a resolution assessing a lien in the amount of \$6,554.50 against the property located at 91 7th Street NE, Ruskin FL 33570 folio #055926.0000 for the cost incurred by the County for demolition and removal of a dilapidated structure and removal of trash, junk and debris. The \$6,554.50 incurred to demolish and remove the dilapidated structure was funded from the Code Enforcement FY 16 budget. Upon sale of the property, reimbursement of all costs will be sought. Should the lien be unsatisfied after the expiration of two years from the date of filing, the proper County personnel will investigate enforcement of the lien by foreclosure action.
- A-10 Approve a resolution assessing a lien in the amount of \$5,990.50 against the property located at 12924 Worchester Ave., Tampa FL 33624 folio #019221.0500 for the cost incurred by the County for demolition and removal of a dilapidated structure and removal of trash, junk and debris. The \$5,990.50 incurred to demolish and remove the dilapidated structure was funded from the Code Enforcement FY 16 budget. Upon sale of the property, reimbursement of all costs will be sought. Should the lien be unsatisfied after the expiration of two years from the date of filing, the proper County personnel will investigate enforcement of the lien by foreclosure action.
- A-11 Approve a resolution assessing a lien in the amount of \$11,620.25 against the property located at 18801 N. US Highway 41, Lutz FL 33549 folio #013961.0000 for the cost incurred by the County for demolition and removal of a dilapidated structure and removal of trash, junk and debris. The \$11,620.25 incurred to demolish and remove the dilapidated structure was funded from the Code Enforcement FY 16 budget. Upon sale of the property, reimbursement of all costs will be sought. Should the lien be unsatisfied after the expiration of two years from the date of filing, the proper County personnel will investigate enforcement of the lien by foreclosure action.
- A-12 Approve a resolution assessing a lien in the amount of \$7,190.00 against the property located at 12222 Begin Dr., Riverview FL 33579 folio #077690.5158 for the cost incurred by the County for demolition and removal of a dilapidated structure and removal of trash, junk and debris. The \$7,190.00 incurred to demolish and remove the dilapidated structure was funded from the Code Enforcement FY 16 budget. Upon sale of the property, reimbursement of all costs will be sought. Should the lien be unsatisfied after the expiration of two years from the date of filing, the proper County personnel will investigate enforcement of the lien by foreclosure action.
- A-13 Appropriate \$382,000 increase in anticipated revenue generated from property registration fees during FY 16. These funds will be used to compensate the Board approved foreclosed property vendor, Community Champions, for higher than projected revenue collections. This budget amendment increases revenue by \$382,000 (from \$3,500,000 to \$3,882,000) with an offsetting increase in Other Professional Services (from \$1,350,000 to \$1,732,000).

Conservation and Environmental Lands Management

- A-14 Accept the 2015 Jan K. Platt Environmental Lands Acquisition and Protection Program (ELAPP) Annual Report, approve the listing of projects for acquisition and protection and authorize staff to pursue the acquisition and protection of the listed projects, including the expenditure of up to \$250,000 on appraisals and other related research required for negotiations. Cost of appraisals and other related research required for negotiations will be funded through existing funds. This action does not increase the budget for the ELAP Program. There are no capital costs or other operating expenses associated with this action. All capital and operating costs, including funding the purchase price, will be addressed at the time an acquisition contract is presented to the Board for approval.

The County Attorney's Office has determined that the hourly rates and prices set forth in each contract are fair and reasonable. The Economic Development Department did not have three (3) Disadvantaged Minority/Disadvantaged Women Business Enterprise (DM/DWBE) firms or three (3) Small Business Enterprise (SBE) firms registered for the specified services; therefore no DM/DWBE participation goal or SBE set-aside was established and included in the Request for Qualifications solicitation for the above-referenced services. The fiscal impact of this Agenda Item can be adequately accommodated within the currently approved FY-16 budget and the outside counsel general funds funding level through FY-17.
- A-16** Approve and award professional legal services agreements with the following law firms to provide specialized legal services to Hillsborough County in matters involving mortgage foreclosure defense litigation: 1) Weidner Law; and 2) DeWitt Law Firm, P.A. The resulting contracts will be effective on the date of Board approval and shall continue for a one (1) year period with automatic renewals of four (4) successive one (1) year periods. The County Attorney's Office has determined that the contingency fee arrangement set forth in each contract is fair and reasonable. The Economic Development Department did not have three (3) Disadvantaged Minority/Disadvantaged Women Business Enterprise (DM/DWBE) firms or three (3) Small Business Enterprise (SBE) firms registered for the specified services; therefore no DM/DWBE participation goal or SBE set-aside was established and included in the Request for Qualifications solicitation for the above-referenced services. The fiscal impact of this Agenda Item can be adequately accommodated within the currently approved FY-16 budget and the outside counsel general funds funding level through FY-17.
- A-17** Authorize the County Attorney's Office to draft ordinance language that would address the issue of abandonment of animals on private property. There is no financial impact to the County to amend the ordinance except for the cost to publish and advertise the required legal notice.
- A-18** Approve the Pro-Rata Litigation Fee Agreement between Hillsborough County, Lexington Insurance Company, and the law firm of Butler Pappas Weihmuller Katz & Craig, LLP. No financial impact to County other than a pro-rata share of costs and attorney's fees but only in the event of a recovery on behalf of the County and never to exceed the amount of the County's recovery.

Economic Development

- A-19** Adopt a resolution recommending that the Tampa Hillsborough Economic Development Corporation's (EDC) Prospect #15-153 (the 'Prospect') be approved as a Qualified Target Industry Business pursuant to Florida's Qualified Target Industries (QTI) Tax Refund Program, and providing up to \$45,000 of local financial support, for the expansion of an engineering operation in the City of Temple Terrace which is expected to create 150 new, higher-wage, quality jobs. The maximum cost to the County for this QTI applicant is \$45,000 spread over a minimum of five years, beginning in FY 18. Funding for this initiative will be included in the Countywide Area Economic Development Activity Funds in the Economic Development Department's FY 18 planned budget. No additional County funds are required. Subject to approval of such budget and future budgets and appropriations, funding will be provided for this initiative through FY 24.

- A-20 Adopt a resolution recommending that the Tampa Hillsborough Economic Development Corporation's (EDC) Prospect #16-211 (the 'Prospect') be approved as a Qualified Target Industry Business pursuant to Florida's Qualified Target Industries (QTI) Tax Refund Program, and providing up to \$60,000 of local financial support, for the establishment of a professional services operation in unincorporated Hillsborough County which is expected to create 100 new, higher-wage, quality jobs. The maximum cost to the County for this QTI applicant is \$60,000 spread over a minimum of five years, beginning in FY 18. Funding for this initiative will be included in the Countywide and Unincorporated Area Economic Development Activity Funds in the Economic Development Department's FY 18 planned budget. No additional County funds are required. Subject to approval of such budget and future budgets and appropriations, funding will be provided for this initiative through FY 24.
- A-21 Approve Hillsborough County Film & Digital Media Incentive Award Agreement between Hillsborough County and Letters The Film, LLC, in the not to exceed amount of \$25,000 to assist in securing the local filming of the motion picture, 'No Postage Necessary,' thus generating employment and business opportunities in the County. Funding for this Agreement is included in the Economic Development Department's FY 16 adopted budget within the Countywide Economic Development Activity Fund - Major Films Incentive Fund.

Fire Rescue

- A-22 Approve Modification #1 to Subgrant Agreement (contract #16-DS-P4-08-39-01-443, CFDA#97.067), between the State of Florida, Division of Emergency Management and Hillsborough County, Fire Rescue Department - Office of Emergency Management to purchase a generator to be installed at the Florida State Fairgrounds. This modification extends the end of the grant funding period from July 31, 2016 to August 15, 2016. This extension is needed to allow additional time for the State to process the EHP form (Environmental and Historical Preservation Screening Form) required to install a generator. This agreement was approved by the Board on May 4, 2016 and funds were appropriated on June 2, 2016. No additional County funding will be required as a result of this modification.

Fleet Services

- A-23 Declare as surplus and authorize disposal of 91 items of vehicles and equipment, and further authorize the Clerk of the Circuit Court to remove the property on the attached list from the inventory asset record. Disposal of property will be offered for sale by public auction to the highest bidder or sold to another public entity or municipality in accordance with BOCC Policy 08.01.01.02 (Disposal of Surplus Fleet Vehicles and Related Equipment), dated April 2, 2008 and Florida State Statute (Section 274.06).

Head Start/Early Head Start

- A-24 Approve Head Start/Early Head Start Program's 2015-2016 Annual Self -Assessment pursuant to the Head Start Act, 42 U.S.C. §9831 et seq., and applicable Federal law. There is no cost to the County.

Health Care Services

- A-25 Approve the 2015 Plan Update to the Hillsborough County Trauma Plan as recommended by the Trauma Audit Committee. There are no additional funds required. The Trauma Agency is in Human Services and funded within the Health Care Services FY 16 adopted budget with County-wide General Funds.
- A-26 Approve, A) the Third Modification to the Agreement (BOCC DOC #13-0564), with, Agency For Community Treatment Services ('ACTS') and B) the Second Modification to the Interlocal Agreement (BOCC DOC #13-0563) with Hillsborough County Sheriff's Office ('HCSO') which extend the agreements under the same terms and conditions for a two-year period commencing June 19, 2016 and ending June 19, 2018. Funding for these agreements are included in the proposed FY 17 budget for the Indigent Health Care Trust Fund and County General Fund. No additional County ad valorem funds are required.

- A-27 Approve, the Fourth Modification to the Agreement (BOCC Doc# 12-1136) with The Crisis Center of Tampa Bay, Inc., d/b/a Transcare (The Crisis Center), for the provision of transportation services throughout the County pursuant to the Florida Mental Health Act, known as the 'Baker Act' for persons in need of mental health services. This modification: 1) extends the current contract term for an additional four months to March 31, 2017; 2) adds three (3) optional one (1) month extension periods or any portion thereof, at the same terms and conditions; and 3) adds \$209,278 for the four month extension period and \$52,320 for each of the three (3) optional one (1) month extension periods, if needed. There are sufficient funds in the FY 17 proposed budget.
- A-28 Approve the Seventh Modification to the Agreement with Pharmacy Administrative Solutions, Inc. which: 1) decreases the reimbursement rate for specialty drugs and injectable/infusion drugs with a date of service on and after November 1, 2016; 2) updates the Human Rights Ordinance language pursuant to the BOCC; 3) increases the total not-to-exceed amount by \$500,000 from \$5,350,000 to \$5,850,000 for the current term ending October 31, 2016; and 4) increases each renewal term not-to-exceed amount by \$250,000 from \$2,675,000 to \$2,925,000. Funding for this modification is accommodated within the FY 16 Indigent Health Care Trust Fund.

Information and Innovation Office

- A-29 Approve and execute Verizon Wireless Right of Entry Agreement for Hillsborough County to grant Verizon Wireless a site access license to perform a Site Investigation at the new Public Safety Operations Center (PSOC) ahead of a proposed future installation of network equipment for an in-building and rooftop system for cellular service coverage. There is no cost to Hillsborough County for this Site Investigation. Verizon Wireless shall bear all cost to perform the Site Investigation.

Management and Budget

- A-30 Approve the FY 17 budgets and 2016 non-ad valorem assessment rates of 23 special dependent districts in Hillsborough County. The rates are set by the governing board of each district. Resident registered voters comprise each respective board. There is no impact on County finances because each district maintains its own financial records, bank accounts and financial systems.
- A-31 Receive report from Risk Management and Safety, Management and Budget Department for liability claims for the second quarter of FY 2016 as of May 25, 2016.
- A-32 Receive report regarding the Status of Reserves for Contingencies in the Tax Fund FY 16 as of June 17th, 2016.

Parks and Recreation Services

- A-33 A) Adopt a Resolution authorizing the licensed use of space in the Mann Wagon Memorial Park Cultural Center located at 1101 East River Cove Street in Sulphur Springs by Community Stepping Stones, Inc., a 501(c)(3) tax exempt Florida not-for-profit corporation (the 'Stepping Stones'), which use is sponsored by the Parks and Recreation Department (the 'PRD'); B) Approve a License Agreement for the Non-Profit Use of County-owned Real Estate with Stepping Stones for the occupancy of 1,207 usable square feet of space in the Mann Wagon Memorial Park Cultural Center. This license agreement will support the Stepping Stones's mission of operating a learning center for the provision of an integrated arts curriculum to at-risk youth. Stepping Stones will pay a monthly occupancy fee, as set forth by Hillsborough County Board of County Commissioners Policy No. 08.02.06.00, in the amount of \$402.33 (\$4.00 per square foot annually) for each year of the three-year term, commencing August 1, 2016 and terminating on July 31, 2019. This occupancy fee is to offset the costs incurred by Hillsborough County for utilities, maintenance, capital improvements and administrative costs for the operation of the cultural center. The occupancy fee has been adjusted from the \$6.00 occupancy fee (full service) presently recouped for similar uses in other County facilities to accommodate the provision of janitorial and pest control services by the Stepping Stones.

In addition, reject the bid submitted by Scarab International, LLLP, which is deemed non-responsive for the stated material deviation of submitting a bid for a belt-driven machine instead of a hydraulic-driven machine, as required in the specifications. Bids were received from four (4) different vendors. There are sufficient funds in the requesting department's operating budget. Purchase orders will be issued against approved budgets.

A-36 Award a contract to the lowest, responsive, and responsible bidder, Angelo's Aggregate Materials, LLC, in the amount of \$329,050.00 for the removal, disposal, and transportation of waste tires from the South County Landfill Facility for the Public Works Department (Invitation to Bid 6865). The resulting contract will be effective on the date shown on the issued blanket purchase agreement and continue for two (2) years, ending on the last day of the final month. The Economic Development Department did not have three (3) Disadvantaged Minority/Disadvantaged Women Business Enterprise (DM/DWBE) or three (3) Small Business Enterprise (SBE) firms registered for the specified services; therefore, no DM/DWBE participation goal or SBE set aside was established and included in the solicitation. Bids were received from three (3) different vendors. There are sufficient funds in the requesting department's operating and enterprise budgets. Purchase orders will only be issued against approved budgets.

A-37 Award and execute an agreement with the lowest, responsive, and responsible bidder, Rowland, Inc., in the amount of \$586,672.00 for the 82nd Street Water Main Upgrades and Repump Station Removal Project (Invitation to Bid 6309,3) for the Public Utilities Department. The resulting agreement will be in effect from the date of Notice to Proceed through completion. The County's Disadvantaged Minority/Disadvantaged Women Business Enterprise (DM/DWBE) Goal Setting Committee established a DM/DWBE participation goal of 14%, and the recommended vendor has committed to achieving 19.74% DM/DWBE participation. The single bid and circumstances were reviewed in accordance with Sec. 3.4.9 of the Procurement Policy and Procedures Manual. The subject solicitation was advertised on January 14, 2016, and posted on the Procurement Services Department's website. Three thousand nine-hundred and thirty-seven (3,931) suppliers were notified and two-hundred and sixty-three (263) suppliers viewed the solicitation documents. Based on staff's follow up discussions with vendors who did not participate, it appears that most contractors were uninterested due to the small size of

the project and the volume of other concurrent and larger pursuits. In addition, existing workload and scheduling impacted vendors' ability to accept new projects. There are sufficient funds in the 82nd Street Water Main Upgrades and Repump Station Removal project budget (CIP No. 31977-12014) to accommodate award of this agreement.

- A-38 Approve and execute the attached revision to Blanket Purchase Agreement No. 215207932 with Bright House Networks, LLC, which increases the contract amount by \$22,540.00, from \$736,000.00 to \$758,540.00, for the Information and Innovative Office (IIO). This revision will add managed router services to allow for dual hub redundancy initially for Public Safety Operations Complex (PSOC) and the County Center building, which is now needed for the County's data center migration from County Center to PSOC. IIO determined the pricing to be fair and reasonable based upon similar pricing with other governmental agencies. There are sufficient funds in the department's FY 16 operating budget. Purchase orders will only be issued against approved budgets.
- A-39 Approve an increase to Contract Purchase Agreement (CPA) No. 216210764 with Graybar Electrical Company, Inc., that increases the CPA amount by \$502,000.00, from \$217,000.00 to \$719,000.00, for ongoing and as needed small purchases, through March 31, 2017, for electrical products by various County departments utilizing County of Los Angeles Contract No. MA-IS-1340234 (RFP No. 13255001) through the U.S. Communities Government Purchasing Alliance. This CPA allows various departments to quickly acquire, through a punch-out system portal (electronic catalog) maintained by the contractor, a wide variety of electrical products (excluding installation and/or services) to perform their daily duties, many of which provide direct services to County citizens. Due to the types of items that can be purchased, the Procurement Services Department will monitor purchases to ensure that purchases remain within the spirit and terms of the award, purchasing volume is leveraged and competed separately if warranted, and the County's Procurement Policy and Procedures are adhered to. In addition to departments utilizing the CPA punch-out system portal, items may also be purchased using the County's Purchasing Card (P-Card) in accordance with applicable policies and procedures. Individual department purchases will be monitored for future contracting opportunities with Disadvantaged Minority/Disadvantaged Women Business Enterprises, Small Business Enterprises, and Disabled Veteran Business Enterprises. The Procurement Services Department determined the pricing to be fair and reasonable based on the percentage discounts offered by the subject U. S. Communities contract. Various funding sources will be used not to exceed previously approved budgets. Purchase orders will only be issued against approved budgets.
- A-40 A) Award and execute an agreement with the lowest, responsive, and responsible bidder, Cornerstone Construction Services Inc., in the amount of \$992,108.75 for the South County Transfer Station Tipping Floor Repair Project (Invitation to Bid 6802,3). The resulting agreement will be in effect from the date of Notice to Proceed through project completion. Based on the County's Disadvantaged Minority/Disadvantaged Women Business Enterprise (DM/DWBE) Goal Setting Committee, this project did not have a DM/DWBE Program participation goal due to the specialty work to be performed. The single bid and circumstances were reviewed in accordance with Sec. 3.4.9 of the Procurement Policy and Procedures Manual. The subject solicitation was advertised on May 4, 2016, and posted on the Procurement Services Department's website. Based on staff's follow up discussions with vendors who did not participate, it appears that most contractors did not have the expertise required to perform this job. Only a few contractors choose to work this type of construction because of the difficult working conditions including, heavy truck traffic in limited space, strong odors, working with pre-existing damaged structures, tight time frames, and working with specialty concrete mixes. B) Approve a budget amendment to increase the Renewal and Replacement fund (40007) by \$375,000.00 for project C54065000 (Solid Waste Management Facilities R&R) and decrease the Renewal and Replacement fund (40007) reserves by \$375,000.00.
- A-41 Approve an increase to Contract Purchase Agreement (CPA) No. 216201437 with Alan Jay Ford Lincoln Mercury Inc., that increases the CPA amount by \$850,000.00 from \$3,500,000.00 to \$4,350,000.00, for the purchase of seventeen (17) replacement vehicles, utilizing the Florida Sheriff Association & Florida Association of Counties (FSA) Contract No. 15-23-0904 through September 30, 2016, for the Fleet Management Department. There are sufficient funds in the Vehicle Replacement Fund. Purchase orders will only be issued against approved budgets.

A-42 Approve the correction of a recently awarded vendor's name from 'Southeastern Data, Inc.' to 'E-Recycling Solutions, LLC, d/b/a Southeastern Data,' for ongoing and as needed disposal, and recycling of electronics collected at Community Collection Centers throughout the County, and transportation of the materials to the appropriate end markets (Invitation to Bid 5752) for the Public Works Department. All other aspects of the Procurement Services Department's recommendation and BOCC award remain unchanged. There are sufficient funds in the requesting department's operating budget and purchase orders will only be issued against approved budgets.

A-43 Approve and execute the attached two (2) Novation Agreements changing Bayside Engineering, Inc., Federal Employer Identification Number (FEIN) 59-3275933 to Johnson Mirmiran & Thompson, Inc. The original agreements provide for ongoing and as needed miscellaneous surveying and mapping services for geomatics (RPS-S-0082-0-2014/TJS) and professional general/civil engineering consultant services (RPS S-0235-0-2011/LP) required by the Public Works Department. There are no changes to the terms and conditions of the original agreement. There is no financial impact to the County as a result of these novation agreements. There are no subcontracting opportunities for Disadvantaged Minority/Disadvantaged Women Business Enterprises as the subject products will be provided by through the FSA contract. There are sufficient funds in the Vehicle Replacement Fund. Purchase orders will only be issued against approved budgets.

A-45 Award and execute an agreement with the lowest, responsive, and responsible bidder, T B Landmark Construction, Inc., in the amount of \$555,162.00 for potable water interconnection at Westchase (ITB 6469,2) for the Public Utilities Department. This agreement provides for the installation of approximately 2,800 linear feet of 12-inch diameter PVC potable water main and approximately 100 linear feet of 24-inch diameter steel casing and associated 12-inch PVC potable water main. The County's Disadvantaged Minority/Disadvantaged Women Business Enterprise (DM/DWBE) Goal Setting Committee established a DM/DWBE Program participation goal of 14% and the recommended supplier has committed to achieving a 15.3% DM/DWBE

Program participation goal. Bids were received from four (4) different vendors. There are sufficient funds in the Westchase Water Main Interconnection CIP Project Budgets (CIP 31977-14006 and CIP 10171-16002) to accommodate award of this contract.

No. ICE-11-0931-05 with CDM Smith, Inc. for Independent Consulting Engineer Services to increase the contract amount by \$88,000 from \$300,000 to \$388,000. The increase is needed to complete a risk matrix for the Solid Waste Resource Recovery Facility and to develop an Engineering Feasibility Report. This information supports the refinancing of the outstanding Solid Waste and Resource Recovery Revenue Bonds Series 2006A and B. The financial impact of this agenda item will be covered within the Public Works Department's Solid Waste Management Division recommended FY 16 Operating Budget.
- A-63 Approve the Detailed Work Plan Budget-Arthropod Control for the Florida Department of Agriculture and Consumer Services to provide up to \$47,310 in State aid for mosquito control services by the Public Works Department Mosquito and Aquatic Weed Control Unit, effective October 1, 2016, and expiring on September 30, 2017. Funding is contingent upon the State's approval of these documents. It is estimated that the State will provide Hillsborough County with \$47,310 which is included in the FY 17 Public Works Department tentative operating budget. No County matching funds are required.
- A-64 Approve September 8, 2016, to conduct a Public Hearing to receive comment concerning the Street Lighting Special Purpose District Rates for the 2016 Tax Year, and to adopt the Non Ad-valorem Assessment Roll for the Hillsborough County Consolidated Street Lighting Special Purpose District. There is no proposed increase or decrease to the current street lighting rates. The fiscal impact of this agenda item can be adequately accommodated within the department's currently approved funding level for FY 16. The average revenue and costs for services of these districts is approximately \$7,929,388.

- A-65 Approve September 8, 2016, to conduct a public hearing to receive comment concerning the annual rate resolution and to adopt the stormwater assessments for the 2016 Tax Year. There is no proposed increase or decrease to the current stormwater assessment rates and will not affect the proposed FY 17 stormwater budget.

Real Estate and Facilities Services

- A-66 Approve Change Order No. 1 (FINAL) with Paul J. Sierra Construction, Inc., Construction Manager for the Northdale Recreation Center Expansion and the Gibsonton Area Recreation Center Multipurpose Building Projects, (CIP Nos. C83221000 and C83226000, Bid No. RFP-C-0227-0-2013/DV), to reduce the contract by an amount of \$31,804.06 and to deduct sixty (60) days of unused allowance time for the Northdale location, as explained in the Background. The projects are complete and the final Change Order is necessary to make final payment and to close out the contract. This action will result in a credit to the County in the amount of \$31,804.06. No additional funds are required.
- A-67 Approve an Agreement with the City of Tampa for Release of Easements, Indemnity Agreement and Bill of Sale for a utility easement containing a wastewater line at the C. Blythe Andrews Jr. Library facility. The library is located within the City of Tampa's water/wastewater service area and the County has requested that the subject easement reserved to the City per the attached Ordinance No. 91-113 be released to accommodate re-development of the property. The City has agreed to release the easement conditioned upon the County assuming ownership and maintenance of the existing wastewater line. The cost associated with this item is limited to recording fees of less than \$100.00, which can be adequately accommodated within the approved budget for CIP No. C76017000.
- A-68 Declare tangible personal property as surplus and authorize its final disposal by donation to qualified non-profit agencies or by sale at public auction. Furthermore, authorize the Clerk of Circuit Court to remove the property from County inventory. This action is in accordance with Administrative Directive (AD) #PI-01 and Florida Statutes 273.01, 274.05 and 274.06, as detailed in the Background. Surplus property will either be donated to non-profit agencies or sold at public auction. Any revenues received from sales will be credited to the Countywide General Fund.
- A-69 Approve an Easement Agreement in favor of Tampa Electric Company (TECO) to provide the necessary land rights to TECO for operating and maintaining electrical distribution facilities constructed to serve the Public Utility Department's new environmental laboratory facility under construction within the County's Falkenburg Complex. The cost associated with this item is limited to recording fees of less than \$100.00, which can be adequately accommodated within the project's approved CIP funding.
- A-70 A) Accept the donation of a Special Warranty Deed for Site Access Right Of Way from HIM Tampa Realty, LLC, for conveyance of land required by the County for construction of certain turn-lane improvements in conjunction with the Madison Avenue Roadway Improvements project; B) Accept the donation of a Special Warranty Deed from HIM Tampa Realty, LLC, for conveyance of a stormwater management pond site required by the County to support the Madison Avenue Roadway Improvements project; and C) Accept a Temporary Construction Easement from HIM Tampa Realty, LLC, to the County to facilitate construction of the Madison Avenue Roadway Improvements stormwater management pond. Pursuant to the Amended Development Agreement between HIM Tampa Realty, LLC, and the County, the developer is required to convey the right-of-way and stormwater pond site to mitigate transportation impacts relating to development of a 570,000 square foot beverage distribution and office facility located on Madison Avenue, east of US Highway 41. The cost associated with this item is limited to recording fees of less than \$100.00, which can be adequately accommodated within the project's approved CIP Funding.
- A-71 Adopt Resolutions: A) Determining a reasonable necessity to acquire fee simple road and associated drainage rights-of-way, and temporary construction easements for the public purpose of constructing road and intersection improvements for Bell Shoals Road (Bloomingdale Avenue to Boyette Road), CIP No. 69112, Project No. 2013-046-R, in Hillsborough County, Florida. B) Authorizing good faith presuit negotiations and the acquisition of such properties and associated property rights by eminent domain proceedings, if necessary, for the project. C) Authorizing and directing the Hillsborough County Attorney's Office and Real Estate and Facilities Services

Department to acquire such property and associated property rights in the name of Hillsborough County, without further approval from this Board, provided that the amounts expended to acquire such property and associated property rights can be adequately accommodated within the project's current budget, and to fully compensate the interested parties as required by law. The purpose of these resolutions is to determine a reasonable necessity to acquire property for a public purpose and to authorize Hillsborough County to exercise the power of eminent domain. Acquisition of Parcels 137, 142, 149, 152, 153, 154/754A&B, 155 and 157 can be adequately accommodated within the currently approved FY 16 Capital Improvement Budget. All property owners for the referenced parcels have been notified about the proposed acquisitions.

A-72 A) Approve the conveyance of an Access and Utility Easement Agreement in favor of Loconti Groves, LP, across a County-owned 30-foot wide strip of land which extends from DeBuel Road northward approximately 2,640 linear feet into Hanna Lake in the Lutz area (the County Strip). The north half of the County Strip bisects the Loconti property ownership, which is under contract for sale. The property owner requests an access and utility easement across a portion of the County Strip to facilitate the orderly development of the Loconti property as a single unified subdivision, while avoiding undesirable impacts on an existing, well established residential community to the north. The appraised value of the permanent easement is \$7,650.00. B) Authorize the Director of Real Estate and Facilities Services to execute any applications or other documents relating to development activities within the easement area, including but not limited to applications or ancillary documents relating to plats and infrastructure construction plans, as deemed necessary by the County's Development Services Department or other regulatory agencies. Financial impact is limited to one-time revenue in the amount of \$7,650.00, which will be received from the developer and deposited to the Unincorporated Area General Fund.

A-73 Approve a First Amendment to Lease to extend the existing lease for 1,134 square feet of space located at 4575 Gunn Highway at Westwood Plaza for one additional year. This lease extension will provide for the continued operation of the Supervisor of Elections' existing voter services office serving the northwest portion of the County from February 1, 2017 through January 31, 2018. The base rent for the one-year extended term is \$21,218 per sq. ft. or \$2005.10 per month. The estimated charges for Additional Rent (operating expenses), including water, sewer and solid waste are \$3.92 per sq. ft. or \$370.91 per month. The Supervisor of Elections will also continue to pay for its electric usage, which is separately metered, and provide janitorial services to the leased premises. The rental rates are within the market rates for the Citrus Park/Carrollwood area. All rent and lease costs are accommodated in the SOE's FY 17 operating budget.

A-74 Approve the First Amendment to Contract for Sale and Purchase of Real Property with the Housing Authority of the City of Tampa (THA) to extend the Inspection Period from 90 days to 180 days. The Contract for Sale and Purchase between the County and THA was approved by the BOCC on April 6, 2016 (Contract) and relates to THA's acquisition of a County-owned six-acre parcel of land located within the West River Master Plan redevelopment area (West River). West River has been identified by the City of Tampa as a focal area proposed for redevelopment as a mixed income, mixed use neighborhood along the Hillsborough River. The sale of the County parcel will enable THA, in partnership with the City, to implement the West River plan. THA must demonstrate control of the property in order to pursue federally funded grants. A-75 Approve for the Social Services Department, a Budget Amendment Resolution to realign \$539,031 within the Social Services CSBG grant budget to bring the budget in line with the actual grant agreement of \$1,794,089 for the FY 2016 Community Services Block Grant (CSBG) Subgrant Agreement, Contract No. 16SB-0D-08-39-01-010 for the period October 1, 2015 through September 30, 2016. The grant will be utilized to fund direct assistance payments for eligible low income households in Hillsborough County. The program is entirely federally funded. Hillsborough County Public Schools (HCPS) Federal portion of \$11,470,818 requires this sub-recipient provide its portion of matching funds of \$2,867,704. The total Federal funds of \$23,994,428 and County match funds of \$3,130,903 (General Fund, In-Kind and State Voluntary Pre-Kindergarten (VPK) funds) will be included in the recommended FY 17 budget pending adoption by the BOCC in September 2016. B) Approve FY 17 Early Head Start (EHS) grant application for Federal funding from the U. S. Department of Health and Human Services of \$5,061,562, providing matching funds of \$1,265,390 for total EHS funding of \$6,326,952 for the period of October 1, 2016 through September 30, 2017. EHS application includes the County's Federal portion of \$2,567,145 which requires County matching funds of \$641,786. Lutheran Services Florida, Inc. (LSF) Federal portion of \$1,493,048 requires this sub-recipient to provide its portion of matching funds of \$373,262. Tampa Metropolitan Area YMCA, Inc. (YMCA) Federal portion of \$1,001,369 requires this sub-recipient to provide its portion of matching funds of \$250,342. The total Federal funds of \$5,062,562 and County match funds of \$641,786 (General Fund and In-Kind) will be included in the recommended FY 17 budget pending adoption by the BOCC in September 2016.

Health Care Services

- B-4** A) Accept, the grant award of \$10,302,488 from the United States Department of Health and Human Services, Health Resources and Services Administration (HRSA) for the period of March 1, 2016 through February 28, 2017. B) Approve budget amendment resolution to decrease appropriations within the HIV Emergency Relief Program/Ryan White Part A Grant FY 15 by \$460,801 from the estimated budget of \$10,763,289 to reflect the actual grant award of \$10,302,488 which includes the Minority AIDS Initiative (MAI) of \$647,813; Formula of \$6,215,057 and Supplemental \$3,439,618 and realign within the same grant fund to reflect the actual budget for

the grant for FY 16. Funds will be allocated to service providers to assist eligible HIV+ individuals for the period of March 1, 2016 through February 28, 2017. The Ryan White Part A Grant program is funded by the Department of Health and Human Services, Health Resources and Services Administration (HRSA). No additional County funds are required.

Human Resources - Professional Development

B-5 11:15 AM (Time Certain) Approve changes to the County self-insured employee health insurance program for FY 17, as reflected in Attachment 1, addressing a \$22 million deficit between projected expenses and revenue for FY 17 through a combination of plan changes, increases in copays and out-of-pocket maximums, decreasing expenditures, and increased contributions by employers, employees, and retirees. The recommended changes will result in an estimated \$18.0 million increase in revenue and an estimated \$3.6 million reduction in expenses in FY 17 to the County's self-insured Employee Group Health Insurance Fund (Fund 50067004). By FY 18, the changes will result in \$18.4 million in increased revenue and \$4.6 million in reduced expenses. The impact of wellness initiatives will have an increasing downward effect on future expenses.

Management and Budget

B-6 11:15 AM (Time Certain) A) Approve refunds of \$16,815,854 from excess general liability and automobile liability fund reserves and \$8,810,612 from excess workers compensation fund reserves. The refunds will be returned to the funds which originally paid the assessments. The refunds will provide funds needed to pay a supplemental FY 16 assessment needed for the self-funded employee health insurance fund. B) Approve a supplemental FY 16 assessment of \$20,903,151 to restore self-funded employee health insurance fund reserves to the statutorily and actuarially required level. The supplemental health insurance assessment is needed due to projected FY 16 health insurance reserves falling below the minimum statutorily required level of two months expenditures as determined by the January 2016 actuarial study performed by Arthur J. Gallagher and Company, the County's actuarial consultant. Reserves are projected to decline below the required level due to health care expenditures exceeding revenues.

B-7 In accordance with the approved bond resolution (R16-061), appropriate \$20,917,716 in proceeds from the Series 2016 CIP Refunding Revenue Bonds. The recommended appropriation of funds, in combination with monies on hand, will allow the County to complete the refunding of its Capital Improvement Program Refunding Revenue Bonds, Series 2006 (the 'Series 2006 CIP Refunding Revenue Bonds' or 'Refunded Bonds'). The recommended appropriation of funds will allow the County to: 1) Pay off approximately \$23,885,000 of its outstanding Series 2006 CIP Refunding Revenue Bonds and related interest expense, and 2) Fund costs of issuance incurred as a result of the Refunding Bond transaction.

Procurement Services

B-8 Award and execute an agreement with the lowest, responsive, and responsible bidder, Ajax Paving Industries of Florida LLC, in the amount of \$1,537,844.11 for intersection improvements at Lakeshore Road and Wilcox Road (Invitation to Bid 6590,2) for the Public Works Department. This agreement includes the following improvements; a southbound right turn lane along Lakeshore Road, roadway reconstruction and widening to create an eastbound left turn lane along Wilcox Road, a traffic signal, curb and gutter, a storm sewer system, sidewalks and signing and pavement markings. The project also includes minor relocations/adjustments of Hillsborough County water/wastewater facilities. The County's Disadvantaged Minority/Disadvantaged Women Business Enterprise (DM/DWBE) Goal Setting Committee established a DM/DWBE Program participation goal of 8% and the recommended vendor has committed to achieving an 11% DM/DWBE Program participation goal. Bids were received from two (2) different vendors. There are sufficient funds in the Lakeshore Road and Wilcox Road Intersection Improvements CIP Project Budget (CIP No. 69601.436 and C31945000) to accommodate award of this contract. Purchase Orders will be only be issued against approved budgets.

- B-9** Award a contract to the vendor offering the highest estimated revenue (\$1,004,123.27), Trademark Metals Recycling LLC, for ongoing and as needed disposal and collection of ferrous scrap metal, nonferrous scrap metal, and white goods received at various Community Collection Centers and County departments for the Public Works Department. This contract will be effective on the date shown on the issued blanket purchase agreement and continue for two (2) years, ending on the last day of the final month. The Economic Development Department did not have three (3) Disadvantaged Business Enterprise (DM/DWBE) or three (3) Small Business Enterprise (SBE) firms registered for the specified services; therefore, no DM/DWBE participation goal or SBE set aside was established. Authorize the Director of Procurement Services Department to approve contract revisions based on the resulting unit prices and dependent on the actual material received. The estimated revenue amount is dependent on the volume and type of products received at the various collection points. Bids were received from two (2) different vendors. There is no financial impact for this contract. Based on anticipated collections, the estimated revenue earned will be \$1,004,123.27.
- B-10** Award a contract to Xylem Water Solutions U.S.A., Inc., in the amount of \$8,400,000.00 for the sole source purchase of ongoing and as-needed Flygt Original Equipment Manufacturer (OEM) Pumps, Replacement Parts, and Xylem Labor Services (Sole Source Contract No. 7067-2) for the Public Utilities Department (PUD). The resulting contract will be effective on the date shown on the issued purchase order and continue for five (5) years, ending on the last day of the final month. A 'Notice of Intent to Sole Source' was advertised; no challenges were received. Xylem Water Solutions USA, Inc., is the only authorized vendor for Flygt products in the State of Florida. Flygt pumps have been installed at numerous lift stations that were originally designed for use with Flygt pumps. PUD staff determined the pricing discount to be fair and reasonable based on negotiation efforts that have resulted in a discount of 9.5% off the manufacturer's published list pricing and comparison to historical pricing. A larger pricing discount was achieved by leveraging future purchases over the five (5) year term. There are no subcontracting opportunities for Disadvantaged Minority Women Business Enterprises as the products are proprietary and will be provided by a single vendor. Authorize the Director of Procurement Services to approve revision and/or updates of the parts and price list. There are sufficient funds in the requesting department's enterprise and operating budgets. Purchase orders will be only issued against approved budgets.
- B-11** Approve an increase to Contract Purchase Agreement (CPA) No. 216202456 with W. W. Grainger, Inc. that increases the CPA amount by \$1,183,000.00 from \$1,332,576.00 to \$2,515,576.00, for ongoing and as needed small purchases, through February 28, 2017, and November 14, 2016, respectively, for maintenance, repair, and operations (MRO) supplies, equipment, and hand held power tools for various county-wide departments utilizing State of Florida Contract No. 450-000-11-ACS and 445-001-11-1. This contract will allow department staff to quickly acquire, through a punch-out system portal (electronic catalog) maintained by the contractor, a wide variety of MRO supplies, equipment, and tools (excluding installation and/or services) to perform their daily duties, many of which provide direct services to County citizens. Due to the types of items that can be purchased, the Procurement Services Department will monitor purchases to ensure that purchases remain within the spirit and terms of the award, purchasing volume is leveraged and competed separately if warranted, and the County's Procurement Policy and Procedures are adhered to. In addition to departments utilizing the CPA punch-out system portal, items may also be purchased using the County's Purchasing Card (P-Card) in accordance with applicable policies and procedures. Individual department purchases will be monitored for future contracting opportunities with Disadvantaged Minority/Disadvantaged Women Business Enterprises, Small Business Enterprises, and Disabled Veteran Business Enterprises. The Procurement Services Department determined the pricing fair and reasonable based on the percentage discounts utilizing the State of Florida contract. Various funding sources will be used not to exceed previously approved budgets. Purchase orders will only be issued against approved budgets.

- B-12** Approve budget amendment to increase the Solid Waste Revenue fund (Fund 40004) by \$6 million and reduce the Solid Waste Rate Stabilization Fund (Fund 40016) by \$6 million to comply with Bond Covenants and Rate Ordinances. This action does not impact the FY 16 budget.

- B-13** Approve the Grant Agreement (Agreement # HL075) between the State of Florida, Department of Economic Opportunity (DEO) and Hillsborough County (Grantee) for reimbursement of up to \$1,500,000 for services and expenses associated with the design and construction of the Veterans Resource Center at Veterans Memorial Park located at 3602 N. U.S. Highway 301, Tampa, Florida 33619; CIP No. C80219000. Approval of this Grant Agreement will not require additional matching funds beyond the existing and past funding for this project.
