 ARGO PARTNERS: QUALITY HEALTH PLANS (CASE No. 2011-CA-002245)— Robbie Chartier

That the Board of County Commissioners accept an offer to receive 7.5% or (\$2,844.45) of total claims due in the amount of \$37,926 from Argo Partners representing Florida Department of Financial Services, Division of Rehabilitation and Liquidation for Quality Health Plans in liquidation.

c. BUDGET TRANSFER BT 16-178 TOURISM SPECIAL REVENUE FUND— Corey Wheeler

That the Board of County Commissioners approve Budget Transfer BT 16-178 in the amount of \$42,600 from Tourism Special Revenue Fund Reserves to Lock 7 Professional Services to appropriate funds for the Lock 7 Master Conceptual Plan and Phase I Construction Services.
