**A RESOLUTION OF THE CITY OF INDIAN HARBOUR BEACH, BREVARD COUNTY, FLORIDA, IMPOSING AN ANNUAL STORMWATER UTILITY ASSESSMENT FOR THE FISCAL YEAR BEGINNING OCTOBER 1, 2016, AGAINST ALL REAL PROPERTY WITHIN THE CITY LIMITS OF INDIAN HARBOUR BEACH, BREVARD COUNTY, FLORIDA; PROVIDING FOR CLASSIFICATIONS OF PROPERTY; PROVIDING FOR CERTIFICATION OF**

ANNUAL STORMWATER UTILITY ASSESSMENT ROLL; PROVIDING AN EFFECTIVE DATE.

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF INDIAN HARBOUR BEACH, BREVARD COUNTY, FLORIDA, SUPPORTING THE BREVARD COUNTY BOARD OF COUNTY COMMISSIONERS INITIATIVE TO HAVE BREVARD COUNTY VOTERS DETERMINE WHETHER TO IMPOSE A ONE-HALF CENT DISCRETIONARY SALES TAX FOR TEN YEARS TO FUND PROJECTS AND PROGRAMS FOR THE RESTORATION OF THE INDIAN RIVER LAGOON THROUGH A VOTER REFERENDUM ON NOVEMBER 8, 2016; PROVIDING AN EFFECTIVE DATE

- 4) **APPROVE, SUBJECT TO THE AVAILABILITY OF SUFFICIENT FUNDS IN THE BUDGET FOR FY 2016-2017, THE RENEWAL OF THE CITY'S HEALTH INSURANCE COVERAGE PROVIDED BY HEALTH FIRST HEALTH PLANS EFFECTIVE OCTOBER 1, 2016 AT A RENEWAL RATE OF 8.1% ABOVE THE CURRENT RATES, AND CONTINUE TO OFFER EMPLOYEES THE OPTION TO PAY THE DIFFERENCE TO OBTAIN AN ENHANCED BENEFIT PLAN.**
