AN ORDINANCE OF THE BOARD OF COUNTY COMMISSIONERS OF BROWARD COUNTY, FLORIDA. RELATING TO THE CHARTER COUNTY AND REGIONAL TRANSPORTATION SYSTEM SALES SURTAX "TRANSPORTATION SURTAX"); AMENDING BROWARD COUNTY ORDINANCE 2016-14 NO. RELATING TO ARTICLE OF CHAPTER 31½ OF THE BROWARD COUNTY CODE OF ORDINANCES ("CODE"), FOR THE PURPOSE OF CONFORMING THE RATE AND DURATION OF THE TRANSPORTATION SURTAX TO THE TERMS OF TRANSPORTATION THE SYSTEM AND INFRASTRUCTURE SURTAXES INTERLOCAL AGREEMENT AND TRANSPORTATION SURTAX RESOLUTION NO. 2016-347; LEVYING, SUBJECT TO APPROVAL BY REFERENDUM, A ONE-HALF PERCENT (0.5%) TRANSPORTATION SURTAX FOR A PERIOD OF ŤHIRŤY (30) PROVIDING YEARS FOR THE TRANSPORTATION SURTAX OVERSIGHT BOARD TO OVERSEE THE USE OF TRANSPORTATION SURTAX PROCEEDS: AND PROVIDING FOR SEVERABILITY, INCLUSION IN THE CODE, AND AN EFFECTIVE DATE.

## (Sponsored by the Board of County Commissioners)

WHEREAS, on May 24, 2016, the Board of County Commissioners of Broward
County, Florida ("Board"), enacted Ordinance No. 2016-14 (the "Transportation Surtax
Ordinance") levying, subject to approval by countywide referendum, a Charter County and
Regional Transportation System Sales Surtax ("Transportation Surtax") at a rate of
three-quarters of one percent (0.75%) for a period of twenty (20) years; and

WHEREAS, following enactment of the Transportation Surtax Ordinance, Broward
County and Broward municipalities representing a majority of Broward County's population
("Municipalities") negotiated a Transportation System and Infrastructure Surtaxes
Interlocal Agreement ("ILA") which, among other things, provides for the scheduling of a
referendum election on the levy of a 30-year, one-half percent (0.5%) Transportation

Surtax and for certain aspects of administration of such Transportation Surtax if approved 1 2 by referendum; and

3 WHEREAS, on June 22, 2016, the Board adopted Resolution No. 2016-347 4 ("Transportation Surtax Resolution"), scheduling a referendum election to be held at the 5 General Election on November 8, 2016, for the purpose of enabling the electorate to 6 determine whether a one-half percent (0.5%) Transportation Surtax for a period of thirty 7 (30) years should be levied; and

8 WHEREAS, the Board desires to amend the Transportation Surtax Ordinance to 9 conform to the ILA and Transportation Surtax Resolution,

11 BE IT ORDAINED BY THE BOARD OF COUNTY COMMISSIONERS OF 12 **BROWARD COUNTY, FLORIDA:**

# Sec. 31<sup>1</sup>/<sub>2</sub>-72. Levy of Transportation Surtax.

19 Pursuant to Section 212.055(1), Florida Statutes, and subject to approval by a 20 majority of the gualified electors of Broward County voting in a referendum at the 21 General Election on November 8, 2016 ("Ballot Measure"), there is hereby levied, for a period of twenty (20) thirty (30) years, commencing at 12:01 a.m. on January 1, 2017, and 22 23 expiring at 11:59 p.m. on December 31, 2036 2046, a three-quarters-of one-half percent

(0.75%) (0.5%) Charter County and Regional Transportation System Sales Surtax

# Sec. 31<sup>1</sup>/<sub>2</sub>-74. Use of Transportation Surtax proceeds.

8 Transportation Surtax proceeds shall be collected, allocated, disbursed, and 9 expended for authorized transportation and transit purposes, in accordance with 10 Sections 212.054 and 212.055(1), Florida Statutes, and any applicable interlocal 11 agreements the Transportation System and Infrastructure Surtaxes Interlocal Agreement 12 ("ILA") between Broward County and Broward municipalities, and the Ballot Measure. A 13 copy of the ILA shall be kept on file and available for inspection during regular business 14 hours in the Broward County Office of Management and Budget.

### Sec. 31<sup>1</sup>/<sub>2</sub>-75. Transportation Surtax Oversight Board.

16 (a) To ensure accountability, objectivity, and transparency in the expenditure of 17 Transportation Surtax proceeds, there is hereby established the ILA establishes an 18 independent Transportation and Infrastructure Surtax Oversight Board (the "Oversight 19 Board"). The Oversight Review Board shall to review and approve proposed 20 transportation projects funded, in whole or part, with Transportation Surtax proceeds, for 21 consistency with the requirements of Section 212.055(1), Florida Statutes, and the ILA. 22 Transportation projects shall be funded with Transportation Surtax proceeds as 23 approved by the Oversight Board.

1 <del>(a)</del> Composition. The Oversight Board shall be comprised of the following 2 nine (9) members: one (1) professional in each of the following fields: accounting, 3 finance, land use or urban planner, law, engineering or construction management, 4 architecture, and environmental science; one former elected official; and one former city 5 or county manager. None of the members shall, at any time during their term, be an 6 elected official or have an employment or contractual relationship with, or be employed 7 by any entity that has a contractual relationship with, Broward County. The following 8 five (5) persons (collectively, the "Appointing Authority"), none of whom may be a 9 current elected official, shall, based on procedures established by majority vote, make 10 nominations for members and shall, also by majority vote, appoint members on or 11 before May 1, 2017 (any designee may be removed and replaced at any time by the 12 designor):

13 1. The Secretary of the Florida Department of Transportation, District 4, or
 14 an employee of District 4 designated by the Secretary;

15 2. The designee of the Broward Workshop;

16 <del>3.</del> The designee of the Broward County Council of Chambers (of 17 Commerce):

18 4. The Broward County Auditor, or the Auditor's designee; and

19 5. The Director of the Florida Atlantic University Center for Environmental
20 Studies, or such person's designee.

(b) <u>Term of Oversight Board Members.</u> Oversight Board members shall serve
 four-year terms and may be reappointed for successive terms. Members may be
 removed for good cause determined by supermajority vote of the Appointing Authority,

and may be removed by a majority vote of the Appointing Authority if the member no
longer meets the qualifications for membership. Any member appointed to replace a
member who has been removed or who resigns shall serve for the balance of the term
of such member. The Appointing Authority shall meet as required to appoint or remove
members.

6 (c) <u>Oversight Board Meetings.</u> The Oversight Board shall meet quarterly.
7 The members shall elect a chairperson to preside over meetings. The Oversight Board
8 shall establish its own rules of procedure for conducting its meetings.

9 (d) <u>Staffing.</u> Broward County shall provide sufficient staff to enable the
 10 Oversight Board to efficiently perform its functions, and shall retain such consultants as
 11 the Oversight Board determines necessary to perform its responsibilities.

12 <del>(e)</del> Approval of Projects. All applications for projects funded by 13 Transportation Surtax proceeds shall be submitted to the Oversight Board, which shall 14 determine whether the project, as described in the project application, is permissible 15 under Section 212.055(1)(d)(4). If the Oversight Board determines that it is permissible. 16 the Oversight Board shall approve the project and shall send written notice thereof to 17 Broward County Administrator. If an approved project is only partially fundable with 1.8 Transportation Surtax proceeds pursuant to Section 212.055(1)(d)(4), the Oversight 19 Board's written approval shall identify those portions of the project fundable with 20 Transportation Surtax proceeds and shall state the total dollar value of those portions. 21 The written notice of approval may contain recommendations made by the Oversight 22 Board regarding best practices or other methods that may be employed to improve the 23 project. If the Oversight Board determines that a proposed project is not permissible

24

under Section 212.055(1)(d)(4), Florida Statutes, the Oversight Board shall reject the
project and shall, in writing, specify the reasons why the project was rejected. Rejected
projects may be modified and resubmitted for subsequent consideration by the
Oversight Board. The Oversight Board shall issue its written notice of project approval
or rejection within one hundred twenty (120) days of its receipt of a completed project
application.

7 (f) <u>Project Oversight.</u> All approved projects shall be subject to the Oversight
8 Board's review, critique, and analysis for the duration of the project. The Oversight
9 Board shall issue annual reports on the performance of ongoing projects and shall
10 provide recommendations for any proposed performance improvements.

(g) (b) <u>Annual Audits.</u> Broward County shall retain an independent certified
public accountant to perform and complete an a<u>A</u>nnual audits of all projects approved
by the Oversight Board and of all Transportation Surtax proceeds received, maintained,
and expended <u>shall be performed in accordance with the ILA</u>.

Section 2. <u>SEVERABILITY</u>.

18 If any portion of this Ordinance is determined by any Court to be invalid, the 19 invalid portion shall be stricken, and such striking shall not affect the validity of the 20 remainder of this Ordinance. If any Court determines that this Ordinance, or any portion 21 hereof, cannot be legally applied to any individual(s), group(s), entity(ies), property(ies), 22 or circumstance(s), such determination shall not affect the applicability hereof to any 23 other individual, group, entity, property, or circumstance.

#### Section 3. INCLUSION IN CODE.

It is the intention of the Board of County Commissioners that the provisions of
this Ordinance shall become and be made a part of the Broward County Code; and that
the sections of this Ordinance may be renumbered or relettered and the word
"ordinance" may be changed to "section," "article," or such other appropriate word or
phrase in order to accomplish such intentions.

# Section 10. EFFECTIVE DATE.

12 (a) This Ordinance shall become effective as provided by law.

(b) <u>Repeal Upon Electorate Disapproval</u>. If the levy of the Transportation
Surtax is not approved by a majority of the electors of Broward County voting in the
referendum at the General Election on November 8, 2016, this Ordinance shall expire
and be deemed repealed in its entirety on December 31, 2016, without further action by
the Board.

18 (c) <u>Sunset.</u> Except as provided in Section 10(b) above, the Transportation 19 Surtax shall "sunset" and expire on December 31, 2036 2046, at 11:59 p.m., without 20 further action by the Board, at which time the Transportation Surtax levied hereunder 21 shall be deemed repealed, terminated, and of no further force and effect, except that the 22 requirements of this Ordinance and any interlocal agreements relating to the 23 administration, use, or oversight of Transportation Surtax proceeds shall survive the

1 expiration of the Transportation Surtax, and shall be fully enforceable in a court of2 competent jurisdiction.

**SUBJECT:** Fiscal Impact Statement Re: Proposed Ordinance Amending Chapter 31 ½ of the Broward County Code of Ordinances, relating to the Transportation Surtax

# **Background**

Charter Counties have the authority to levy up to a 1 percent increase in the sales tax subject to approval by a majority vote of the electorate for Transportation purposes. Generally, the tax proceeds are restricted for the development, construction, operation, and maintenance of bus systems, fixed guide-way rapid transit systems, on-demand transportation services, roads, and bridges. The proposed ordinance amends the rate and duration of the transportation surtax to the terms of the Transportation System and Infrastructure Surtaxes Inter-local Agreement.

# Fiscal Impact

It is estimated that the levy of one-half cent of local option sales tax for transportation would generate \$158 million in revenue the first full year and is estimated to increase, on average, 2.2 percent each year for the life of the tax.

The tax would be effective January 1, 2017 and the first proceeds are anticipated to be received by the end of March 2017, therefore, only a partial year of revenues would be received in FY17.
