8. Re-approval of Modification #1 to Agreement #2015/2016-64 SHSG Issue 13

Re-approval of Modification #1 to Agreement #2015/2016-64 (FY2015 State Homeland Security Grant, Issue 13) with the State of Florida Division of Emergency Management, extending the Agreement term through March 31, 2017, with no change in the original Agreement amount of \$13,893.00. Following Board approval on December 13, 2016, the Division requested that additional reinstatement language be added to the modification as the previous Agreement had expired on Dec. 31, 2016, prior to signing and approval by the Division. 9. First Public Hearing to Consider Amendment to the Land Development Code to Add Rural Event Center as a Conditional Use with Conditions – Continued from January

A proposed ordinance to consider amendments to the Land Development Code to add Rural Event Center as a conditional use with conditions was presented to the Board on January 10, 2017. At the Board's January 10, 2017 meeting, the Board granted staff's request for a continuance of the public hearings until February due to input received from the community and the Board regarding the terms of the ordinance.

NEW BUSINESS

10. Clay County Youth Intervention Program

Approval to waive the Purchasing Policy and authorize staff to develop a Contract directly with W. Rick Curtis as the Program Director to manage the Clay County Youth Intervention Program, based on his years of experience and knowledge of the DJJ System. The State has allocated \$250,000.00 within the Department of Juvenile Justice budget for this program. This program has also been referred to as the S.W.E.A.T. program. (K. Thomas / Judge Collins)

11. Bid #15/16-1, Moody Avenue Park ADA Baseball Field

Approval to post notice of intent and award Bid #15/16-1, Moody Avenue Park ADA Baseball Field, to F & G Construction General Contractors, Inc. the lowest responsive bidder in the amount of \$457,000.00 which includes Alternate No. 1.- Large Group Shelter. Approval will be effective after 72 hour bid protest period has expired assuming no protests are received. Staff requests approval of the attached Construction Agreement. 12. Roadway Impact Fee Calculation For Clay County

Approval to accept staff's ranking of RFP #16/17-11, Roadway Impact Fee Calculation for Clay County, and approval of the contract with the number one ranked firm, Tindale-Oliver Associates, Inc., for a term not to exceed 12 weeks, for the cost of \$122,375.00.

13. Draft list of roadways to be included in Impact Fee Study

Attached is the list of roadway priorities identified in the Clay County Infrastructure Funding Study prepared by the TPO. Also attached is the list of roadway improvements included in the 2008 Road Impact Fee Study.

These lists will serve as the starting point for roadways to be included in the impact fee study. Once the consultant is under contract, a finalized list will be prepared and presented to the Board for consideration.

14. Fair Share Agreement between Clay County and Wisteria Properties, LLC

On June 28, 2016, staff presented three options for Board consideration in a discussion concerning the proposed fair share agreement with Wisteria Properties, LLC. ("Wisteria").

The purpose of the three options was to address Commissioner Robinson's concerns that the fair share payment was not being applied to the construction of the C.R. 739B improvement. Staff noted that, because C.R. 739B was not a segment included in the County's Road Impact Fee Ordinance, the applicant would not receive impact fee credits if that improvement was the one designated in the agreement. The Board voted 3-2 to designate C.R. 739B as the segment to be the designated road

improvement in the agreement. Because, under this scenario, impact fee credits would not be allowed, the applicant did not further pursue the final execution of the agreement. Subsequently, in January staff met with the applicant's representative and Commissioner Hendry to discuss language that could be included in the agreement that would be acceptable to both parties. Staff believes the attached agreement addresses the concerns of the Commissioner and the applicant.

Scott Westervelt's term as an At-Large member expired January 1, 2017. Mr. Westervelt submitted an application for Board consideration of reappointment as an At-Large member to the Planning Commission. Applications have also been received from Carl W. Davison and Michael Vermillion for Board consideration of an appointment as an At-Large member of the Planning Commission.
