**WHEREAS**, the temporary moratorium would be applicable to residentially zoned districts only; and

**WHEREAS**, the temporary moratorium would expire on April 30, 2017; and

**WHEREAS**, City Council does hereby find that the approval of this Resolution is in the best interest of the City of Marco Island

**NOW, THEREFORE, BE IT RESOLVED** by the City Council of the City of Marco Island, Florida that:

**Section 1.** The above recitals are true and correct and incorporated herein.

**Section 2.** The Marco Island City Council approves the temporary moratorium on the enforcement of parking regulations for vehicles blocking the sidewalks in residential districts between the hours of 10:00 p.m. and 6:00 a.m. through April 30, 2017.
