ORDINANCE NO. 2017-786 AN ORDINANCE RELATING TO SIGNS; PROVIDING FOR THE REPEAL OF THE EXISTING TOWN OF NORTH REDINGTON BEACH SIGN ORDINANCE CODIFIED AT CHAPTER 86, SUBPART B (LAND DEVELOPMENT CODE) OF THE TOWN OF NORTH REDINGTON BEACH CODE OF ORDINANCES; PROVIDING FOR A NEW TOWN OF NORTH REDINGTON BEACH SIGN ORDINANCE IN PLACE OF CHAPTER 86, SUBPART B (LAND DEVELOPMENT CODE) OF THE TOWN OF NORTH REDINGTON BEACH CODE OF ORDINANCES; PROVIDING FOR A PURPOSE, INTENT AND SCOPE; PROVIDING FOR APPLICABILITY; PROVIDING FOR DEFINITIONS; PROVIDING FOR PROHIBITED SIGNS IN ALL ZONING DISTRICTS; PROVIDING GENERAL PROVISIONS FOR SIGNS (SUCH AS THE MEASUREMENT OF SIGN SIZE, MEASUREMENT OF SIGN HEIGHT OF A FREESTANDING SIGN, SIGN ILLUMINATION FOR TEMPORARY AND PERMANENT SIGNS, VIEWPOINT NEUTRALITY, SUBSTITUTION OF NONCOMMERCIAL SPEECH FOR COMMERCIAL SPEECH, CONSENT OF LEGAL OWNER OF PROPERTY, SIGNS ON PUBLIC PROPERTY, SIGNS THAT OBSTRUCT MEANS OF EGRESS, SIGNS THAT INTERFERE WITH VENTILATION OPENINGS, SIGNS MUST MAINTAIN CLEARANCE FROM UTILITIES AND SHALL NOT INTERFERE WITH SURFACE AND UNDERGROUND WATER OR WITH DRAINAGE, SIGNS SHALL NOT BE ATTACHED TO CERTAIN PROPERTY AND SHALL NOT IMPAIR ROOF ACCESS, SIGNS DECLARED A NUISANCE AND REPAIR; SIGNS PRESENTING IMMEDIATE PERIL TO PUBLIC HEALTH OR SAFETY, STREET ADDRESS SIGNS, FLAGPOLES/FLAGS, FLAG BRACKETS/STANCHIONS/FLAGS, NONCOMMERCIAL ONSITE PARKING SPACE SIGNS, SIGNS AT SERVICE STATION ISLANDS, MONUMENT SIGNS, WALL SIGNS, AWNING SIGNS, CANOPY SIGNS, CHANGEABLE COPY SIGNS, PROJECTING SIGNS, WINDOW SIGNS, AND DOOR SIGNS); PROVIDING FOR ALLOWED TEMPORARY SIGNS IN ZONING DISTRICTS; PROVIDING FOR ALLOWED PERMANENT SIGNS IN ZONING DISTRICTS (INCLUDING RESIDENTIAL ZONING DISTRICTS AND NON-RESIDENTIAL ZONING DISTRICTS); PROVIDING FOR BUILDING PERMITS; PROVIDING FOR SIGN PERMITS; PROVIDING FOR NONCONFORMING SIGNS; PROVIDING FOR MISCELLANEOUS PROVISIONS; PROVIDING**
