

## ORDINANCE NO. 17- 02

AN ORDINANCE OF THE TOWN OF REDINGTON SHORES, FLORIDA, AMENDING SECTION 54-3 OF THE A CODE OF THE TOWN OF REDINGTON SHORES, FLORIDA@, PERTAINING TO CLOSING HOURS FOR BUSINESS ESTABLISHMENTS SERVING AND/OR SELLING ALCOHOLIC BEVERAGES, INTOXICATING BEVERAGES OR INTOXICATING LIQUOR; AMENDING THE CLOSING HOURS FOR SUCH BUSINESS ESTABLISHMENTS; PROVIDING FOR INCLUSION OF SUCH AMENDED ORDINANCE IN THE A CODE OF THE TOWN OF REDINGTON SHORES, FLORIDA@; PROVIDING AN EFFECTIVE DATE.

BE IT ORDAINED BY THE BOARD OF COMMISSIONERS OF THE TOWN OF REDINGTON SHORES, FLORIDA:

SECTION 1. That Section 54-3 of the Code of the Town of Redington Shores, Florida, is hereby amended as follows:

'54-3. Closing hours for business establishments serving and/or selling alcoholic beverages, intoxicating beverages or intoxicating liquor.

- A. Florida Statute '562.14 is hereby superseded.
- B. All business establishments in the Town of Redington Shores, licensed or unlicensed, dealing in alcoholic beverages, intoxicating beverages or intoxicating liquors, public or private, shall remain closed and shall not serve and/or sell alcoholic beverages, intoxicating beverages or intoxicating liquor from the hours of 2:00 a.m. to 8:00 a.m. each day of the week except Sunday.
- C. ~~All such business establishments shall remain closed and shall not serve and/or sell alcoholic beverages, intoxicating beverages or intoxicating liquor on each Sunday from the hours of 2:00 a.m. to 11:00 a.m.~~
- D. "Closed" shall mean that the business establishment may not be occupied by any customer or guest. Only the owner, manager and employees of same may lawfully enter or occupy the premises during closed hours.

ED. Vendors licensed under Florida Statute "563.02(1)(a), 564.02(1)(a) and 565.02(1)(a) are specifically included in the provisions of this chapter ~~with the exception that said vendors shall not dispense beer, wine or liquor between the hours of 12:01 a.m. and 8:00 a.m. each weekday, and between the hours of 12:01 a.m. Sunday and 11:00 a.m. Sunday.~~

SECTION 2. It is the intention of the Town Commission and it is hereby ordained that all other provisions of Chapter 54 of the ACode of the Town of Redington Shores@ not hereby modified or amended shall remain in full force and effect.

SECTION 3. It is the intention of the Town Commission and it is hereby ordained that the provisions of this Ordinance shall become and be made a part of the "Code of the Town of Redington Shores" and the publisher of the Code of Ordinances may renumber, reclassify or otherwise insert this Ordinance in an appropriate place to accomplish such intention.

SECTION 4. This Ordinance shall take effect immediately upon its final passage.
