Staff's Recommended Board Motion:

Approve and execute the attached First Modification Agreement with MCI Communications Services, Inc., d/b/a Verizon Business Services, to increase the agreement amount by \$1,406,700.00, from \$612,000.00 to \$2,018,700.00, (File No. 7814) for the 9-1-1 Agency and Public Utilities Department. This First Modification increases the agreement amount and consolidates services for the 9-1-1 Agency for the purpose of using the Private Internet Protocol (PIP) circuits that are currently serving more than seventy (70) sites associated with the Fire Printer Network utilized by Hillsborough County Fire Rescue, Tampa Fire Rescue, Temple Terrace Fire Department, and the Public Utilities Department (PUD). The requested modification will allow PUD to continue monitoring and controlling four (4) water treatment facilities, seven (7) wastewater treatment facilities, one (1) solids processing facility, thirty-three (33) reclaimed water pump stations and (800+) raw wastewater pump stations using the PIP circuits. There are sufficient funds in the requesting department's operating budget. Purchase orders will only be issued against approved budgets.

Financial Impact Statement:

Background:

On February 15, 2017, the BOCC awarded Sole Source File No. 7814, in the amount of \$612,000.00, to provide the ongoing and as needed Session Initiation Protocol (SIP) internet based digital Voice Communication Services for the Information and Innovation Office (IIO) and the 13th Judicial Court for a three (3) year period. PIP is a component of SIP, and the requested increase remains within the spirit of the approved Sole Source. Additionally, the requesting department reports that the pricing is the same or lower than the original Sole Source pricing. The Services performed under Agreement (BOCC Doc. No. 09-0089) are scheduled to expire on August 31, 2017.

THIS FIRST MODIFICATION AGREEMENT, dated this ____ day of ____ 2017, is entered into by and between **HILLSBOROUGH COUNTY**, a political subdivision of the State of Florida, hereinafter referred to as the "**COUNTY**"; and MCI Communications Services, Inc., d/b/a Verizon Business Services hereinafter referred to as the "**CONTRACTOR**".

WITNESSETH:

WHEREAS, the **COUNTY** and **CONTRACTOR** entered into a U.S. Services Agreement dated February 15, 2017, concerning COUNTY Sole Source File Number 7814, BOCC Doc. No. 17-0187, Session Initiation Protocol (SIP) internet based digital Voice Communication Services; and

WHEREAS, the award was for a three (3) year period beginning July 1, 2017 and ending June 30, 2020, in the amount of \$612,000.00 and three (3) one-year renewal periods; and

NOW, THEREFORE, in consideration of the mutual covenants, promises and representations contained herein and for other good and valuable consideration the receipt and sufficiency of which are hereby acknowledged, the **COUNTY** and **CONTRACTOR** hereby agree to modify the Agreement as follows:

1. The aforesaid recitals are true and correct and are incorporated herein by this reference.
2. The total monetary amount of the Agreement shall be increased by \$1,406,700.00 from \$612,000.00 to \$2,018,700.00.
3. The above revision shall become effective upon BOCC approval.

All other terms and conditions of the Agreement which do not conflict with this **FIRST MODIFICATION** are hereby reaffirmed in their entirety. In the event of a conflict between the terms of this modification and the Agreement, the terms of this modification shall control.
