SUBJECT: Amend Zoning Ordinance to Provide for No Through Truck Zones

**TITLE OF AGENDA ITEM:** AN ORDINANCE OF THE CITY COMMISSION OF THE CITY OF BELLE GLADE, FLORIDA, AMENDING CHAPTER 27 "TRAFFIC AND MOTOR VEHICLES" TO ADDRESS THE REGULATION OF COMMERCIAL VEHICLES BY AMENDING SECTION 27-10 "LOADED FIELD TRUCKS PROHIBITED ON CERTAIN STREETS"; PROVIDING FOR THE REPEAL OF ORDINANCES IN CONFLICT, SEVERABILITY, CODIFICATION, AND AN EFFECTIVE DATE.

**REPORT IN BRIEF:** Our current Code provides limitations/restrictions on loaded field trucks, having six or more bearing wheels, on certain city streets. The proposed Ordinance, attached, will replace existing language of "Loaded field trucks" with "No through truck zones", which includes a definitive definition of a heavy truck transporting property that has three or more axles, including, if attached, a trailer, or should the truck's gross weight be in excess of 8,000 pounds, including load and trailer.

Furthermore, this Ordinance, if accepted, will enhance the safety of pedestrians and bicyclers and the reduction of noise, pollution, and excessive wear and tear on S.E. Avenue G, along with previously identified areas.

There are exceptions in the proposed Ordinance, being: heavy truck deliverying or providing service to an area that would be inaccessible otherwise; to reach the driver's personal residence; public service or government-owned vehicles; and emergency vehicles.

Staff recommends approval of this Ordinance.



#### ORDINANCE NO.

#### AN ORDINANCE OF THE CITY COMMISSION OF THE CITY OF BELLE GLADE, FLORIDA, AMENDING CHAPTER 27 "TRAFFIC AND MOTOR VEHICLES" TO ADDRESS THE REGULATION OF COMMERCIAL VEHICLES BY AMENDING SECTION 27-10 "LOADED FIELD TRUCKS PROHIBITED ON CERTAIN STREETS"; PROVIDING FOR THE REPEAL OF ORDINANCES IN CONFLICT, SEVERABILITY, CODIFICATION, AND AN EFFECTIVE DATE.

WHEREAS, the City of Belle Glade, Florida (the "City") is a duly constituted municipality having such power and authority conferred upon it by the Florida Constitution and Chapter 166, Florida Statutes; and

WHEREAS, Section 316.008(1)(g), Florida Statutes, grants authority to the City to restrict the use of streets and highways under the City's jurisdiction; and

WHEREAS, in 1967, the City adopted Section 27-10 "Loaded field trucks prohibited on certain streets" of the City's Code of Ordinances which prohibits certain vehicles from travelling on certain streets within the City; and

WHEREAS, the City wishes to balance the needs of commerce and truckers with the desire to minimize the negative impacts of trucks on the City's roadways and neighborhoods, including, but not limited to, the safety of pedestrians and bicyclers and the reduction of noise, pollution, and excessive wear and tear on City streets; and

WHEREAS, the City Commission wishes to update Section 27-10 to meet the current needs of the City and to add to the list of protected streets; and

WHEREAS, the City Commission of the City of Belle Glade has determined that this ordinance serves a public purpose and is in the best interest of the public health, safety and welfare of the residents of the City.

# NOW, THEREFORE, BE IT ORDAINED BY THE CITY COMMISSION OF THE CITY OF BELLE GLADE, FLORIDA THAT:

Section 1. The foregoing recitals are hereby fully incorporated herein by reference as legislative findings of the City Commission of the City of Belle Glade.

Section 2. Chapter 27 "Traffic and Motor Vehicles", Section 27-10, "Loaded field trucks prohibited on certain streets" of the Code of Ordinances of the City of Belle Glade is hereby amended to read as follows:

Sec. 27-10. - Loaded field trucks prohibited on certain streets No through truck zones.

(a) <u>Definitions.</u>

#### Heavy truck, as used in this section only, shall be defined as:

- 1. Any truck with three (3) or more axles, including any attached trailer, if any; or
- 2. Any truck with a gross weight in excess of 8,000 pounds, including load and any attached trailer, if any;

*Truck*, as used in this section only, shall be defined as any motor vehicle which is designed or used principally for the transportation of property.

(b) <u>Prohibition.</u> It is unlawful to operate or permit to be operated any loaded field <u>heavy</u> truck, as defined herein, having six (6) or more bearing wheels upon the following designated streets in the city, provided, that the designated streets shall be properly signposted. The streets to which this section shall apply are as follows:

1. S.E. Avenue G.

2. All of those streets bounded on the east by South Main Street, on the west by Southwest Tenth Street, on the north by West Avenue A, and on the south by Southwest Avenue G, and the east-west projection thereof between the east-west boundaries, excluding South Main Street and Southwest Avenue E.
