SUBJECT: Fertilizer Ordinance

ISSUE: Consideration of adoption of ordinance

BACKGROUND SUMMARY: At a recent Lake County League of Cities luncheon a program was presented on the county's adoption of an enhanced fertilizer ordinance which changed to their Land Development Regulations pertaining to fertilizers.

Changes included:

- Phosphorous & Nitrogen Summer Application Ban which bans application of phosphorous & nitrogen from June through September to address increased runoff potential during the rainy season
- Increasing the application setback from water bodies from 10' to 15' to provide additional buffer for fertilizer runoff and a voluntary low maintenance zone extended to 15'
- Slow release Nitrogen content requirement for 50% slow release content to address leaching potential

The city adopted Florida Friendly Landscaping requirements some years back. The revision by the county has applied more stringent requirements.

STAFF RECOMMENDATIONS: Determine if the Council wishes staff to present an ordinance revising the fertilizer requirements.

Staff Summary

The purpose of this ordinance is to amend Lake County Code, Appendix E, Land Development Regulations, Chapter VI, Section 6.13.00, entitled "Fertilizer Use." On April 18, 2017, the Lake County Board of County Commissioners adopted the Florida Department of Environmental Protection Model Ordinance for Florida-Friendly Fertilizer Use on Urban Landscapes and amended the Code to provide a new section entitled "Fertilizer Use". This ordinance amends Section 6.13.00 by restricting the application of certain fertilizer from ten (10) feet to fifteen (15) feet of any pond, lake, stream, canal, or other waterbody, including wetlands; and requiring fertilizer containing nitrogen applied during the months of October through May must contain a certain amount of slow release nitrogen.

Changes are shown as follows: Strikethrough for deletions and <u>Underline</u> for additions to existing Code sections. The notation "* * *" shall mean that all preceding or subsequent text remains unchanged (excluding any renumbering or relettering that might be needed).

AN ORDINANCE OF THE BOARD OF COUNTY COMMISSIONERS OF LAKE COUNTY, FLORIDA; AMENDING LAKE COUNTY CODE, APPENDIX E, LAND DEVELOPMENT REGULATIONS, SECTION 6.13.00, ENTITLED "FERTILIZER USE"; RESTRICTING THE TIMING OF APPLICATION AND CONTENT OF CERTAIN FERTILIZERS; MODIFYING APPLICATION PERMITTED FROM TEN (10) FEET TO FIFTEEN (15) FEET OF A WATERBODY; PROVIDING FOR INCLUSION IN THE CODE; PROVIDING FOR SEVERABILITY; PROVIDING FOR FILING WITH THE DEPARTMENT OF STATE; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the quality of the lakes, streams and wetlands in Lake County are critical to the environmental, economic and recreational prosperity of the County and its residents; and

WHEREAS, the Lake County Board of County Commissioners developed, enacted, and
 implemented an ordinance pursuant to the Model Ordinance for Florida-Friendly Use on Urban Landscapes
 contained in Section 403.9337, Florida Statutes; and

WHEREAS, the Board of County Commissioners seeks to amend the previously adopted
 ordinance concerning fertilizer use to provide additional restrictions and requirements.

NOW THEREFORE, be it ordained by the Board of County Commissioners of Lake County,
 Florida, as follows:

6.13.01 General.

A. Legislative Findings. As a result of impairment to the County's surface waters caused
 by excessive nutrients, or, as a result of increasing levels of nitrogen in the surface and/or ground
 water within the aquifers or springs, the County has determined that the use of fertilizers on lands
 within Lake County has the potential for adverse effects on surface and/or ground water.
 Accordingly, the County finds that management measures contained in the "Florida-Friendly Best
 Management Practices for Protection of Water Resources by the Green Industries", as amended,
 may be required by this ordinance.

11 B. Purpose and intent. This section regulates the proper use of fertilizers by any 12 applicator; requires proper training of Commercial and Institutional Fertilizer Applicators; 13 establishes training and licensing requirements; establishes a Prohibited Application Period; specifies allowable fertilizer application rates and methods, fertilizer-free zones, low 14 15 maintenance zones, and exemptions. The Ordinance requires the use of Best Management 16 Practices which provide specific management guidelines to minimize negative secondary and 17 cumulative environmental effects associated with the misuse of fertilizers. These secondary and 18 cumulative effects have been observed in and on Lake County's natural and constructed 19 stormwater conveyances, rivers, creeks, canals, springs, lakes, estuaries and other water bodies. 20 Collectively, these water bodies are an asset critical to the environmental, recreational, cultural 21 and economic well-being of Lake County residents and the health of the public. Overgrowth of 22 algae and vegetation hinder the effectiveness of flood attenuation provided by natural and 23 constructed stormwater conveyances. Regulation of nutrients, including both phosphorus and 24 nitrogen contained in fertilizer, will help improve and maintain water and habitat quality.

C. Scope of Application. This Ordinance shall be applicable to and shall regulate any
 and all Applicators of fertilizer and areas of Application of fertilizer within the unincorporated
 portions of Lake County, Florida, unless such Applicator is specifically exempted under this
 section from the regulatory provisions of this section. This Ordinance shall be prospective only,
 and shall not impair any contracts existing before July 1, 2017.

6.13.02 Definitions. The following words, terms and phrases, when used in this section, will have the meanings set forth below unless the context clearly indicates otherwise.

Administrator means the County Manager or designee who has the authority to administer and enforce the provisions of this section.

Application or Apply means the actual physical deposit of fertilizer to turf or landscape plants.

Applicator means any Person who applies fertilizer on turf and/or landscape plants in unincorporated Lake County, Florida.

Best Management Practices means turf and landscape practices or combination of practices based on research, field-testing, and expert review, determined to be the most effective and practicable on-location means, including economic and technological considerations, for improving water quality, conserving water supplies and protecting natural resources.

Commercial Fertilizer Applicator, except as provided in F.S. § 482.1562(9), means any person who applies fertilizer for payment or other consideration to property not owned by the person or firm applying the fertilizer or the employer of the applicator.

Fertilize, Fertilizing, Fertilization means the act of applying fertilizer to turf, specialized turf, or landscape plants.

Fertilizer means any substance or mixture of substances that contains one or more recognized plant nutrients and promotes plant growth, or controls soil acidity or alkalinity, or provides other soil enrichment, or provides other corrective measures to the soil.

Guaranteed Analysis means the percentage of plant nutrients or measures of neutralizing capability claimed to be present in a fertilizer.

Institutional Applicator means any person, other than a private, non-commercial or a Commercial Applicator (unless such definitions also apply under the circumstances), that applies fertilizer for the purpose of maintaining turf and/or landscape plants. Institutional Applicators shall include, but shall not be limited to, owners, managers or employees of public lands, schools, parks, religious institutions, utilities, industrial or business sites and any residential properties maintained in condominium and/or common ownership.

Landscape Plant means any native or exotic tree, shrub, or groundcover (excluding turf).

Low Maintenance Zone means an area a minimum of ten-(10)fifteen (15) feet wide adjacent to water courses which is planted and managed in order to minimize the need for fertilization, watering, mowing, etc.

Person means any natural person, business, corporation, limited liability company, partnership, limited partnership, association, club, organization, and/or any group of people acting as an organized entity.

Prohibited Application Period means the time period during which a Flood Watch or Warning, or a Tropical Storm Watch or Warning, or a Hurricane Watch or Warning is in effect for any portion of Lake County, issued by the National Weather Service.

Lake County Approved Best Management Practices Training Program means a training program approved per F.S. § 403.9338, as amended, or any more stringent requirements set forth in this section, that includes the Florida Department of Environmental Protection's Florida-Friendly Best Management Practices for Protection of Water Resources by the Green Industries, 2008, as amended.

Saturated soil means a soil in which the voids are filled with water. Saturation does not require flow. For the purposes of this ordinance, soils shall be considered saturated if standing water is present or the pressure of a person standing on the soil causes the release of free water.

Slow Release, Controlled Release, Timed Release, Slowly Available, or Water Insoluble Nitrogen means nitrogen in a form which delays its availability for plant uptake and use after application, or which extends its availability to the plant longer than a reference rapid or quick release product.

Turf, Sod, or Lawn means a piece of grass-covered soil held together by the roots of the grass.

Urban landscape means pervious areas on residential, commercial, industrial, institutional, highway rights-of-way, or other nonagricultural lands that are planted with turf or horticultural plants.

Β.	Fertilizer Free Zones. Fertilizer shall not be applied within <u>fifteen (15)ten (10)</u> feet of any pond, stream, watercourse, lake, canal, or wetland as defined in Chapter 62-340, F.A.C., as amended, or from the top of a seawall, <u>unless a deflector shield, drop spreader</u> , or liquid applicator with a visible and sharply defined edge, is used, in which case a minimum of three (3) feet shall be maintained. Newly planted <u>tTurf and/or landscape</u> plants may be fertilized in this zone only for a sixty (60) day period beginning thirty (30) days after planting if need to allow the plants to become well established. Caution shall be used to prevent direct deposition of nutrients into the water.
C.	Low Maintenance Zones. A voluntary ten (10)fifteen (15) foot low maintenance zone is strongly recommended, but not mandated, from any pond, stream, water course, lake, wetland or from the top of a seawall. If more stringent Lake County-Code-regulations apply, this provision does not relieve the requirement to adhere to the more stringent regulations. No mowed or cut vegetative material may be deposited or left remaining in this zone or deposited in the water. Care shall be taken to prevent the over-spray of aquatic weed products in this zone.
D.	Fertilizer Content and Application Rates.
	 Fertilizers applied to <u>tTurf</u> within unincorporated Lake County shall be applied in accordance with requirements and directions provided by Section 5E-1.003, FA.C., as amended. Fertilizers containing nitrogen shall not be applied before seeding or sodding a site, and shall not be applied for the first thirty (30) days after seeding or sodding, except when hydro-seeding for temporary or permanent erosion control in an emergency situation (wildfire, etc.), or in accordance with the Stormwater Pollution Prevention Plan for that site. Fertilizers containing Nnitrogen or phosphorus fertilizer shall not be applied to Turf or landscape plants except as provided in subsection (1) above for Turf, or in UF/IFAS recommendations for landscape plants, vegetable gardens, and fruit trees and shrubs, <u>Furthermore, fertilizers containing phosphorus shall not be applied to Turf</u> unless a soil or tissue deficiency has been verified by an approved test. Fertilizers containing nitrogen applied to Turf or landscaping plants during the period of October 1 through May 31 must contain no less than fifty percent (50%) slow release riteres.

	 Spreader deflector shields are required when fertilizing via rotary (broadcast) spreaders. Deflectors must be positioned such that Fertilizer granules are deflected away from all impervious surfaces, fertilizer-free zones and water bodies, including wetlands. Fertilizer shall not be applied, spilled, or otherwise deposited on any impervious surfaces. Any Fertilizer applied, spilled, or deposited, either intentionally or accidentally, on any impervious surface shall be immediately and completely removed to the greatest extent practicable. Fertilizer released on an impervious surface must be immediately contained and either legally applied to Turf or any other legal site, or returned to the original or other

All businesses applying Fertilizer to Turf and/or landscape plants (including but not limited to residential lawns, golf courses, commercial properties, and multi-family and condominium properties) must ensure that at least one employee has a "Florida-Friendly Best Management Practices for Protection of Water Resources by the Green Industries" training certificate.

If any section, sentence, clause, phrase or word of this Ordinance is for any reason held or declared to be unconstitutional, inoperative or void, such holding or invalidity shall not affect the remaining portions of this Ordinance; and it shall be construed to have been the Commissioner's intent to pass this Ordinance without such unconstitutional, invalid or inoperative part

therein; and the remainder of this Ordinance, after the exclusion of such part or parts shall be deemed and 2 held to be valid, as if such parts had not been included herein; or if this Ordinance or any provisions thereof shall be held inapplicable to any person, groups of persons, property, kind of property, circumstances or set of circumstances, such holding shall not affect the applicability thereof to any other person, property or circumstances.

Section 5. Filing with the Department of State. The Clerk shall be and is hereby directed forthwith to send an electronic copy of this Ordinance to the Secretary of State for the State of Florida in accordance with Section 125.66, Florida Statutes.

Section 6. Effective Date. This ordinance shall become effective as provided for by law 12 ("Effective Date"); provided, however, that no enforcement action shall be taken, nor penalties or fines 13 shall be imposed for violations of this ordinance for a period of one (1) year from the Effective Date. After 14 this initial grace period of one (1) year, any violation of the provisions of this Ordinance may be subject to 15 the Code Enforcement proceedings outlined in Chapter 8, Lake County Code or the provision for injunctive 16 relief provided in Section 1-8, Lake County Code,
