15	WHEREAS, due to the lack of readily available legal parking options for patrons of
16	commercial businesses, City Council has determined it to be in the best interest of the public to
17	allow vehicle parking in swales and alleys in commercial areas between the hours of 7:00 a.m. and
18	midnight; and
19	WHEREAS, City Council finds that the City has a significant and substantial interest in
20	amending the City Code to allow for parking in swales and alleys adjacent to commercially zoned
21	districts between the hours of 7:00 a.m. and midnight.
22	NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY
23	OF MARCO ISLAND, FLORIDA:
24	SECTION 1. Recitals.
25	The foregoing "WHEREAS" clauses are hereby ratified and confirmed as being true,
26	correct, and reflective of the legislative intent underling this Ordinance.
27	SECTION 2. City Code Amended.
28	That Section 50-37 "Prohibited Parking" of Article II "Stopping, Standing and Parking" of
29	Chapter 50 "Traffic and Vehicles" of the Code of Ordinances of Marco Island, Florida, is hereby
30	amended by adding a new paragraph (1) to Subsection (3) to read as follows:
31	Chapter 50 – TRAFFIC AND VEHICLES

33	ARTICLE II. – STOPPING, STANDING AND PARKING

35	Sec. 50-37. – Parking Prohibited.

37	(3) Stand or park a vehicle on a swale, or in a swale area, whether the vehicle is occupied or
38	not, except momentarily to pick up or discharge a passenger, or passengers, or property, under
39	the following circumstances:

(1) Except between the hours of 7:00 a.m. and midnight for vehicles parking in swales
 and alleys adjacent to commercially zoned districts. unless otherwise temporarily
 modified by Council by Resolution, as deemed in the best interest of the City.

SECTION 3. Codification.

46 It is the intention of the City Council that the amendments to the City of Marco Island Code 47 of Ordinances made by this Ordinance shall constitute a revised Section 50-37 of the City 48 of Marco Island Code of Ordinances, and that the sections of this Ordinance may be 49 renumbered and re-lettered as necessary, and that the word "Ordinance" may be changed 50 to "Section", "Article" or other appropriate word.

51 SECTION 4. Conflicts.

All ordinances or parts of ordinances and all resolutions or parts of resolutions in conflict with the provisions of this Ordinance are hereby superseded and replaced to the extent of any conflict by the provisions of this Ordinance.

55 SECTION 5. Severability.

If any term, section, clause, sentence or phrase of this Ordinance is for any reason held to be invalid, illegal, or unconstitutional by a court of competent jurisdiction, the holding shall not affect the validity of the other or remaining terms, sections, clauses, sentences or phrases of this Ordinance, and this Ordinance shall be read and applied as if the invalid, illegal, or unenforceable term, provision, clause, sentence or section did not exist.
