## **RESOLUTION 2020-H**

A RESOLUTION OF THE CITY OF HIGH SPRINGS, FLORIDA; DETERMINING THE AMOUNT OF AND FIXING THE TENTATIVE RATE OF AD VALOREM TAXATION FOR FISCAL YEAR 2020/2021; PROVIDING FOR CONFLICTS, SEVERABILITY AND AN EFFECTIVE DATE

BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF HIGH SPRINGS, FLORIDA AS FOLLOWS:

**SECTION ONE**. That the tentative millage for Fiscal Year 2020/2021 is fixed at 5.8800 mills which is a 3.84% increase from the current rolled-back rate of 5.6628 mills.

**SECTION TWO.** MILLAGE RATE. That there shall be levied and collected by the City of High Springs, Florida for the Fiscal Year 2020/2021 upon all **NON-EXEMPT TAXABLE PROPERTY** within the corporate limits of said City, a tentative tax rate of 5.8800 mills on each dollar of non-exempt appraised value for the purpose of realizing a sum sufficient to fund the budget and meet and defray the necessary operating expenses of said City for the ensuing Fiscal Year.

**SECTION THREE. CONFLICTS**. All Resolutions or parts of Resolutions in conflict with any of the provisions of this Resolution are hereby repealed.

**SECTION FOUR. SEVERABILITY.** If any section or portion of a section of this Resolution proves to be invalid, unlawful or unconstitutional, it shall not be held to invalidate or impair the validity, force or effect of any other section or part of this Resolution.

**SECTION FIVE. EFFECTIVE DATE.** This Resolution shall become effective immediately upon passage and adoption this 10th day of September 2020.
