**RESOLUTION NO. 2020-\_\_\_**

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF WESTON, FLORIDA, APPROVING AND ADOPTING THE FINAL MILLAGE RATE FOR TAXATION OF REAL AND PERSONAL PROPERTY LYING WITHIN THE BOUNDARIES OF THE CITY OF WESTON TO FUND THE BUDGET FOR FISCAL YEAR 2021 COMMENCING OCTOBER 1, 2020 AND ENDING SEPTEMBER 30, 2021.

WHEREAS, First, the City of Weston is a municipality located in Broward County, Florida;  
and

WHEREAS, Second, pursuant to Section 200.065, Florida Statutes, a public hearing on the City of Weston's final millage rate for Fiscal Year 2021 was held at 7:00 p.m. on Wednesday, September 23, 2020, virtually at [www.westonfl.org/e-meeting](http://www.westonfl.org/e-meeting).

NOW, THEREFORE, BE IT RESOLVED by the City Commission of the City of Weston, Florida:

Section 1: The foregoing recitals contained in the preamble to this Resolution are incorporated by reference herein.

Section 2: The final millage rate approved and adopted for the taxation of all real and personal property lying within the boundaries of the City of Weston, Florida shall be 3.3464 mills per \$1,000.00 of assessed property value for the Fiscal Year 2021.

Section 3: The percentage by which the millage rate to be levied is 3.41% above the rolled back rate of 3.2360 mills [computed pursuant to F.S. 200.065 (1)] and 0.19% above the rolled back millage rate adjusted for change in per capita Florida personal income of 3.3402 mills as set forth herein.

Section 4: This final millage rate of 3.3464 per \$1,000.00 of taxable value is for the calendar year 2020 to fund the expenses for the Fiscal Year commencing October 1, 2020 and ending September 30, 2021.

Section 5: The City Clerk is directed to forward certified copies of this Resolution to the Broward County Property Appraiser, the Broward County Revenue Collector, and the Florida Department of Revenue.

Section 6: If any one or more of the provisions of this Resolution shall be held contrary to any express provision of law or contrary to the policy of express law, though not expressly prohibited or against public policy, or shall for any reason whatsoever be held invalid, then such provision shall be null and void and shall be separate from the remaining provisions, and shall in no way affect the validity of all other provisions of this Resolution.

Section 7: This Resolution shall take effect upon its adoption.
