What is the Meeting Agenda? The City Commission makes policies and conducts the city's business in an open and transparent forum. The agenda is an outline of what will happen during the meeting. It includes the following sections:

Adoption of Consent Agenda (CA): The Consent Agenda is a group of business items that are voted on together in one motion. These items are not discussed separately. The Commission may remove an item to discuss it during the meeting or at a later meeting. This process saves time for the Commission to discuss items on the Regular Agenda.

**Adoption of Regular Agenda:** The Commission must approve the order of items on the Regular Agenda, which is the list of items set for discussion. The Commission can also re-order or remove items.

The **(B)** after an item's title means that there are materials, called Backup, in support of the item. Click the links on the agenda to view the documents. An **(NB)** after an item's title means there are no Backup materials for the item.

**How to Share Your Opinion.** Your opinion is important to the City Commission. There are multiple ways to add a comment to the official record.

**Submit Written Public Comment:** You may write a public comment on any City Commission Meeting agenda item. Visit our website, www.cityofgainesville.org, and go to the "Agendas & Minutes" tab. Click on the "eComment" link in the right-hand column. Written comment opens when the agenda is published the Friday before the meeting and closes one (1) hour before the start of the meeting. Your comments will be sent to the City Commissioners and added to the official record.

**Speak at a Public Meeting:** Any member of the public may sign up to speak at a City Commission meeting. Visit our website, www.cityofgainesville.org, and go to the "Agendas & Minutes" tab on our website. Click on the "eComment" link in the right-hand column and register to speak on a specific agenda item. Online registration closes one (1) hour before the meeting is called to order. You may also register on the sign-up sheet in the Auditorium before the meeting begins. Speakers will be called to the podium by name and should address their comments to the Chair of the meeting, usually the Mayor. There are two types of public comment during Commission Meetings:

**General Public Comment:** The public is invited to speak to the Commission for three (3) minutes about any topic, as long as it is not on the Agenda. This is an opportunity to bring up new ideas or issues to the Commission. Each person may speak during one comment period: at the start of the 1pm session, at the start of the 5:30pm session, or at the end of the meeting. The Commission will not discuss or make decisions on ideas presented during this time. Comments may be referred to City staff for follow up.

**Public Comment on Agenda Items:** The Commission may request public comment on specific agenda items during discussion. Speakers may have three (3) minutes and comments must stay focused on the agenda topic at hand.

**Early Public Comment:** The Commission has created Early Public Comment to allow community members to speak on agenda items without waiting for the item to be called during the meeting. Speaking at Early Public Comment waives the right to speak later during the meeting. Members of the public may speak for three (3) minutes on one agenda item or five (5) minutes on two or more items. Speakers should begin their comments by announcing which items they are addressing so the timeclock can be set properly.

The City of Gainesville encourages civil public speech. Disruptive behavior is not permitted during City Commission meetings. Please do not bring food, drinks, props, signs, posters, or similar materials into the Auditorium. Cheering and applause are only permitted during the Proclamations/Special Recognitions portion of the meeting.

Transfer of Property Assets between GRU and General Government (NB)

AGENDA UPDATE - REMOVE ITEM

*Explanation:* There are times that General Government and GRU agree to transfer property between entities in order to best serve the community. General Government and GRU staff have coordinated to identify two such transfers.

1. Transferring a City of Gainesville real property asset to GRU for the purpose of constructing a solid waste handling facility.

The property for the Main Street Water Reclamation Facility was a 20 acre parcel purchased in 1930. The real property targeted for transfer is a 5.344 acre area located in the southeast corner of this 20 acre parcel, identified as Alachua County Tax Parcel No. 15691-000-000 ("the Property"). In 1967, the City leased the 5.344 acre area () to the Gainesville Municipal Waste Conversion Authority, Inc. (GMWCA) for the construction and operation of a Compost Plant. Between 1969 and 1975, GMWCA defaulted on the lease and the Compost Plant ceased operation. The site has remained unused since 1975. GRU has identified the need for a location to dewater and consolidate solids that are extracted from wastewater lines as part of GRU's wastewater line cleaning processes. GRU needs to dewater the solids so that they may be disposed of at a waste management facility. The Property is located just east of the Main Street Plant and is easily accessible by an existing 120-foot public utility easement that is currently used to access, maintain and operate electric transmission lines and sanitary sewer facilities. A dewatering location on the east side of Gainesville is needed at this time in order to be most efficient at rehabilitating the gravity mains near this location. The close proximity to the Plant, being located in a centralized location to the cleaning activities, immediate access to Williston Road, and the site setback from surrounding properties make this location ideal for the GRU's Solid Waste Handling Facility.

2. Transferring the GRU real property asset, Boulware Springs Park and Historic Water Works to the City of Gainesville's Parks, Recreation & Cultural Affairs (PRCA) department.

The real property targeted for transfer is a 30.3 acre area located at 3300 SE 15th Street, Boulware Springs Park, and is identified as Alachua County Tax Parcel No. 16244-000-000 ("the Property"). The Property was acquired around 1891 to serve as the water supply for Gainesville. In 1988, the City acquired an additional 73 acres to expand Boulware Springs for development of an urban park. These properties now operate together as Boulware Springs Park and Historic Water Works and are used as a public park that provides many amenities to residents and visitors, such as picnic facilities, parking, bathrooms, a historically preserved building, extensive tree canopy and a major trailhead for the 17-mile Gainesville-Hawthorne Trail.

The proposed terms include transfer of all the property and assets to PRCA, who is best equipped to maintain and operate this facility to best serve the public. PRCA will assume responsibility of providing utility services including electric, water, wastewater, telephone, communications, garbage pickup and maintenance of the associated with the property. The current operating agreement between GRU and PRCA will subsequently be discontinued.

*Fiscal Note:* There are no initial costs associated with transferring of the properties between General Government and GRU. There may be costs that each entity is planning regarding future use of the property that will need to be in each entity's budget. The solid waste handling facility has capital improvement costs that are in the approved W/WW budget. The cost to operate the Boulware Springs Park including the electric, water, wastewater, telephone, communications, garbage pickup and maintenance is estimated at \$20,000 - \$25,000 per year and will be the responsibility of PRCA.

> **RECOMMENDATION** The City Commission authorize the General Manager, or his designee, and the City Manager, or his designee, to complete the transfer of assets and property.

#### Florida Board of Trustees (UF) and the City of Gainesville (B)

This is a request for the City Commission to authorize the City Manager to execute the First Amendment to the Master Services Agreement with the University of Florida Board of Trustees and the City of Gainesville for Regional Transit System.

*Explanation:* For more than a decade, there has been a partnership between the University of Florida Board of Trustees (UF) and the City of Gainesville Regional Transit System (RTS) to provide public transit services to the UF community (including students, employees, spouses, and retirees).

COVID-19 has had a tremendous impact on transit across the nation and here in our own community. RTS has seen an unprecedented drop in ridership since March; monthly ridership dropped as much as 88% when compared to the monthly average of the last 3 years in the same month. As a result, service hours were reduced to account for anticipated revenue reductions. RTS projects that at least \$4.4 million worth of service revenue normally provided by the UF Master Service Agreement will be lost due to the pandemic between March 2020 and December 2020. In support of the City's efforts to battle the spread of COVID-19, UF has once again become a valued partner in our community.

The proposed amendment provides \$2,977,000 in funding for the period of March 2020 through December 2020 to pay for special cleaning and disinfecting activities related to COVID-19 to ensure safe, accessible and sufficient RTS transportation service, including a full complement of RTS drivers, for the 2020 Fall Semester. The remaining difference of approximately \$1.4 million between lost service revenue and the COVID-19 prevention assistance provided by UF will be offset by a combination of a reduction in operating expenses and the FTA CARES funds.

*Fiscal Note:* The total anticipated revenue for these additional services are not to exceed \$2,977,000 as outlined in the Amendment.

**RECOMMENDATION** The City Commission authorize the City Manager or his designee to execute the First Amendment to the Master Services Agreement and related documents between the University of Florida Board of Trustees and the City of Gainesville, subject to approval by the City Attorney as to form and legality.

# CA-9 <u>200293.</u> Interlocal Agreement Concerning the Preparation and Funding of the Alachua Countywide Bicycle-Pedestrian Master Plan (B)

This item is a request for the City Commission to approve the City's participation in a joint agreement with the Metropolitan Transportation Planning Organization for the Gainesville Urbanized Area (MTPO), Alachua County and the University of Florida for the development of a countywide Bicycle-Pedestrian Master Plan.

*Explanation:* The City of Gainesville together with Alachua County and the University of Florida are jointly funding the update of the Alachua Countywide Bicycle and Pedestrian Master Plan. This plan will serve as an update to the current Alachua Countywide Bicycle Master Plan planning document series and the initial Alachua Countywide pedestrian facility planning document. This multimodal planning document will address the safe mobility of bicyclists and pedestrians, including the provision of access to regional transit service, bicycle and pedestrian facility connectivity and roadway network integration. The MTPO staff has released an RFP soliciting consulting services for the plan development which is expected to begin in January 2021. City staff will participate in the consultant selection and plan development.

City of Gainesville and ElderCare of Alachua County, Inc. for continuation of the On-Demand Senior Transportation Program.

*Explanation:* The City of Gainesville has had a funding agreement with ElderCare of Alachua County, Inc., for the On-Demand Transportation Services program since FY2015. Due to its continued popularity, the program has been approved for renewal each year through the budget process.

ElderCare of Alachua County, Inc. is responsible for the management and oversight of the program and has a separate contract with subcontractors that provide the transportation services to eligible seniors.

On-Demand Transportation Services are defined as on-call transportation originating or ending within the City of Gainesville limits, and not extending outside Alachua County limits, from the first floor or main lobby of the Eligible Passenger's origin to the first floor or main lobby of the Eligible Passenger's destination.

*Fiscal Note:* There is \$36,200 budgeted in the FY 2021 budget for the On-Demand Senior Transportation program.

**RECOMMENDATION** The City Commission authorize the City Manager (or designee) to execute the FY2021 funding agreement between the City of Gainesville and ElderCare of Alachua County, Inc. for continuation of the On-Demand Senior Transportation Program, subject to review by the City Attorney as to form and legality.

This item is a request for the City Commission to approve the second amendment to the Interlocal Agreement between Alachua County and the City of Gainesville for Recycling Processing extending the term through FY21.

*Explanation:* Alachua County has processed and marketed the City's curbside recycling since 2014 at the County's Material Recovery Facility at the Leveda Brown Environmental Park. The current agreement was originally approved in 2019 by the City Commission. The current agreement expired on September 30, 2020.

> Costs and revenues from the contract are dependent on the average price of recyclables marketed by Alachua County. The value of recyclables has been less than the cost to process the material which results in a monthly bill to the City. The City receives revenue when the average price for recyclables is greater than \$150 per ton.

The Alachua County material recycling facility is the only dual stream recycling processing facility in the area.

*Fiscal Note:* Funding in the estimated amount of \$250,000 is budgeted in the FY21 Solid Waste Fund Account.

## Edward Byrne Memorial Justice Assistance Grant Program FY 2020 (JAG) (B)

*Explanation:* This is a Memorandum of Understanding agreement between the Alachua County Board of County Commissioners, the Alachua County Sheriff Office (ACSO), and City of Gainesville Police Department (GPD) of disbursement of funding available under the Edward Byrne Memorial Justice Assistant Grant Program Solicitation (JAG). Upon award receipt, the City will use the funds for Law Enforcement equipment including cameras and associated expenses and NIBRS training. *Fiscal Note:* The Sheriff agrees to provide the City funds upon receipt of award. The amount the City agrees to use is \$64,073 of the total of \$106,697 for equipment including cameras and associated expenses and NIBRS training.

This is a request of the City Commission's approval to accept the grants through the Florida Department of Transportation Safety Office.

Explanation: The Florida Department of Transportation's Safety Office is sponsoring the City of Gainesville Motorcycle/Scooter Safety and Education Program, the Gainesville Police Department Distracted Driver Program and the City of Gainesville Safe Gator Program. The City of Gainesville Motorcycle/Scooter Safety and Education Program is an overtime-only for proactive traffic enforcement projects with a focus on motorcycle and scooter infractions. The grant also funds a minimum of twelve (12), six-hour Safe Motorcycle and Rider Techniques (SMART) courses to train civilian riders in real world scenarios. The Gainesville Police Department Distracted Driver Program is an overtime-only for proactive traffic enforcement projects with a focus on reducing distracted driving behaviors. The City of Gainesville Safe Gator Program is an overtime-only detail for proactive enforcement and education with a focus on impaired driving. All grants are overtime-only education and proactive traffic enforcement projects with funding provided by the Florida Department of Transportation. The amount requested though the grant application is as follows: Motorcycle/Scooter Safety and Education Program \$65,000 GPD Distracted Driver Program \$55,000 City of Gainesville Safe Gator Program \$65,000 Total requested from the Florida Department of Transportation \$185,000 Fiscal Note: The total grant awarded to the City is \$140,000 The original amount requested for the City of Gainesville Motorcycle/Scooter Safety and Education Program was \$65,000 however FDOT awarded \$50,000. The original amount requested for the GPD Distracted Driver Program

was \$55,000 however FDOT awarded \$25,000. The original amount requested for the City of Gainesville Safe Gator Program was \$65,000 however FDOT awarded \$65,000.

The top three firms moved forward to oral presentations (demonstration of software) with the committee ranking those firms in the following order: 1) Crowe LLP, 2) Sysoft, and 3) Information Consultants Inc.

Crowe LLP was chosen as the vendor to accomplish the City's goals of centralization of all departmental contracts. Crowe' has customizable dashboards in order for departments to get a consolidated view into the status of all outstanding contract obligations and to take action if something needs to be addressed. The approval process between Legal, Risk, Procurement and other approvers will be streamlined, and with automated updates, the current status of all contracts is quickly viewable with the ability to quickly pinpoint next steps and red flags. The software will track and manage contract planning, solicitation, execution, and closeouts. Documents are stored securely in the cloud.

*Fiscal Note:* The total bid award amount is \$162,500.00. \$42,500.00 for year one implementation has been allocated for this project in the FY2020 budget. The remaining years 1-4 are \$30,000.00 per year and will be funded by the Budget and Finance Department's operating budget.

*Explanation:* FDOT proposes Financial Project Number ("FIN") 444990-1-52-01, which shall include the replacement, installation, or construction of various signage, pavement markings, and/or flashing signs within various, identified school zones.

*Fiscal Note:* There is no capital fiscal impact with this request, as construction will be performed by FDOT. There may be a periodic maintenance cost

(estimated to be less than \$5,000 annually) related to operating and maintaining school zone flashers, pavement marking and signage as needed.

**RECOMMENDATION** The City Commission adopt a Resolution authorizing the execution of the Construction and Maintenance Agreement with FDOT and authorize the City Manager to execute all necessary documents, subject to the approval of the City Attorney as to form and legality.

Ordinance No. 200067

An ordinance of the City of Gainesville, Florida, amending Section 30-3.30. Review Criteria of the Land Development Code (Chapter 30 of the City of Gainesville Code of Ordinances) relating to Wellfield Protection Special Use Permits; providing directions to the codifier; providing a severability clause; providing a repealing clause; and providing an effective date.

Explanation: STAFF REPORT

This ordinance will amend the Land Development Code (LDC) Wellfield Special Use Permit issuance criteria to allow the underground storage of petroleum within the tertiary Murphree Wellfield Zone. The affected area is primarily located in the northeast quadrant of the City of Gainesville and extends past the city boundaries. The tertiary Murphree Wellfield Zone is the least restrictive out of the three Murphree Wellfield zones and has historically allowed for underground storage of petroleum via Special Use Permit. After the 2017 Land Development Code update, language that previously allowed the underground storage of petroleum in the tertiary wellfield zone was eliminated. Staff was not able to find any record that this omission was intentional.

The City Plan Board held a public hearing on June 25, 2020, where it voted to recommend approval of this amendment to the Land Development Code. This ordinance requires two hearings and will become effective immediately upon adoption at second reading.

RECOMMENDATION The City Commission adopt the proposed ordinance.

An ordinance of the City of Gainesville, Florida, to vacate, abandon, and close a certain public right-of-way generally located south of SW 4th Avenue, west of SW 12th Street, north of SW 5th Avenue, and east of SW 13th Street, as more specifically described in this ordinance, subject to terms and conditions; providing directions to the Clerk of the Commission; providing a severability clause; providing a repealing clause; and providing an effective date.

#### Explanation: STAFF REPORT

This ordinance vacates, with certain conditions, a portion of a 15-foot wide east/west alley and a 20-foot wide north/south alley that lays between SW 4th and 5th Avenues. The east/west right-of-way distance is approximately 300 feet and the north/south right-of-way is approximately 150 feet. The right-of-way to be vacated is improved and totals approximately 4,800 sq. ft. (+/- 0.12 acres). Vacation of this public right-of-way will facilitate the redevelopment of the adjoining properties as part of a high-density, multiple-family development. All of the adjacent property owners, including the applicant, agree to this vacation of public right-of-way. The City Commission may vacate a public right-of-way upon its finding that the criteria in Section 30-3.41 of the Land Development Code have been met.
