## **ORDINANCE NUMBER 2456-2020**

AN ORDINANCE OF THE CITY OF STUART, FLORIDA AMENDING THE STUART CODE OF ORDINANCES, CHAPTER 12 – BUSINESS, ARTICLE VI. WRECKERS AND VEHICLE TOWING, TO BE IN ACCORDINACE WITH FLORIDA STATE STATUTE; FOR REPEAL OF CONFLICTING ORDINANCES; PROVIDING FOR SEVERABILITY; PROVIDING FOR CODIFICATION; AND PROVIDING FOR AN EFFECTIVE DATE, AND FOR OTHER PURPOSES.

WHEREAS, the Stuart Police Department is recommending an amendment to the City of Stuart Code of Ordinances, Chapter 12 – Business, Article VI. Wreckers and Vehicle/Vessel Towing in order to remove inconsistencies therein and be consistent with revised Florida Statutes; and

**WHEREAS**, the revised Ordinance will now include "vessels" in accordance with Florida Statute §327.02; and

WHEREAS, the revised Ordinance amends the towing storage site location from six (6) miles to ten (10) miles which broadens the amount of towing companies the City of Stuart may utilize; and

WHEREAS, the revised Ordinance will add language requiring a property owner to post notice with specific requirements, which apply to vehicles, that unauthorized vehicles or vessels will be towed away at the owner's expense; and

**WHEREAS**, the City Commission of the City finds that it is in the best interest of the public health, safety and welfare of the citizens of the City of Stuart to amend the Code of Ordinances of the City of Stuart to be consistent with Florida Statute 715.07.

## NOW THEREFORE BE IT ENACTED BY THE PEOPLE OF THE CITY OF STUART, FLORIDA:

**SECTION 1:** Pursuant to the amendments to Florida Statute 715.07, City of Stuart Code of Ordinances, Chapter 12 – Business, Article VI. Wreckers and Vehicle/Vessel Towing is hereby amended as set forth in Attachment "A", attached hereto.

**SECTION 2:** If any word, clause, sentence, paragraph, section or part thereof contained in this Ordinance is declared to be unconstitutional, unenforceable, void or inoperative by a court of competent jurisdiction, such declaration shall not affect the validity of the remainder of this Ordinance.

**SECTION 3:** All ordinances or parts of ordinances herewith are hereby repealed to the extent of such conflict.

**SECTION 4:** The provisions of this Ordinance shall be codified.

**SECTION 5:** This Ordinance shall take effect upon adoption.
