Adopt Ordinance No. 1652, First Reading, An Ordinance of the City of Cocoa Beach, Florida, amending the Future Land Use Element of the City's Comprehensive Plan, specifically amending Policy II.2.1 relating to allowable Building Heights; providing for severability; and providing for an effective date. Ordinance No. 1652 would amend the Comprehensive Plan by:
 - adding language with respect to height to address wireless communication towers and lightning rods. The installation of a wireless communication tower for public safety, and cell service operations, to be located at the new police facility, may require a height above 45 feet. The application of this policy would apply to towers only, and not to associated equipment buildings.
 - removing the requirement to amend the Comprehensive Plan each time there is a variance approval for building height. The removal of this policy would in no way affect the approval status of the sites with a height variance approval.
