  - adding language with respect to height to address wireless communication towers and lightning rods. The installation of a wireless communication tower for public safety, and cell service operations, to be located at the new police facility, may require a height above 45 feet. The application of this policy would apply to towers only, and not to associated equipment buildings.
  - removing the requirement to amend the Comprehensive Plan each time there is a variance approval for building height. The removal of this policy would in no way affect the approval status of the sites with a height variance approval.

The project is a demolition and redevelopment of the current International Palms Resort, and is the future site of the Westin Hotel and Resort Cocoa Beach. The Westin will contain 502 guest rooms, which is the vested density for the site, and associated amenities. A public access easement and public beach access will be provided. Utilities and underground infrastructure will be replaced; the pervious area will be increased; and an exfiltration stormwater management system will be incorporated. Low impact design (LID) concepts, with native Florida-Friendly landscaping and turtle friendly lighting will be employed.
