#### LEGISLATIVE ITEMS

**44.** <u>21-0601 - Pdf</u>

Installing New Lot of Record Date within the Large Scale Agriculture and General Agriculture Future Land Use Map Categories – Adoption Hearing. Request to approve by ordinance, a proposed substantive and technical amendment to the Walton County Comprehensive Plan, specifically Policies L-1.2.1 and L-1.2.2 pertaining to the Large Scale Agriculture and General Agriculture Future Land Use Map categories, allowing parcels of land recorded within the Official Records of Walton County on or before January 1, 2021 to qualify for one (1) single family residential dwelling unit, notwithstanding the allowable density for these categories.

Also requested is a request to approve by ordinance, several proposed companion amendments to the Walton County Comprehensive Plan and a second reading of proposed companion amendments to the Land Development Code. 1) Amending Policy L-1.11.3 of the Walton Comprehensive Plan pertaining to lot of record limitations, providing for internal consistency and clarity. 2) Amending Section 2.02.00 M of the Walton County Land Development Code pertaining to existing lot of record provisions providing for internal consistency and clarity. 3) Amendments to Sections 2.02.01 and 2.02.02 of the Walton County Land Development Code pertaining to the Large Scale Agriculture and General Agriculture Zoning Districts, allowing parcels of land recorded with the Official Records of Walton County on or before January 1, 2021 to qualify for one (1) single family residential dwelling unit, notwithstanding the allowable density for these categories.

**45.** <u>21-0602 - Pdf</u> Wetland Density Transfers – Transmittal Hearing. Proposed technical and substantive text amendment to the Walton County Comprehensive Plan Conservation Element, specifically Policy C-1.1.2, eliminating the currently authorized transfer of the gross density from wetland portions of development sites to upland portions when wetlands portions are not impacted within the South Walton Planning Area.

First Reading. Also proposed is a companion amendment to Section 4.01.03 of the Walton County Land Development Code eliminating the currently authorized transfer of density from non-impacted primary and secondary wetland protection zones to other portions of the site. The proposed companion amendment is only applicable to the South Walton Planning Area.

**46.** <u>21-0603 - Pdf</u> Amending the General Agriculture and Large Scale Agriculture Future Land Use Map Category Allowable Densities when Road Frontage Exists – Transmittal Hearing. Proposed technical and substantive amendment to Walton County Comprehensive Plan, specifically policies L-1.2.1 and L-1.2.2, amending the allowable residential density to one (1) unit per five (5) acres from one (1) unit per forty (40) acres within the Large Scale Agriculture category and one (1) unit per ten (10) acres within the General Agriculture category, where there is at least 100 feet of parcel road frontage on a County maintained roadway.

First Reading. Also proposed are two companion amendments to the Walton County Land Development Code: 1) Amending Sections 2.02.01 and 2.02.02 pertaining to the Large Scale Agriculture and General Agriculture Zoning Districts changing the allowable density from one (1) unit per forty (40) acres and one (1) unit per ten (10) acres respectively, to one unit per five acres in cases where the proposed development parcel contains at least 100 feet of frontage along a County maintained roadway. 2) Amending Section 1.13.12 pertaining to Major Plats, increasing the threshold for requiring plat from four acre lots to five acre lots and including the option for un-platted lots with at least 100 feet of frontage on a County maintained roadway.
