1. Request Staff to study the feasibility of allowing private golf cart use on the City's Golf Course. Florida Statutes 320.01(22) defines golf carts. The study would include recommendations for private golf cart usage, golf cart street route designations, and signage.

2. Consider the recommendations, discussed at the May 3, 2021, Planning Board meeting, to initiate the sale of City property, located at 870-880 South Orlando Avenue, for a price of no less than the appraised value of 795,000 dollars. Bids would be evaluated, ranked and recommended in the best interest of the City by a selection committee, comprised of the Mayor, City Manager, and Planning Board Chair. Final determination to be made by the City Commission.

On May 3, 2021, The Planning Board recommended the following:

That the minimum acceptable bid is \$795,000 (appraised value).

That the bid solicitation allows bidders to submit:

- Either a dollar bid accompanied by a conceptual development proposal describing the intended use of the land that is consistent with the City Charter, Comprehensive Plan, or Land Development Regulations

- Or a straight dollar bid without a conceptual development proposal.

That bids received be reviewed from a qualitative and quantitative perspective and then evaluated and ranked as in the best interest of the city by a selection committee comprising the Mayor, the City Manager, and the Chair of the Planning Board with the committee making its recommendation on the sale of the property to the City Commission. That the City Commission make a final determination on the sale of the property.

City staff requests the following be added to the motion:

Development proposals include type of housing, number of units, parking, approximate height, etc.

That city staff is authorized to proceed with advertising the property for sale as soon as practicable.

3. Discuss the need for a study to levy Service Assessment Fees to aid the Cocoa Beach Public Safety Departments (Cocoa Beach Fire Department and possibly the Cocoa Beach Police Department). Florida Statute Chapter 170, Supplemental and Alternative Method of Making Local Municipal Improvements, provides for the method to implement a special assessment. Florida Statue 197.3632 provides for a uniform method for the levy, collection, and enforcement of non-ad valorem assessments. Such assessments would authorize annual funding of public safety protection services, facilities, or programs to be collected using the property tax bill.
