Subject: Ordinance relating to the authority to issue parking citations

Resolution / Ordinance Title: An Ordinance of the City of Tampa, Florida, relating to the authority to issue parking citations; making revisions to City of Tampa Code of Ordinances Chapter 15 (Parking); Amending Article I, (Administrative Provisions); Division I. - (General Provisions; Administrative Authority; Definitions;) Section 15-4.5, (authority to issue citations for parking tickets); repealing all ordinances or parts of ordinances in conflict therewith; providing for severability; providing an effective date.

RECOMMENDATION:
For City Council approval.

BACKGROUND:
The City of Tampa has established standards for parking in Chapter 15, Parking City of Tampa Code of Ordinances (City Code). Section 15-4.5 of the City Code authorizes parking enforcement specialists and police officers to issue parking citations for violations of Chapter 15. Section 27-283.11(b) of the City Code prohibits the parking of “commercial equipment” in residential districts, with the exceptions of loading/unloading and personal vehicles regardless of commercial names or insignias. Currently, violations of Section 27-283.11(b) are enforced via Code Enforcement. To provide more effective and uniform enforcement of all parking standards, parking enforcement specialists and police officers require the ability to issue parking citations for violations of Section 27-281.11(b), using Section 15-4.5, the authority to issue citations for parking tickets. Tampa City Council has determined that the amendment is in the best interest of the residents of the of the City of Tampa.
