SUBJECT: Ordinance 2021-13 Amending Off-Street Parking Requirements Second Reading

RECOMMENDATION: AN ORDINANCE OF THE VILLAGE COMMISSION OF THE

VILLAGE OF BISCAYNE PARK, FLORIDA, AMENDING SECTION 5.6 "OFF-STREET PARKING" OF CHAPTER 5 "TRANSPORTATION" OF THE BISCAYNE PARK LAND DEVELOPMENT CODE TO LIMIT APPROVED PARKING SURFACES TO ONLY FORTY PERCENT (40%) OF THE FRONT YARD, AND REQUIRING THAT THE REMAINDER OF THE FRONT YARD CONSIST OF LANDSCAPING AND

GREEN AREA; REQUIRING THAT ALL PARKING SURFACES SHALL BE OF ONE MATERIAL AND OF UNIFIED DESIGN THROUGHOUT; AMENDING AND

CLARIFYING THE ALLOWABLE MATERIALS FOR PARKING

SURFACES; PROVIDING THAT CONCRETE PARKING

SURFACES CAN BE PAINTED SUBJECT TO THE

LIMITATIONS SET FORTH THEREIN; PROVIDING FOR DRAINAGE AND MAINTENANCE REQUIREMENTS; REQUIRING THAT ANY IMPROVEMENTS TO FIFTY PERCENT (50%) OR MORE OF A PARKING SURFACE SHALL REQUIRE THAT THE ENTIRE PARKING SURFACE

BE IMPROVED.

BACKGROUND:

On August 5, 2021, the Commission commenced a discussion

concerning the scope and details of a potential ordinance

amending the Village's off-street parking requirements.

On September 7, 2021, the Commission further clarified and confirmed their intentions with respect to proposed amendments to the Village's off-street parking requirements.

Based upon the consensus of, and direction given by, the Village Commission, an ordinance was prepared amending Section 5.6 of the Village's Land Development Code, updating the Village's off-street parking requirements.

The proposed ordinance was scheduled for the first available meeting of the Planning Board, which was October 4, 2021. The recommendations of the Planning Board were distributed and considered by the Commission during First Reading. Additional revisions were made and the item is now before the Commission for approval on Second Reading.
