Consideration of an ordinance amending Chapters 1, 2, 5, and 9 of the Walton County Land Development Code establishing regulations and creating a new regulatory program related to short term vacation rental units within unincorporated Walton County. The proposed amendment: creates a required host registration and compliance program; provides for onsite parking requirements at a rate of one onsite parking space per 600 square feet of living area; establishes certain life safety related requirements; establishes enhanced review of larger units including building and design standards aimed at neighborhood compatibility; and includes other regulations and requirements.
