Ordinance No. 2023-1 Amending the Land Development Code Chapter 61, Part 2 (Streets and Rights-of-Way); Chapter 64 (Signs); Chapter 65, Part 2 (Applications and Procedures); and Chapter 66 (Definitions) As They Pertain To Signs (LDC2022-10007) (Economic Development)

## **Summary:**

From time to time the need arises to amend City regulations in order to comply with court cases, react to new legislation, respond to an evolving industry and/or to make the rules easier to understand by both the general public and City staff. This amendment is an effort to update Chapter 64 (Signs) of the City's Land Development Code (LDC).

There are four (4) main priorities being addressed by the proposed amendment:

- Rewriting existing regulations for signs and/or their characteristics in a content neutral manner as required by the Supreme Court, to include new provisions for the regulation of Minor (temporary) signs,
- Reorganizing existing sign provisions in a more user-friendly format to include tables and updated definitions
- Introducing new standards to allow certain digital signs and other sign types in response to changing industry technologies,
- Establishing more uniform regulations of signs across all zoning districts to simplify and clarify the standards

Associated sign regulations found in other parts of the LDC are also being updated accordingly.
