# **Affordable Housing Services**

- A-1 (a) Approve the First Modification to the CDBG Funding Agreement between Hillsborough County, Sunrise Community, Inc., and Regional Properties, Inc., for public facility improvements located at 2714 Kirby Drive, Tampa, Florida 33614 to extend the expenditure deadline from January 31, 2023 to May 31, 2023. The First Modification also extends the expiration date of the agreement from April 30, 2023 to July 31, 2023. (b) Approve a First Amendment to the Land Use Restriction Agreement with Sunrise Community, Inc. and Regional Properties, Inc., to extend the declaration of covenants until July 31, 2038. (c) Approve the First Modification to CDBG Funded Mortgage and Note with Sunrise Community, Inc. and Regional Properties, Inc. to extend the term of the Mortgage and Note to July 31, 2038. The extension of time is required due to the fact that the lowest bid came in over the allotted budget. Sunrise Community and Regional Properties, its consultant, and general contractor required time to renegotiate which resulted in the reduction in the scope of work to accommodate the allotted available funds. (d) Approve authorization of the Hillsborough County Board of County Commissioners Chair to execute the documents included herein as approved by the County Attorney's Office and recommended by Affordable Housing Services. There is no fiscal impact associated with this modification.
- A-2 Approve a Third Modification to the Software as a Service (SaaS) Agreement ("Third Modification") between Hillsborough County ("County") and Benevate, Inc., ("Benevate") for its Neighborly software authorizing an additional \$10,411. 68 to add a County department and its users; and remove two (2) other County departments and users as part of the Affordable Housing Services existing agreement. The existing agreement ("Existing Agreement") originated with Affordable Housing Services ("AHS") to manage regulatory compliance and monitoring of its programs; other County Departments such as Economic Development, and Customer Service also utilize the software to support the enrollment, qualification, administration and reporting requirements for various programs and services administered by their departments that benefit county residents, interlocal agencies, non-profit and for-profit agencies. This Third Modification adds an additional \$10,411.68 in funding to the existing agreement in order to add the Hillsborough County Arts Council to the remaining 1st year extended term. Payment to Benevate shall be prorated upon execution of the Third Modification. Two (2) County departments will be removed from the Existing Agreement at their request thereby reducing the overall funding required. Total funding for the Neighborly software across all County departments including the Arts Council for FY 23 is \$109,635.04. The \$10,411.68 in funding required is available in the Arts Council approved FY 23 budget, the payment amount shall be prorated from the effective date to December 17, 2023, and purchase orders will only be issued against approved budgets.
- A-3 Approve a Joinder and Consent to the Dedication of Lands for the replat of the Overlook Oaks Estates subdivision by Hillsborough County as mortgagee pursuant to the HOME CHDO Funding Agreement between Hillsborough County and Hillsborough County Habitat for Humanity Community Development Housing Organization, Inc. for development of affordable housing on land located at Overlook Drive in the City of Temple Terrace. The project requires the replat of the land to be developed as affordable housing, and Hillsborough County, as mortgagee, is required to consent to the dedication of lands for replat. The County is not assuming any responsibility for utilities, drainage or other easements but rather consents to the dedication of the replat as stated. This approval will further the completion of documents needed to construct four (4) single affordable family homes under the Home Investment Partnership Program of the United States Department of Housing and Urban Development within the City of Temple Terrace. There is no fiscal impact associated with the Joinder and Consent.

# **Capital Programs**

A-4 Approve and execute Change Order No. One (1), to the construction contract with Ajax Paving Industries of Florida, LLC for General Roadway Resurfacing Services (CIP No. Various, Bid No. 19777,2 CPA No. 221202194). This Change Order is being processed to reinstate and ratify the contract retroactively to November 30, 2022, and to extend the contract time by 365 calendar days from November 30, 2022, to November 30, 2023. This Change Order will also increase the original contract amount by \$100,000 from \$14,891,232.03 to \$14,991,232.03 which will be used to replenish the remaining allowance for Non-Priced Items (NPI) to cover any additional unforeseen conditions or new work needed during the extended term. The Contractor, as part of the original award, committed to subcontracting a minimum of 8% to Certified Disadvantaged Minority/Disadvantaged Women Business Enterprise (DM/DWBE) firms, which remains in effect. To date, the contractor has subcontracted 4.67% to Certified DM/DWBE firms. At this time, the contractor's payments have been delayed due to the

- County's system upgrade. Once the contractor's invoice backlog has been paid, it is anticipated the goal will be met. Funding is available in the approved Capital Improvement Program (CIP) budget for various projects, and purchase orders will only be issued against approved budgets.
- A-5 Approve and authorize the County Administrator to issue two (2) separate Call(s) for Artists for Public Art to be located at the planned roundabouts at the intersection of Balm Riverview Road and Symmes Roads as well as the intersection of Memorial Highway and Montague Street. The roundabouts will be constructed by the County as part of the Capital Improvement Program. The two (2) art projects are funded by the FY 23 Public Art Program. The theme for the artwork at Balm Riverview/Symmes Road roundabout will be a statue of a stallion in tribute to Terrell Sessums and the roundabout at Memorial Highway and Montague Street will have an abstract sculpture. There is no significant cost to the County for the issuance of the Call(s) for Artists. Funding for the Artwork(s) is included in the Fiscal Year 23 Capital Improvement Program within the Public Art Program (CIP No. C70000000).
- A-6 Approve the FY 23 budget amendment resolution to appropriate \$1,200,000 from the School Board of Hillsborough County, Florida ("School Board") for the Collins Elementary School Circulation Improvements Project No. C69638021, in accordance with the fully executed Ground Lease Agreement between the School Board and Hillsborough County, which was approved by the Board of County Commissioners (BOCC) on April 20, 2022. The School Board plans to expand and construct a middle school at its existing Collins Elementary School site. The Ground Lease Agreement specifies that the County and School Board will equally share the cost of the design and construction of the required offsite roadway improvements within the right-of-way of Summerfield Boulevard and Panther Trace Boulevard. The \$1,200,000 represents the School Board's maximum contribution to the cost of the offsite improvements. This budget amendment resolution will add \$1,200,000 to the Pedestrian Safety and Mobility Enhancement Program Project No. C69638000.

# **Communications and Digital Media**

A-7 Approve and execute the Enterprise Master Services Agreement with Netlify, Inc., which materially modifies the County's Standard Purchase Order Terms and Conditions, to provide cloud-based website hosting infrastructure services for the Communications and Digital Media Services Department (CDM) at a 23% cost savings. The County Attorney's Office and Procurement Services Department reviewed and approved the changes in accordance with Section 6-101(5) of the Procurement Policy. The Netlify platform is a leap forward in web hosting technology that is not only more cost effective than the County's current solution, but also more powerful and robust, providing best in industry reliability and redundancy. In this case, there were no subcontracting opportunities for Certified Disadvantaged Minority/Disadvantaged Women Business Enterprise (DM/DWBE) or Registered Small Business Enterprise (SBE) firms as the subject goods or services will be provided directly and exclusively by the existing contractor under a cooperative procurement with Omnia Partners. No additional funds are required by executing the Netlify Enterprise Master Services Agreement as funds are available on the current blanket purchase agreement (222208303). The estimated annual cost for this service in the amount of \$81,282.98 will be purchased through an approved Omnia Partners Cooperative Contract (4400006644) via Insight Public Sector, Inc. Purchase orders will only be issued against approved budgets.

# **County Attorney's Office**

- A-8 Reject a Demand for Judgment in the amount of \$175,000.00 in the case of M.M., a minor by and through his mother, Jennifer Mankowski, as his mother and natural guardian vs. Hillsborough County, Fishhawk Community Development District II and Fishhawk Ranch Community Development District, Case No. 2021-CA-3351. There is no financial impact.
- A-9 Authorize the County Attorney's Office to reject a proposal for settlement in the amount of \$200,000 in the personal injury lawsuit entitled John Donnelly v. Hillsborough County, et.al., Circuit Civil Case # 22-CA-4573. There is no financial impact associated with this item.
- A-10 Authorize the County Attorney's Office to take all necessary legal action, including the initiation of litigation, in the matter of CareerSource Tampa Bay, CareerSource Pinellas, and Hillsborough County versus Chubb Insurance Corporation. CareerSource Tampa Bay and CareerSource Pinellas intend to jointly file suit against their mutual insurer, Chubb Corporation, which has denied coverage under their Director and Officer Liability Policy related to the US Department of Labor (USDOL) investigation. The County Attorney's Office recommends initiating suit against Chubb as an equitable subrogee in order to assist CSTB in obtaining insurance coverage for the loss, which would result in CSTB being able to reimburse the County for

funds the County previously paid to the Florida Department of Economic Opportunity (DEO). The matter will be handled in house and the only cost to the County will be filing fees.

# **Economic Development**

- A-11 Approve Hillsborough County Film & Digital Media Incentive Award Agreement between Hillsborough County and FX Productions, LLC. in the not to exceed amount of \$60,000 to assist in securing the local filming of "Triple 7" (the "Project"). The Film Commission recommends that an incentive be offered to secure its Florida film production in Hillsborough County based on the tourism marketing and promotional benefits of the Project. Accompanying the Agreement is a letter from the Film Tampa Bay Director certifying that the Project's impacts are consistent with program parameters and are sufficient to meet the minimal thresholds to qualify for the incentive. Funding for this Agreement is included in the Economic Development Department's FY 23 adopted budget within the Countywide Economic Development Activity Fund and will be provided from Major Films Incentive Fund, Small Productions Incentive Fund and Corporate Industry Promotion Fund.
- A-12 Approve an Agreement between Tampa Bay Workforce Alliance, Inc., d/b/a CareerSource Tampa Bay (CSTB), and the County for the Ex-Offender/Returning Citizen Workforce Training Program to develop a workforce training and job placement services program (Program) for the period of April 1, 2023, to September 30, 2024. The Program will introduce participants to the skills and traits necessary to improve their employability and raise their interest in and awareness of career opportunities within Hillsborough County, as well as engage employers in providing employment opportunities for ex-offenders/returning citizens. Funding for this Agreement, in the amount of \$150,000 per fiscal year, is included in the Countywide General Operating Fund Non-Profit Organizations FY 23 adopted and FY 24 planned budgets.
- A-13 (a) Approve the Agreement between Hillsborough County and Black Horse Studio Holdings LLC, a limited liability company existing under the laws of the State of Florida ("Grantee") in the amount of \$224,028 for improvements to the property located at 2001 N. Howard Avenue, Tampa, Florida, a contributing property to the West Tampa National Register Historic District. (b) Approve a Preservation and Restricted Use Agreement between Hillsborough County and Black Horse Studio Holdings LLC, requiring repayment of grant funds in the event that the improved property is sold without the County's consent within five (5) years. (c) Adopt a Resolution allocating Historic Preservation Challenge Grant (HPCG) funds to Black Horse Studio Holdings LLC, a Florida company. Funding for the Agreement in the total amount of \$224,028 was part of the 2022 round of funding for the Historic Preservation Matching Fund Project, which is included in the Adopted FY 23 FY 27 Capital Improvement Program. These funds are administered by the Economic Development Department.
- A-14 (a) Approve the Agreement between Hillsborough County and East Seventh Avenue LLC, a limited liability company existing under the laws of the State of Florida ("Grantee") in the amount of \$71,861 for improvements to the property located at 1514 E. 7th Avenue in Tampa, Florida, located within the boundaries of the Ybor City National Historic Landmark District. (b) Approve a Preservation and Restricted Use Agreement between Hillsborough County and Grantee, requiring repayment of grant funds in the event that the improved property is sold without the County's consent within five (5) years. Funding for the Agreement in the total amount of \$71,861 was part of the 2022 round of funding for the Historic Preservation Matching Fund Project, which is included in the Adopted FY 23 FY 27 Capital Improvement Program. These funds are administered by the Economic Development Department.

# **Engineering and Operations**

- A-15 Approve and execute the First Modification to the Agreements with Burgess & Niple, Inc.; Kimley-Horn and Associates, Inc.; Johnson, Mirmiran & Thompson, Inc.; and Alfred Benesch & Company (RPS No. 19840,1) for ongoing and as-needed professional traffic and road safety engineering services. These modifications will increase the agreements by \$650,000 from \$1,000,000 to \$1,650,000 for each consultant. The additional agreement capacity will allow the Engineering and Operations Department to provide support in administering traffic and road safety programs as detailed in the Background. The agreements include the requirement to subcontract a minimum of 10% of the ultimate fees to Certified Disadvantaged Minority/Disadvantaged Women Business Enterprises (DM/DWBE), and the consultants have committed to meet the DM/DWBE participation goal for the original agreements and these modifications. There are sufficient funds for various projects in the approved Capital Improvement Program budget and in the Engineering and Operations Department's FY 23 operating budget to accommodate these increases. Purchase orders will only be issued against approved budgets.
- A-16 Approve two Federally-Funded Subaward and Grant Agreements with the State of Florida, Division of Emergency Management (FDEM), for two grants awarded by the Federal Emergency Management Agency (FEMA) under the FY 2020

Flood Mitigation Assistance (FMA) Grant Program. The first Federally-Funded Subaward and Grant Agreement# B0165, Project# FMA20-007, for \$177,200.00, will fund a residential mitigation reconstruction project in Ruskin. The second Federally-Funded Subaward and Grant Agreement# B0161, Project# FMA20-013 for \$298,886.60 will fund a residential acquisition project near Plant City. Both properties are on FEMA's severe repetitive loss list and are located in unincorporated Hillsborough County. The period of performance begins upon execution by both parties and ends on July 21, 2025. Budget amendments will be submitted to appropriate funds upon receipt of the fully executed agreements from the FDEM.

A-17 Approve the FY 23 Cooperative Funding Agreement No. 23CF0003976 ("Agreement") with the Southwest Florida Water Management District ("SWFWMD") for Hillsborough County Digital Flood Insurance Rate Map (DFIRM) Updates. The project consists of updating the effective FEMA DFIRMs using the recently completed County Watershed Management Master Plans (WMMPs) and associated stormwater models. Pursuant to the Agreement, the County would receive \$375,000 from SWFWMD and the County would provide \$375,000 in matching funds, for a total of \$750,000, for the period of October 1, 2022, through October 31, 2026. Following SWFWMD approval of this Agreement, a budget amendment resolution will be forthcoming to accept and appropriate \$375,000 from SWFWMD and realign \$375,000 for the County share, for a total of \$750,000 to the Hillsborough County DFIRM Updates grant. This will increase the Watershed Master Plan Updates Project No. C46140000 by \$375,000, and purchase orders will only be issued against approved budgets.

#### Facilities Management and Real Estate Services

- A-18 Adopt six (6) Resolutions of Eminent Domain for the US 92 and Gallagher Road Intersection Improvement Project. The resolutions: (a) Determine a reasonable necessity to acquire three (3) fee simple road rights of way and four (4) temporary construction easements for the public purpose of constructing road and intersection improvements for the US 92 and Gallagher Road Intersection Improvement Project, CIP No. 69679042, Project No. 2020-132-R, in Hillsborough County, Florida. (b) Authorize and direct the Hillsborough County Attorney's Office and Facilities Management & Real Estate Services Department staff to conduct good faith pre-suit negotiations and the acquisition of such properties and associated property rights by eminent domain proceedings, if necessary, for the project. (c) Authorize and direct the Hillsborough County Attorney's Office and Facilities Management & Real Estate Services Department staff to acquire such property and associated property rights in the name of Hillsborough County, without further approval from this Board, provided that the amounts expended to acquire such property and associated property rights can be adequately accommodated within the project's current budget, and to fully compensate the interested parties as required by law. The overall project will provide traffic safety improvements such as a new left turn lane, new sidewalks, pedestrian crossing signals with crosswalk, and traffic signal replacements. Acquisition of Parcels 101, 105/705, 106, 702, 703, and 704 can be adequately accommodated within the Intersection Capital Improvement Program, Project No. C69679000.
- A-19 Approve a Site Access Agreement allowing access to County-owned property by the Florida Department of Environmental Protection ("FDEP") and its contractor to perform environmental site assessment activities. On May 6, 2020, the County approved purchase of the Property located at 902 E. Kennedy Boulevard, Tampa ("Property") as part of the Courthouse Land Acquisition Capital Improvement Project. The property was formerly owned by Bridgestone Retail Operations, LLC ("Tenant") and operated by Firestone automotive service. After the purchase, the County leased the Property back to the Tenant until April 2, 2023. The FDEP assessment will evaluate and determine contamination levels and when necessary, remove and remediate contamination from the property. There is no financial impact associated with this item. The site agreement is under the Petroleum Restoration program and is limited to activities with no cost to the County.
- A-20 Approve a Site Access Agreement ("Agreement") allowing access to County-owned property by the Florida Department of Environmental Protection ("FDEP") to perform environmental site assessment and remediation activities on approximately 35,554 square feet at Amalie Arena located near Channelside Drive and Water Street ("Site). The Agreement will resume and complete remediation that was paused in 2018 due to utility work on the Site in support of the Water Street Tampa redevelopment project. The Agreement specifies that assessment activities will be scheduled with the County and their Partners in order to eliminate and minimize interfering with Arena activities and events. Both the Tampa Sports Authority and Tampa Bay Arena LLC are in support and have signed the Agreement. The Site is under the Petroleum Restoration program and is limited to activities with no cost to the County.

#### **Fire Rescue**

- A-21 Approve and execute the first modification to a contract with PCN Strategies Inc., for the purchase of equipment, software, server hardware, appliances, accessories, warranties and related professional support services for the Hillsborough County Fire Rescue Department (HCFR). This modification will extend the BPA (218206198) by one (1) year. Additional funding is not required due to the agreement containing sufficient funds through the revised expiration date. In the original award (2018), given the specialized nature of the services no participation goal or set-aside was established for this procurement. Regarding this modification, there are no reasonable subcontracting opportunities for DM/DWBE/SBE firms as the specified products will continue to be provided directly and exclusively by the existing contractor. Funding for this procurement is available in the requesting department's budget, and purchase orders will only be issued against approved budgets.
- A-22 Approve the Interlocal Agreement with the Florida State Fair Authority for Fire Rescue to provide Advanced Life Support (ALS) medical standby coverage during the 2023 Florida State Fair. Fair Authority funds shall be paid to the County in the amount of \$90,000.00 for ALS medical standby coverage with staffing as indicated in the deployment schedule at the 2023 Florida State Fair.
- A-23 Approve Agreement Modification #1 for Federally Funded Subaward Grant Agreement with the State of Florida, Division of Emergency Management Performance Grant American Rescue Plan ACT (ARPA) Agreement # G0363, CFDA 97.042 to extend the Grant Agreement end date from 12/31/22 to 03/30/23 to enable full utilization of the funds. There will be no financial impact with this contract amendment.

# **Health Care Services**

The total amount of this agreement includes unspent funding from the previous year's Justice Assistance Grant award in the amount of \$7,000.00. Funding for this agreement is included in the Management and Budget's FY 23 adopted budget.
- A-38 Approve, by a supermajority vote, pursuant to Board Policy 03.02.04.00, a FY 23 budget amendment resolution to transfer \$4.2 million from the Catastrophic Disaster Recovery Fund reserves and appropriate it within the BOCC FEMA Hurricane Ian Disaster Events Fund (10796). All recommended vendors are registered SBE and certified DM/DWBE firms. Funding for this procurement is available in the requesting department's approved budget and purchase orders will only be issued against approved budgets.

Specifically, awards are recommended to: George G.
