2023-99 Fiscal Year 2022 City Investment Performance Report (B) **Department:** Financial Services

Description: Fiscal Year 2022 Investment Performance Summary Report and detailed backup reporting for the City's Operating Fund, General Employees' Pension Plan, Police Officers' and Firefighters' Pension Plan, Retiree Health Insurance Trust Fund, and Evergreen Cemetery Trust Fund.

Fiscal Note: City Operating Fund – The Fund's FY22 year-end balance was \$232,073,638. The FY22 annualized investment return was on the City's SBA Prime Fund Account was 0.84%, and FY22 accrued interest earned on the City's Bond Portfolio was 0.43%. The Bond Portfolio's annualized return at 9/30/22 was 4.23%. Total FY22 City Operating Fund interest earned and accrued was \$1,811,859. The City Bond Portfolio's unrealized mark to market value loss at 9/30/2022 was - \$1,408,172. City Operating Fund interest is allocated to all applicable City Funds that maintain cash balances during the fiscal year.

General Employees' Pension Plan – The Plan's FY22 year-end balance was \$516,847,066. The Plan's FY22 investment rate of return was - 20.79%, and the investment loss was -\$144,081,021. General

Employees' Pension Plan investment returns only impact the Plan, but they have an indirect effect on the City's required employer pension contribution rate which is determined through actuarial valuations performed annually by the Plan's actuary.

Police Officers' & Firefighters' Pension Plan – The Plan's FY22 year-end balance was \$245,371,697. The Plan's FY22 investment rate of return was -16.30%, and the investment loss was -\$53,724,928. Police Officers' & Firefighters' Pension Fund investment returns only impact the Plan, but they have an indirect effect on the City's required employer pension contribution rate which is determined through actuarial valuations performed annually by the Plan's actuary.

Retiree Health Insurance Trust Fund – The Fund's FY22 year-end balance was \$56,450,903. The Fund's FY22 investment rate of return was -17.93%, and the investment loss was -\$12,299,951. Retiree Health Insurance Trust Fund investment returns only impact the Fund, but they have an indirect effect on the City's required Fund contribution rate which is determined through actuarial valuations performed regularly by the Fund's actuary.

Evergreen Cemetery Trust Fund – The Fund's FY22 year-end balance was \$1,174,048. The Fund's FY22 investment rate of return was - 26.44%, and the investment loss was -\$475,955. Evergreen Cemetery Trust Fund investment returns only impact the Trust Fund.

Expected investment returns for the City's Operating Fund, General Employees' Pension Plan, Police Officers' and Firefighters' Pension Plan, Retiree Health Insurance Trust Fund, and Evergreen Cemetery Trust Fund are included in the City's annual budgets.

Recommendation: The City Commission review and accept the submitted FY2022 City Investment Performance Summary Report as recommended by the Finance Committee.

2022-762 Open Container Discussion and Direction (B) Department: Sustainable Development
