LEGISLATIVE ITEMS

30. <u>23-0745 - Pdf</u> Land Development Code Chapter 5 Text Amendments to Public Roadway Connections – First reading of an ordinance to change the Walton County Land Development Code. The proposed change amends Chapter Five, Section 5.04.04 (Access Management). The amending language clarifies criteria associated with vehicle access and circulation for new roads and driveways proposed to connect to a countymaintained roadway. The proposed ordinance provides guidance on driveway connection permits, traffic analysis, and operational improvements. It also allows staff discretion to elevate the permit authorization approval to the Board of County Commissioners **31**. 23-0746 - Pdf Land Development Code Chapter 5 Text Amendments. First reading of an ordinance to change the Walton County Land Development Code. The proposed changes amend Chapter Five, including but not limited to Section 5.00.07 (Development in Flood Zones), Section 5.04.00 (Transportation Systems), Section 5.06.00 (Stormwater Management), and Section 5.07.10 (Tall Structures). The amending language relates to the classification of roads and installing a requirement for when roads must be dedicated to the public, among other traffic-related changes. Staff is also recommending additional clarifying changes consistent with efforts to maintain and improve the interpretation and implementation of the Land Development Code and enhance flood and stormwater standards. The proposed ordinance amends the standards of review and requirements for single-family residential stormwater plans. Changes to the single-family stormwater level of service standards based on impervious surface ratios (ISRs), the inclusion of maximum impervious surface ratio, floodplain management clarification, and other substantive changes are proposed. These changes will impact many current standards and components of the Code, including but not limited to development in flood zones, transportation classification, stormwater management, and review requirements for tall towers
