1. Nature and purpose of agenda item:

This is a Public Hearing to adopt Resolution 2023R-66 that establishes water and sewer rates.

On 9/21/2023, the Board authorized staff to send out notices with the October utility bills outlining proposed adjustments to the water and sewer rates. Notices were sent to the Fort White water customers about the rate increase approved by the Town of Fort White. Notices were sent to the Ellisville customers proposing new sewer rates and setting a Public Hearing for November 16,2023. The Resolution sets new sewer rates for Ellisville and restates all other utility charges.

COLUMBIA COUNTY, FLORIDA RESOLUTION NO. 2023R-66

A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF COLUMBIA COUNTY, FLORIDA, ESTABLISHING WATER AND SEWER MONTHLY SERVICE CHARGES, RESTATING OTHER UTILITY CHARGES AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the County provides water and wastewater services in the unincorporated area of the County known as the Designated Service Area per Ordinance 2010-01 and provides water service to customers in the Mason City area;

WHEREAS, the Board of County Commissioners authorized a rate study that was conducted by the Florida Rural Water Association and the board has reviewed that rate study;

WHEREAS, the Board of County Commissioners previously established utility rates on August 19, 2010 in Ordinance 2010-11, codified at section 118-550 et seq of the Columbia County Code of Ordinances, and which rates are subject to change by adoption of a Resolution in accordance with code section 118-552(b);

WHEREAS, by this Resolution the Board desires to adjust rates as provided in the rate study and, for the sake of clarity, restate all utility charges in order to maintain a single rate sheet for all constituents receiving utility services from the County; and

WHEREAS, utility customers were notified on the first week of October 2023, by mail, of the proposed fee and rate changes.

NOW, THEREFORE, BE IT RESOLVED by the Board of County Commissioners of Columbia County, Florida that the Board hereby restates and amends the water and sewer rate schedule for the County's utility services as follows.

SECTION 1: WATER AND SEWER CHARGES AMENDED AND RESTATED

The Water and Sewer Charges set forth in Chapter 118, Article IV, Division 5 are restated and amended as follows (stricken items are deleted; underlined terms are inserted):

(c) All water and sewer Customers will pay monthly usage charges with respect to each gallon of water used. The base facility charges and monthly usage charges shall be as set forth below until amended by resolution of the Board of County Commissioners as follows:
