On February 9, 1960, students from DeLand's all-Black Euclid High School staged a sit-in at the lunch counter in the Woolworth's store which occupied this building. One of the leaders was Joyce Cummings Cusak, who went on to become the first Black person to be elected to the Florida legislature from Volusia County. Although lunch counter sit-ins had begun in other Southern cities, DeLand's was only the second in Florida. The students also sat in at McCrory's located across the street. They continued their protest for a week, causing the lunch counters to shut down. During their action, the students were protected by the City of DeLand Police. Eventually, Woolworth's and McCrory's reopened their lunch counters, serving customers regardless of color.

## PETITIONS AND REQUESTS FROM THE PUBLIC PRESENT

OLD BUSINESS

1. Second Reading of Ordinance No. 2023-23, Amending the Zoning of Approximately 38.5 Acres of Property, Located at 801 Sol Y Sombra for the Manchester Neighborhood Planned Development. First Reading on 10-16-2023.

The City Commission is requested to approve the amendment to the Manchester PD, for the development of 37 multi-family units and permitting 4 single-family units.

2. <u>Second Reading of Ordinance No. 2023-24</u>, Amending the Zoning of Approximately 14.57 Acres of Property, Located at the Intersection of Clear Lake Road and North Spring Garden Avenue, the Pointe Grand Apartments Planned Development. First Reading 10-16-2023.

The applicant is proposing an amendment to the Pointe Grand Apartments PD for the purpose of reducing the number of guest parking spaces to convert into approximately 27 covered parking stalls.

3. Second Reading of Ordinance No. 2023-25, Abandoning a 50-Foot Wide by 255-Foot Long Portion of the Pine Avenue Right-of-Way Running along the Western Boundary of 1632 Parade Circle, and along the Eastern Boundary of 1615 and 1607 North Woodland Boulevard. First Reading 10-16-2023.

The City Commission is requested to approve the abandonment of a 50-foot wide by 255 linear feet of the Pine Ave right-of-way running along the western boundary of 1632 Parade Circle, and along the eastern boundary of 1615 and 1607 N. Woodland Boulevard and reserving a utility easement over the southerly fifteen feet (15') of the abandoned right-of-way.

4. <u>Second Reading of Ordinance No. 2023-26, Granting a Petition to Create the Cresswind DeLand</u> Community Development District. First Reading 11-6-2023.

This is a companion resolution to Ordinance 2023-1486 which established the Cresswind DeLand Community Development District. The adopted ordinance provides that the CDD will have to enter into an interlocal agreement with the City. The ordinance provides a 60-day time limit from adoption of this Ordinance for execution of the interlocal agreement. This interlocal agreement provides for a host of specific requirements for the CDD which are consistent with the types of enhanced amenities and infrastructure maintenance responsibilities set forth in the City's CDD policy resolution.

6. Second Reading of Ordinance No. 2023-27, Granting a Petition to Create the Kepler Road Community Development District. First Reading 11-06-2023.

This is a companion resolution to Ordinance 2023-1485 which established the Kepler Road Community Development District. The adopted ordinance provides that the CDD will have to enter into an interlocal agreement with the City. The ordinance provides a 60-day time limit from

adoption of this Ordinance for execution of the interlocal agreement. This interlocal agreement provides for a host of specific requirements for the CDD which are consistent with the types of enhanced amenities and infrastructure maintenance responsibilities set forth in the City's CDD policy resolution.

## **NEW BUSINESS**

1. First Reading of an Ordinance Amending Land Development Regulations to Add Doggie Daycare as an Allowed Use where Veterinary Clinics are Allowed and Adding Veterinary Clinics and Doggie Daycare Facilities with no Outside Runs or Kennels as a Conditional Use in C-2A.

The City's current Land Development Regulations do not include Doggie Daycare as an allowed use in any of the City's zone districts. Over the past few years there have been several inquiries regarding doggie daycare facilities. Staff has evaluated the anticipated impact of a doggie daycare facility with no outdoor runs or kennels and determined that "Veterinary Clinics allowing inside overnight boarding, no outside runs or kennels" is a similar use with similar impacts. Section 33-12 will be updated to add a definition for doggie daycare, and clarify the parking requirements in Section 33-91.03 for veterinary clinics to include doggie daycare. The parking requirements for veterinary clinics have also been revised to add doggie daycare uses. The proposed draft also adds Veterinary Clinics and Doggie Daycare facilities with no outside runs or kennels as a conditional use in C-2A.

2. First Reading of Ordinance, Changing the Zoning Amending the DeLand Toyota PD, for +-10.43 Acres of Property, Located at 1701 South Woodland Boulevard, to Amend and Restate DeLand Toyota Planned Development, for the Purposes of Creating One Overall Development Plan with the Addition of a Proposed 8,000 Square Foot Building.

This is a request to approve the Amended and Restated DeLand Toyota PD Agreement on first reading.

3. Resolution Approving a Class IV Site Plan, Hillpointe/Pointe Grand Apartments, Located Southeast of the Intersection of Clear Lake Road and North Spring Garden Avenue.

The City Commission is requested to approve the Class IV site plan for the Pointe Grand Apartments.

4. <u>Resolution Approving Final Plat, Lakewood Park Phase 3 Located at Dr. Martin Luther King, Jr.</u> Beltway and County Road 4139.

The applicant, Richard Brown, Johnston's Surveying, Inc, is requesting approval of a Final Plat for Phases 3a and 3b of the Lakewood Park residential subdivision to subdivide a 79.74-acre parcel into 123 single-family residential lots, stormwater, open space tracts, tree protection areas.

5. <u>Consideration re Utility Service Agreement for DeLand Commons.</u>
