10:00 A.M. D-1 Conduct a public hearing and consider enacting an ordinance generally providing for the renewal of the levy of, and referendum on, the Half-Cent Local Government Infrastructure Surtax known locally as the Community Investment Tax (CIT). The subject ordinance generally provides for the following: the renewal of the CIT commencing December 1, 2026, and continuing through December 31, 2041; a requirement that CIT funds are to be distributed by interlocal agreement among the County, the Cities and the School Board (the "Interlocal Agreement"), which provides that five percent (5%) of the CIT funds are to be distributed to the School Board and the balance to the County and the Cities using the statutory State Shared Half-Cent Sales Tax distribution formula; CIT funds may be used for infrastructure for transportation and public works, public safety, public facilities, public utilities and public schools; CIT funds may be pledged to repay bonds; amendments to the Hillsborough County Code to address the foregoing; November 5, 2024, as the date of the referendum for the renewal of the CIT; the ballot language for the referendum; and a requirement that for the referendum to be placed on the ballot, prior to August 1, 2024, the Interlocal Agreement must be entered into, and the County, the Cities and the School Board must each adopt by resolution after a public hearing a list of projects to be funded for the CIT renewal period. If the subject ordinance is enacted and the associated referendum is approved by a majority vote of the electorate of Hillsborough County, an estimated \$167,000,000 in new revenue in FY 27 would be available for distribution to, and use by, the County, the Cities and the School Board as provided for in the ordinance. The estimated new revenue in FY 28 is estimated at \$206,000,000.

County Administrator's Organization

Affordable Housing Services

- A-1 (a) Adopt by resolution an amendment to the Local Housing Assistance Plan (LHAP) for Fiscal Years 2022 2025 to remove one local housing incentive strategy and execute the resolution and certification as required by the State Housing Initiatives Partnership Program (SHIP). The LHAP must comply with regulatory requirements outlined in Florida Statute sec. 420.9075 and Chapter 67-37.005 of the Florida Administrative Code. The LHAP establishes general housing and incentive strategies for Hillsborough County's annual allocations of SHIP funds. This amendment removes "Modification of Impact (Mobility) Fee Requirements" as a local housing incentive strategy to align the LHAP with the adopted Consolidated Impact Assessment Program Ordinance and Board policy and comply with regulatory requirements. (b) Authorize Affordable Housing Services to submit the Second Amendment to the LHAP to the Florida Housing Finance Corporation. There is no fiscal impact.
- A-2 Approve and execute the First Modification to the Agreement and accompanying amended Mortgage, Promissory Note and Land Use Restriction Agreement (LURA) between Hillsborough County and Bel Mar Partners, LLLP, a Florida limited liability limited partnership, to extend both the expenditure and expiration dates by six (6) months to allow time for the completion of a 100-unit multi-family affordable housing rental development known as Casa Bel Mar Apartments. Bel Mar Partners, LLLP was the successful proposer of RFP 23281. Under the First Modification, the expenditure date will be extended from April 30, 2024 to October 31, 2024, and the expiration date will be extended from July 31, 2024 to January 31, 2025. The LURA will likewise be amended to maintain the 30 year affordability period. This project is almost complete and requires additional time due to delays related to weather and TECO coordination of utility lines. There is no fiscal impact related to this agenda item.
- A-3 Approve and execute the Second Modification to the Agreement between Hillsborough County ("County") and East Tampa Business and Community Development Alliance, Inc. ("ETBCDA"), a Florida not-for-profit corporation, to extend the expenditure and expiration dates by one year each to allow time for completion of two (2) remaining rehabilitation projects and the two (2) demolition and reconstruction projects that are currently about 50% complete. ETBCDA was the successful proposer of RFP 19848 to provide rehabilitation assistance to income eligible homeowners. At the completion of this single family, owner-occupied rehabilitation project two (2) homes will be demolished/rebuilt, and thirteen (13) homes will be rehabilitated and preserved to current standards. These rehabilitation projects benefit low-income households located in areas of unincorporated Hillsborough County and in the municipalities of Plant City or Temple Terrace. Labor and supply shortages have led to the delay of completion of the remaining homes. The expenditure date will be extended from April 30, 2024, to April 30, 2025, and the expiration date from July 31, 2024, to July 31, 2025. Owner-occupied rehabilitation is a strategy as recognized in the County's Local Housing Assistance Plan (LHAP) to assist with preservation of single family homes. There is no fiscal impact for this Second Modification.
- <u>A-4</u> Approve and execute the First Modification to the Dual Source Funding Agreement ("Agreement") and accompanying modifications to the Mortgages, Notes and Land Use Restriction Agreement (LURA) between Hillsborough County ("County") and Fulham Terrace, Ltd., ("Fulham") to extend the expenditure date of the Agreement by eight (8) months, from April 30, 2024 to December 31, 2024, and the expiration date by eight (8) months, from July 31, 2024, to March 31, 2025, in order to facilitate the completion of the 116-unit, multi-family affordable housing development ("Project") for low-income persons. Fulham was the successful proposer of RFP 19849.1. The Project, known as Fulham Terrace, is located at 10461 Towncenter River Lane, Riverview, FL 33578 and delays due to supply chain and labor shortages created the need to modify the Agreement and accompanying documents. Fulham will complete the multi-family development with the requested time extension. There is no fiscal impact associated with approval of this agenda item.
- A-5 Approve and execute the Second Modification ("Second Modification") to the State Housing Initiatives Partnership (SHIP) and Local Affordable Housing (HOPE) Program Funding Agreement between Hillsborough County ("County") and The Centre for Women, Inc. ("CFW"), a Florida not for profit corporation, to extend the expenditure date from April 30, 2024 to September 30, 2024; and to extend the expiration date from July 31, 2024 to December 31, 2024, to allow for the rehabilitation of an additional three (3) homes as part of the single-family, owner-occupied housing rehabilitation program benefiting low-income households located in areas of unincorporated Hillsborough County and in the municipalities of Plant City or Temple Terrace. CFW was the successful proposer of RFP 19848 to provide rehabilitation assistance to income eligible homeowners. CFW has met their obligation under this agreement and with remaining funds will expand the program to three (3) additional

families. No additional funds are required for the expanded services. This project is consistent with strategies in the adopted Local Housing Assistance Plan (LHAP) to preserve affordable housing by providing rehabilitation services to existing homeowners. There is no fiscal impact for this Second Modification.

- A-6 Approve and execute a Community Development Block Grant-CARES Act ("CDBG-CV") Public Facilities grant funding agreement and accompanying form of Mortgage, Promissory Note and Land Use Restriction Agreement ("LURA") between Hillsborough County ("County"), Friends of Joshua House Foundation, Inc. and FOJH Properties, LLC (together, "FOJH"), a successful proposer under RFP 24148,1, in an amount not to exceed \$307,825 to assist the agency with the preparation for, prevention of, or spread of future pandemic disease. The CDBG-CV Public Facility funding is made available by the U.S. Department of Housing and Urban Development through the Coronavirus Aid, Relief and Economic Security Act (CARES Act) approved in the PY 23-24 Annual Action Plan and Substantial Amendments. FOJH will receive \$307,825 for eligible CDBG-CV upgrades to the foster residential group home property located at 1515 Michelin Court, Lutz, 33549. FOJH will record a mortgage, note and LURA with a 20-year term to secure the County's investment. The Agreement will be funded with \$307,825 from the CDBG-CV FY 24 grant budget.
- A-7 Approve and execute the Community Development Block Grant-CARES Act ("CDBG-CV") Public Facilities grant funding agreement and accompanying form of Mortgage, Promissory Note and Land Use Restriction Agreement ("LURA") between Hillsborough County ("County") and University Area Community Development Corporation, Inc. ("UACDC"), a successful proposer under RFP 24148,1, in an amount not to exceed \$300,377 to assist the agency with the preparation, prevention of or spread of future pandemic disease. The CDBG-CV Public Facility funding is made available by the U.S. Department of Housing and Urban Development through the Coronavirus Aid, Relief and Economic Security Act (CARES Act) approved in the PY 23-24 Annual Action Plan and Substantial Amendments. UACDC will receive \$300,377 for eligible CDBG-CV upgrades to the property located at 13704 N. 20th St, Tampa, 33613. UACDC will record a mortgage, note and LURA with a 20-year term to secure the County's funding. The Agreement will be funded with \$300,377 from the CDBG-CV FY 24 grant budget.
- A-8 Approve and execute the Dual Source Funding Agreement between Hillsborough County and The Children's Home, Inc. and accompanying Mortgage, Note and Land Use Restriction Agreement ("LURA") to fund a public facility improvement with Community Development Block Grant ("CDBG") Program funds and CDBG-CV program funds through the CARES Act of the United States Department of Housing and Urban Development in an amount not to exceed \$688,113. The Children's Home, Inc. was a successful proposer to RFP 24148. The funds will be utilized for interior and exterior rehabilitation to the residential foster care facility located at 10909 Memorial Highway, Tampa, FL 33615 to improve the quality of life of the residents, including improvements that are in part designed to prevent, prepare for, and respond to the spread of coronavirus. This project meets the County's Annual Action Plan and Consolidated Plan goals to provide safe, decent affordable housing in Hillsborough County. The Mortgage, Note and LURA will secure the County's investment in this public facility for the next 20 years. This Dual Source Funding Agreement will be funded with \$303,353 from the CDBG FY 24 grant fund and \$384,760 from the CDBG-CV FY 24 grant fund budgets.

<u>A-9</u> Approve the release of the demolition lien assessed by Resolution # R05-110, Case No.: C05-0031, in the amount of \$5,673.74 against the property located at 3602 W. Hamilton Ave., Tampa, FL 33614 formerly 7024 N. Himes Ave., Tampa, FL 33614, Folio # 027009.0000, for the costs incurred by the County for the demolition and removal of a deteriorated structure and removal of trash, junk, and debris. This lien has been satisfied, and a release of lien is being requested.

County Attorney's Office

A-10 Reject a Proposal for Settlement for \$200,000.00 in the case of Shawn Daniels v. Hillsborough County, Case No. 23-CA-913.

Engineering and Operations

A-11 Approve and execute the First Modification to the existing contract with NDL LLC for ongoing and as-needed rights-of-way and ponds landscape maintenance services (20036), for the Engineering & Operations Department. This First Modification will extend the contract by three (3) months, from April 30, 2024, to July 31, 2024, and increase the contract by \$1,000,000.00, from \$6,583,377.34 to \$7,583,377.34. The Engineering & Operations Department is requesting this time extension and contract amount increase due to reaching the capacity of the existing contract, and to allow the current contractor to continue

services until the new competitive bid solicitation (ITB-24-24780) can be completed, and possibly transitioned to a new vendor. The contract provides services aimed at maintaining roadways in a manner that ensures both aesthetic appeal and safety. As part of the original award, the contractor committed to subcontracting a minimum of 7% to Certified Disadvantaged Minority/Disadvantaged Women Business Enterprise (DM/DWBE) firms, which remains in-effect, however, the contractor has achieved 57.4% participation. Funding for this modification is included in Engineering and Operations' FY 24 adopted budget, and purchase orders will only be issued against approved budgets.

- A-12 Approve FY 24 budget amendment resolution to reduce \$252,000 in SWFWMD funding and realign \$252,000 from the Stormwater Management Project Fund into the grant fund within the Neighborhood Drainage Capital Improvements Project No. C46145000 for the County's proportionate share in accordance with the executed First Amendment to the Hillsborough County SCADA System (Q213) Agreement No. 21CF0003393, BOCC Doc. No 23-0856. The initial agreement, and SWFWMD funding amount, was based on a scope that included an initial estimate of 250 real-time water-level monitoring stations. The scope has since been optimized to provide a representative quantification of water levels throughout the County with 180 monitoring stations, which is a 28% reduction, and the amendment reduced the SWFWMD funding amount and increased the County's funding amount proportionally, by \$252,000. This FY 24 budget amendment resolution will reduce the Neighborhood Drainage Capital Improvements Project No. C46145000 by \$252,000, from \$37,564,143 to \$37,312,143.
- A-13 Approve and execute Change Order No. One (1), to the contract with Proshot Concrete, Inc., for the Bridge Repair and Rehabilitation Services Contract, (CIP No. Various, Bid No. 20423,1 CPA No. 221210184). This Change Order will (a) extend the Contract Time by 183 calendar days, from May 31, 2024, to November 30, 2024, and (b) increase the Contract Price by \$1,000,000.00 to complete additional bridge repair projects included in the FY 24 work plan. The Contractor, as part of the original award, committed to subcontracting a minimum of 4.0% to Certified Disadvantaged Minority/Disadvantaged Women Business Enterprise (DM/DWBE) firms, which remains in effect. To date, the contractor has subcontracted 4.51% to Certified DM/DWBE firms. This Change Order will increase the contract by \$1,000,000.00, from \$11,999,132.50 to \$12,999,132.50. Funding is available in various projects within the approved Capital Improvement Program budget, and purchase orders will only be issued against approved budgets.
- A-14 Approve and execute the Second Modification to the existing contract with Cardinal Landscaping Services of Tampa, Inc., for the right-of-way mowing services for the West Service Area, (ITB 22086,2). The purpose of this modification is to increase the contract capacity by \$100,000.00, from \$875,121.60 to \$975,121.60, to ensure services are performed and associated payments are made through the end of the contract period of April 30, 2024. The contract is used for ongoing and as-needed mowing and removal of litter from roadway rights-of-way and designated ponds throughout the County. The contractor, as part of the original award, is committed to subcontracting a minimum of 8% to Certified Disadvantaged Minority/Disadvantaged Women Business Enterprise (DM/DWBE) firms, which remains in effect. To date, Cardinal Landscaping Services of Tampa, Inc., has achieved 8.3% participation and is also a registered Hillsborough County Small Business Enterprise. Funding is included in the Transportation Trust Fund within Engineering and Operations Department's FY 24 adopted budget.

Environmental Services

<u>A-15</u> Approve an agreement with LowCarbon America Corporation for a demonstration pilot for carbon capture. The Board directed staff to review a proposal from LowCarbon America Corporation for the installation, operation, and testing of a unit process at the County's Falkenburg Waste to Energy Facility. This Pilot Project is being installed to determine the feasibility and capabilities of a permanent carbon capture and sequestration technology. If proven successful, a full-scale carbon capture project could provide economic and environmental benefits for the citizens of Hillsborough County. There is no financial impact to Hillsborough County from this Agreement.

Facilities Management and Real Estate Services

A-16 Approve a License Agreement ("License") between Hillsborough County ("County") and Tampa Electric Company ("TECO") for approximately 962 square feet (0.022 acres) on Folio 109054-5000, with the address of 3803 W. Martin Luther King Drive, Tampa commonly known as the New York Yankees George M. Steinbrenner Field. The license provides TECO a ninety-one (91) foot long path with the necessary real estate rights to install, construct, operate, repair, replace, and maintain aboveground and underground lines, wires, cables, data transmission and communication facilities to provide electrical services to a new Information Technology Center ("ITC") building to be built and leased by the New York Yankees Partnership ("NYY") on the adjacent Hillsborough Community College ("HCC") property. The cost associated with this agenda item is limited to

recording fees of less than \$100, which can be adequately accommodated within the approved Facilities Management and Real Estate Services Department budget.

- <u>A-17</u> Approve an Easement Agreement ("Easement") with Tampa Electric Company ("TECO") for approximately 10,787 square feet (0.248 acres) for the purpose of providing TECO the necessary real estate rights to install, construct, operate, repair, replace, and maintain aboveground and underground lines, wires, cables, data transmission and communication facilities to provide electrical services to the Traffic Operations Center located at 2310 Regional Water Lane (Folio No. 065474-0000). No compensation is required for service to a County facility pursuant to Section V of the Guidelines for Real Property Transactions between Hillsborough County and Tampa Electric Company, dated July 8, 2004. The cost associated with this agenda item is limited to recording fees of less than \$100, which can be adequately accommodated within the approved Facilities Management and Real Estate Services Department budget.
- A-18 Approve an Easement Agreement ("Easement") with Tampa Electric Company ("TECO") for approximately 5,896 square feet (0.14 acres) for the purpose of providing TECO the necessary real estate rights to install electrical service, construct, operate, repair, replace, and maintain aboveground and underground lines, wires, cables, data transmission and communication facilities to provide electrical services to the New Tampa Performing Arts Center ("Site") located at 8550 Hunters Village Road (Folio Nos. 033581-2574, 033581-2578, and 033581-2580). No compensation is required for service to a County facility pursuant to Section V of the Guidelines for Real Property Transactions between Hillsborough County and Tampa Electric Company, dated July 8, 2004. The cost associated with this agenda item is limited to recording fees of less than \$100, which can be adequately accommodated within the approved Facilities Management and Real Estate Services Department budget.
- <u>A-19</u> Approve an Easement Agreement ("Easement") with Tampa Electric Company ("TECO") for approximately 301 square feet (0.007 acres) for the purpose of providing TECO the necessary real estate rights to install electrical service, construct, operate, repair, replace, and maintain aboveground and underground lines, wires, cables, data transmission and communication facilities to serve the Church Park Head Start facility located at 5657 Webb Road (Folio No. 006748-0000). No compensation is required for service to a County facility pursuant to Section V of the Guidelines for Real Property Transactions between Hillsborough County and Tampa Electric Company, dated July 8, 2004. The cost associated with this agenda item is limited to recording fees of less than \$100, which can be adequately accommodated within the approved Facilities Management and Real Estate Services Department budget.
- <u>A-20</u> Approve an Easement Agreement ("Easement") with Tampa Electric Company ("TECO") for approximately 1,957 square feet (0.045 acres) for the purpose of providing TECO the necessary real estate rights to install, construct, operate, repair, replace, and maintain aboveground and underground lines, wires, cables, data transmission and communication facilities to provide electrical services to the Rhodine Fire Station No. 46 located at 10775 Rhodine Road (Folio No. 077441-0000). No compensation is required pursuant to Section V of the Guidelines for Real Property Transactions between Hillsborough County and Tampa Electric Company, dated July 8, 2004. The cost associated with this agenda item is limited to recording fees of less than \$100, which can be adequately accommodated within the approved Facilities Management and Real Estate Services Department budget.
- <u>A-21</u> Approve and execute a First Modification ("Agreement") with Electrical Engineering Enterprises, Inc., for continued ongoing and as-needed switchgear/transfer switches and electrical power system testing and maintenance services at various facilities throughout the County for the Facilities Management & Real Estate Services Department. The modification will extend the Agreement by seven (7) months, from May 1, 2024, to November 30, 2024. The agreement ensures prompt responses to power outages and disaster-related emergencies while a new solicitation is being developed. In this case, there were no Certified Disadvantage Minority/Disadvantage Women Business Enterprise (DM/DWBE) firms and no Registered Small Business Enterprise (SBE) firms for the specified services; therefore, no participation goal or set-aside was established for this Agreement. No additional funding is needed for this Agreement, and current funds are available in the requesting department's approved budget, and purchase orders will only be issued against approved budgets.

Fleet Services

A-22 Declare as surplus and authorize the disposal of 75 vehicle and equipment items and further authorize the Clerk of the Circuit Court to remove the property on the list from the inventory asset record. Disposal of the property will be offered for sale by public auction to the highest bidder or sold to another public entity or municipality in accordance with BOCC Policy 08.01.01.02 (Disposal of Surplus Fleet Vehicles and Related Equipment), dated April 2, 2008, and Florida State Statute

(Section 274.06). ("Suncoast") BOCC Doc #03-2063, and Seventeenth Modification Agreement with Tampa Family Health Centers, Inc. ("TFHC") BOCC Doc #03-2075 for the provision of specialty care medical services for the Hillsborough County Health Care Plan ("HCHCP"). These modifications 1) delete and replace the Fee Schedules effective May 1, 2024, 2) add the Prohibition Agreements, and 3) add the Restriction on Funding for Identification article pursuant to Section 125.0156, Florida Statutes, to each of the Agreements. The changes to the Fee Schedules were requested by the Networks. Funding for the modifications is included in the FY 2024 budget for the Indigent Health Care Trust Fund. No additional County Ad Valorem funds are required.
- A-24 Approve the FY 24 Budget Amendment resolution to adjust the FY 24 adopted beginning fund balance to current fund balance estimates which reflect actual fiscal year ending FY 23 activity. The net result of the proposed budget revisions is an increase of \$7,533,797 in fund balances and revenues within the BOCC-CW State Opioid Settlement fund. The opioid crisis is a complex public health issue with significant implications for individuals, families, and communities. To effectively combat this crisis, it is essential to allocate funding to key areas, including education, prevention, treatment, recovery, and administration within the Opioid Settlement fund. This budget amendment adjusts fund balance and revenues against personnel services, operating expenditures and grants and aids as shown in the line-item detail. This annual true-up of fund balances is good accounting/budgeting practice and will enhance budgetary and cash control. If approved, budgeted beginning fund balance will be aligned with current fund balance estimates resulting in a net increase of \$7,533,797 within the BOCC-CW State Opioid Settlement fund, bringing it from \$19,057,403 to \$26,591,200. No additional County funds are required as a result of this item.
- A-25 Approve the Twelfth Modification Agreement with St. Joseph's Community Care, Inc., a wholly owned subsidiary of St. Joseph's Hospital, Inc., BOCC Doc #06-1044 for the provision of specialty care medical services for the Hillsborough County Health Care Plan ("HCHCP"). The modification 1) updates and clarifies the Recitals; 2) extends the Agreement for a one-year period commencing July 1, 2024, for an annual aggregate amount of \$25,750,000, and continuing in full force up to and including June 30, 2025; 3) adds three (3) optional one-year renewal periods by the County through its Director of Health Care Services Department; 4) deletes and replaces the Scope of Services subparagraph A; 5) deletes and replaces the Billing subparagraph A; 6) deletes and replaces the Compensation subparagraph A; 7) deletes and replaces the Fee Schedule effective May 1, 2024; 8) adds the Prohibition Against Economic Incentives for Foreign Entities article pursuant to Section 288.0071, Florida Statutes; and 9) adds the Restriction on Funding for Identification article pursuant to Section 125.0156, Florida Statutes. The changes to the Fee Schedule were requested by the Networks. Funding for the modification is included in the FY 2024 budget for the Indigent Health Care Trust Fund. No additional County Ad Valorem funds are required.

Health Care Services – Nonprofit Contract Administration

- <u>A-26</u> Approve the Agreement with The Skills Center, Inc. to administer funding for Tampa Alumnae Delta Sigma Theta in an amount not to exceed \$75,000 for the period of October 1, 2023 through and including September 30, 2024 to provide programs focusing on education, physical development and mental health for youth and adults residing in Hillsborough County. Funding for this agreement is included in the Nonprofit Organizations FY 24 adopted budget within the Countywide General Revenue Fund. No additional County Ad Valorem funds are required.
- A-27 Approve the Agreement between Hillsborough County and Wholesome Community Ministries, Inc. for funding in an amount not to exceed \$99,220, for the period of October 1, 2023, through and including September 30, 2024, for the provision of programs to create a wellness hub that combines multiple health and human services in one location to deliver affordable healthcare, counseling, food security, community-based resources, referrals, and behavioral development support to children and families in Wimauma and surrounding rural communities. Funding for this Agreement is included in the Nonprofit Organizations FY 24 adopted budget within the Countywide General Revenue Fund. No additional County Ad Valorem funds are required.

Human Resources

A-28 Approve and execute the Second Modification Agreement with Resources Investment Advisors, LLC for 457 Consulting Services (6620,5) for the Human Resources Department. This modification is to extend the expiration date of Blanket Purchase Agreement No. 222211670 by two (2) years, from June 30, 2024, to June 30, 2026, and increase the agreement amount by \$79,000, from \$276,500, to \$355,500. This contract provides investment advisory services in connection with the County's 457(b) Deferred Compensation Plan. After careful review and consideration, it has been deemed to be in the County's best interest to ensure continuity of the 457 Consulting Services for our employees, while the Human Resources Department develops the specifications and requirements for a new competitive solicitation to be issued. In the original award the opportunity for proposers to receive five (5) bonus points by subcontracting a minimum of 10% of the ultimate fees to Certified Disadvantage Minority/Disadvantaged Women Business Enterprises (DM/DWBE) was available; however, the awarded proposer did not request such points. Funding for this procurement is available in the requesting department's budget, and purchase orders will only be issued against approved budgets.

- <u>A-29</u> (a) Approve the EnviroSim End User License Agreement (EULA) for the use of BioWin software with EnviroSim Associates Ltd. for the Water Resources Department at a total cost of \$3,000. (b) Authorize electronic acceptance via an online process, to be completed by a designated employee within the Information Technology Department. BioWin is a software used to design, upgrade, and optimize wastewater treatment plants of all types. The solution will run simulations for each of the County's wastewater treatment plants and will obtain reliable and accurate outcomes. Acceptance of the BioWin EULA will not result in an additional financial impact to the County. The annual license will be purchased by PCard at a total cost of \$3,000 via an online ordering process. Purchases will only be made against approved budgets.
- <u>A-30</u> (a) Approve the Workbench Setup License Agreement for the use of InVEST software with Stanford University for the Conservation and Environmental Lands Management Department (CELM). (b) Authorize electronic acceptance via an online process, to be completed by a designated employee within the Information Technology Department. InVEST software assists CELM by offering data-driven insights and creating visualizations. These tools aid in effective natural resource management across the County's nature preserves and conservation parks ecosystems. The InVEST software is available at no cost to the County. Acceptance of the Workbench Setup License Agreement with Stanford University will not result in a financial impact.
- (a) Approve the License Agreement for the use of Beyond Compare 4 software with Scooter Software, Inc., for the Engineering & Operations Department at a total cost of \$74.47. (b) Authorize electronic acceptance via an online process, to be completed by a designated employee within the Information Technology Department (ITD). Beyond Compare is a software application that enables users to compare, merge, and synchronize data, assisting staff with management and inventory of County-owned bridges. In this case, there are no subcontracting opportunities for Certified Disadvantaged Minority/Disadvantaged Women Business Enterprise (DM/DWBE) or Registered Small Business Enterprise (SBE) firms as the subject services will be provided directly and exclusively by the existing contractor under a cooperative contract with the State of Florida. Acceptance of the Beyond Compare 4 software, in the amount of \$74.47 will be purchased utilizing an approved Contract Purchase Agreement (224300192) with Insight Public Sector, Inc. through an available State of Florida Contract (43210000-23-OMNIA-ACS), and purchase orders will only be issued against approved budgets.
- (a) Approve and execute the Spectrum Price Attachment to Spectrum Enterprise TV Services Agreement for the annual rate changes. (b) Approve an extension to Blanket Purchase Agreement 221202129, with Charter Communications Operating LLC, for continued cable television, equipment, and installation services for the Information Technology Department through April 6, 2028. (c) Authorize signature delegation to the Director of Technology for acceptance of future rate changes and new Service Orders, without any increase to the overall award amount. The existing (Spectrum Enterprise TV Services Agreement) with Charter Communications allows the County to continue services on a month-to-month basis until the County provides Charter with at least a thirty days' notice for termination; therefore, the current Blanket Purchase Authorization (BPA) will be extended from April 6, 2025 to April 6, 2028, for continuation of services that allow County staff to view public meetings/hearings, monitor inclement weather, attend training seminars and webinars, and stay informed about community events. The agreement has sufficient capacity remaining to cover the extension period; no additional funding is required. An updated Notice of Intent to Sole Source (SS-23-24505) was previously posted, and no challenges were received. Disadvantaged Minority/Disadvantaged Women Business Enterprise (DM/DWBE) or Registered Small Business Enterprise (SBE) firms. Because this was a sole source procurement, the products will continue to be provided directly and exclusively by the existing vendor. Funding for the services is available in the requesting department's approved budget, and Purchase Orders will only be issued against approved budgets.

- A-35 Approve the termination of an existing contract (23280) with Wildlife Control Services, LLC, for the removal of feral hog removal services due to its failure to pay the required and agreed upon annual fee for the awarded area (Zone 6) to the County. Wildlife Control Services, LLC, notified the County on September 21, 2023, of its intent not to pay the annual fee of \$2,200.00 and provide the specified services in the awarded zone. In this case, there were no Certified Disadvantaged Minority/Disadvantaged Women Business Enterprise (DM/DWBE) firms and no Registered Small Business Enterprise (SBE) firms for the specified services; therefore, no participation goal or set-aside was established for this procurement. No funding is required for the recommended motion.
- A-36 Award a four (4) year contract to the lowest, responsive, and responsible bidder, Himes Electric Company, Inc., for ongoing and as-needed maintenance and repair of sports lighting systems at sports complexes and parks throughout the County (ITB-24-24467) for the Parks & Recreation Department at a total cost of \$936,510.00. The subject work will include the installation, removal, maintenance, and repair sports lighting systems, park area lighting, light-emitting diode conversion fixtures, electrical equipment and components, and other materials. No award is recommended for Line No. 1-1 due to the lack of offered discounts. If (when) parts are required, the items will be secured in accordance with the Procurement Policy. In this case, there were no Certified Disadvantaged Minority/Disadvantaged Women Business Enterprise (DM/DWBE) firms and no Registered Small Business Enterprise (SBE) firms for the specified services; therefore, no participation goal or setaside was established for this procurement. Funding is available in the requesting department's operating budget, and purchase orders will only be issued against approved budgets.
- A-37 Award a four (4) year contract to the lowest, responsive, and responsible bidder, Tampa Bay Orthopaedic Designs, Inc., for ongoing and as-needed purchases of orthotic and prosthetic devices (ITB-24-24514) for the Health Care Services Department at a total cost of \$627,000.00. This contract will be used to provide orthotic and prosthetic devices to clients of the Hillsborough County Health Care Plan (HCHCP) in accordance with Medicare guidelines. In this case, there were no Certified Disadvantaged Minority/Disadvantaged Women Business Enterprise (DM/DWBE) firms and no Registered Small Business Enterprise (SBE) firms for the specified devices; therefore, no participation goal or set-aside was established for this procurement. There are sufficient funds in the requesting department's FY 24 approved Indigent Health Care Services Fund, and purchase orders will only be issued against approved budgets.
- <u>A-38</u> Award a five (5) year Hillsborough County Registered Small Business Enterprise (SBE) Set-Aside contract to the lowest, responsive, and responsible bidder, S and C Janitorial Inc., for ongoing and as-needed janitorial services at various facilities throughout the County (ITB-24-24610) for the Facilities Management & Real Estate Services Department at a total cost of \$1,675,869.40. The resulting contract will support the requesting department in ensuring County facilities are properly maintained. In this case, the specified work was approved as a Hillsborough County Registered SBE Set-Aside; therefore, the Disadvantaged Minority/Disabled Women Business Enterprises (DM/DWBE) program requirements do not apply. The recommended vendor, S and C Janitorial Inc., is a Hillsborough County Registered SBE and Certified DM/DWBE firm.

Funding for this procurement is available in the requesting department's approved budget, and purchase orders will only be issued against approved budgets.

- A-39 Award a three (3) year sole source contract to Airgas USA, LLC, for ongoing and as-needed purchases of "Walk-O2-Bout" portable medical grade oxygen delivery systems and associated medical grade oxygen refills (SS-24-24712) for the Fire Rescue Department at a total cost of \$746,261.05. The subject oxygen delivery system is mobile and provides an all-in-one solution (tank, regulator, meter, and outlet port), which enables first responders to provide more responsive care to patients. A Notice of Intent to Sole Source (SS-24-24712) was properly posted, and no challenges were received. In this case, there were no subcontracting opportunities for Certified Disadvantaged Minority/Disadvantaged Women Business Enterprise (DM/DWBE) or Registered Small Business Enterprise (SBE) firms because this is a sole source procurement and as such, the subject equipment and related services will be provided directly and exclusively by the recommended vendor. Funding for this procurement is available in the requesting department's approved budget, and purchase orders will only be issued against approved budgets.
- <u>A-40</u> Receive a report regarding Administrative Awards with values of \$100,000 to \$250,000 during the period of January 1, 2024, to March 31, 2024.

Solid Waste

- <u>A-41</u> Approve Change Order No. 49 to an Agreement (RFP-C-206-89) with Waste Management Inc. of Florida (WMI), for additional work for continuing construction and operation of the Southeast County Landfill. This Change Order No. 49 is for additional services on Sundays and weekday after-hours (overnight) service at the Southeast County Landfill to perform landfill operations to accommodate transfer station diversions on an as-needed basis. The original contract award did not contain a Certified Disadvantaged Minority/Disadvantaged Women Business Enterprise (DM/DWBE) subcontracting requirement. The total contract value to date is \$64,011,052.40. This Change Order is not to exceed the current remaining contract balance of \$1,922,163.95. The cost of this Change Order is \$1,080,627.37. Funding for this Change Order is available in the department's approved operating budget.
- <u>A-42</u> Approve and execute the First Modification to the Agreement with Advanced Environmental Laboratories, Inc. for ongoing and as-needed laboratory analytical services (20484,1) for the Solid Waste Management Department. This First Modification Agreement is to extend the contract expiration date by three (3) months, from April 30, 2024, to July 30, 2024, to provide additional time to solicit and award a new contract for laboratory analytical services. In the original award, due to limited availability of Certified Disadvantaged Minority/Disadvantaged Women Business Enterprise (DM/DWBE) and Registered Small Business Enterprise (SBE) firms in this category, no participation goal or set-aside was established for this procurement. The amendment extends the expiration of the agreement until March 31, 2025. The agreement provides up to \$750,000 in cooperative funding from the District. (b) Approve a FY 24 budget amendment resolution to receive and appropriate \$750,000 from the District under Agreement No. 20CF0002669 for the project. The funds will be allocated into the Countywide Aquifer Recharge Program (C10327000), of which the NHARP project is a component. This project is included in the WRD's Capital Improvement Program, funded in FY 24. The budget amendment will also realign \$750,000 from the Valrico Equalization Basin project (C10291000) to the Countywide Aquifer Recharge Program (C10327000) for the required cooperative funding match. This FY 24 budget amendment resolution will decrease the Valrico Equalization Basin Project (C10291000) by \$750,000, from \$23,789,915.37 to \$23,039,915.37, and will increase the Countywide Aquifer Recharge Program (C10327000) by \$1,500,000, from \$1,000,000 to \$2,500,000.

- A-44 (a) Approve Grant Agreement No. QG009 between the Florida Department of Environmental Protection (DEP) and Hillsborough County Water Resources Department (WRD) for the Ruskin and Wimauma Low Pressure Sewer System/Septic-to-Sewer Conversion Project. The agreement provides a grant of up to \$6,102,808, the funds of which will be used for the Ruskin and Wimauma Sewer System Conversion Project (C10320000). The budget amendment will be processed following full execution of the grant agreement. This amendment does not impact water rates and charges.
- A-45 Approve the Third Modification to the existing cooperative contract purchase agreement (CPA) (ITB 15-20) administered by the Hillsborough County Sheriff's Office (HCSO) with Communications International, Inc. for maintenance, repair, and purchase of radio and communications equipment for the Water Resources Department at a total cost of \$194,320.00. The cost associated can be adequately funded within the Department's operating budget, and purchase orders will only be issued against approved budgets.
- A-46 Approve the Eighth Modification with First Data Government Solutions, LP (FDGS) for AccessNet Software Interactive Voice-Web Response Maintenance and Support (5211). FDGS provides transaction and merchant service processing to meet the needs of the Water Resource Department and maintain Payment Card Industry (PCI) compliance. This modification increases the Agreement by \$3,200,000.00, from \$4,050,716.48 to \$7,250,716.48, which will fund through the end of the contract in 2027. Because this was a sole source procurement, the services will continue to be provided directly and exclusively by the existing vendor. The cost associated can be adequately funded within the Department's operating budget. Purchase orders will be issued only against approved budgets.
- A-47 Approve and execute Change Order Number Two to the construction contract with Southeast Drilling Services, Inc., (SEDS) for the South Hillsborough Aquifer Recharge Expansion Infrastructure Project (CIP 10259), Bid No. 18644,1 to extend the contract time an additional 149 days, from April 27, 2024, to September 23, 2024, for the Water Resources Department. The additional time is needed to allow for completion of the separate drilling work before surface piping infrastructure can be installed. The contractor, as part of the original award, committed to subcontracting a minimum of 5% to Certified Disadvantaged Minority/Disadvantaged Women Business Enterprise (DM/DWBE) firms. (Garney), for the One Water -**B-1** South Wastewater Conveyance and Treatment Project (Project) (RFP 23-24453), which includes Phase 1A Preliminary Evaluation and Conceptual Planning services for the Water Resources Department (WRD) at an estimated cost of \$3,595,744. This first phase, Phase 1A, will serve as the foundation for the entire Project and will focus on performing comprehensive evaluations to confirm the major components that will be incorporated into the design for the Project, which will be further developed in subsequent subphases as part of Phase 1. This award recommendation involves only the services for Phase 1A. Services for Phases 1B, 1C, and 2 will be presented to the Board for separate consideration and approval at a later date. Based on current market conditions, the total Progressive Design-Build budget is estimated at a not-to-exceed amount of \$671,000,000. In this case, a Certified Disadvantaged Minority/Disadvantaged Women Business Enterprise (DM/DWBE) Program participation goal of 14% was established for the entirety of the project, and the recommended vendor has committed to achieving this goal. (b) Approve the FY 24 Budget Amendment Resolution to realign \$8,400,000 within the WRD Capital Improvement Program in order to fund this initial phase and other project needs. The budget amendment will realign a total of \$2,400,000 from WRD's Utility System General Revenue Capital Expense Account Fund (Fund 40105) and \$6,000,000 from WRD's Wastewater Impact Fees Fund (Fund 40181). In summary, this FY 24 budget amendment resolution will decrease C10309000 by \$5,500,000, from \$21,380,461 to \$15,880,461, and will increase C10301000 by \$3,600,000, from \$3,000,000 to \$6,600,000; increase C10308000 by \$500,000, from \$500,000 to \$1,000,000; and increase C10314000 by \$1,400,000, from \$0 to \$1,400,000. This budget amendment will result in a net zero change to the Adopted FY 24 Capital Improvement Program.
