## A. Water Allocation Permit- Forest Glenn

Authorize the insurance of a water supply capacity allocation permit in the amount of 16,300 gallons per day, which is 2.4% of the excess capacity for the Forest Glenn development, subject to the approval of the Florida Department of Environmental Protection permit for the installation of water and sewer infrastructure.

# D. Online Sting Grant Funding for Titusville Police Department's Investigation Division

### A. Ordinance No. 25-2025 - Fence Permit

Conduct the Public Hearing and Final Reading of Ordinance No. 25-2025 amending the Code of Ordinances to clarify requirements for the repair and replacement of permitted fences to be consistent with florida building code requirements by amending Sections 6-56 "Construction Permit Required; Inspection, Approval Prior To Use Or Occupancy" and 34-346 "Nonconforming Structures – Rebuild and Repair", providing for severability, repeal of conflicting ordinances, incorporation into the code and an effective date. (This is a legislative item.)

On July 2, 2025, the Planning and Zoning Commission recommended approval of the ordinance, 4-0.

# B. Small Scale Amendment (SSA) Application No. 2-2025 – 5320 South Washington Avenue

Conduct the Public Hearings and Final Reading of the ordinances for Small Scale Amendment Application No. 2-2025 – 5320 South Washington Avenue - Annexation, Small Scale Comprehensive Plan Map Amendment and Rezoning Application:

Ordinance No. 22-2025 amending Section 7, Chapter 63-2001, Laws of Florida, Special Acts of 1963, by annexing certain property located at 5320 South Washington Avenue having Parcel ID Number: 22-35-26-00-511 to be included within the City limits; providing for severability; providing for repeal of conflicting ordinances and providing for an effective date. (This ordinance is a legislative item.)

and

Ordinance No. 23-2025 amending the Code of Ordinances by amending Ordinance No. 60-1988, which adopted the Comprehensive Plan of the City of Titusville, by amending the future land use map, by changing the land use designation on approximately 4.52+/- acres of property located at 5320 South Washington Avenue, having Brevard County Parcel ID Number: 22-35-26-00-511, from the Community Commercial (Brevard County) future land use designation to the Commercial High Intensity (City of Titusville) future land use designation; providing for severability; providing for repeal of conflicting ordinances; and providing for an effective date. (This ordinance is a legislative item.)

and

Ordinance No. 24-2025 amending Ordinance No. 5-1993 of the City of Titusville, by amending the zoning map made a part of said ordinance by reference by changing the BU-1 General Retail Commercial (Brevard County) zoning district to the Community Commercial (CC) zoning district on approximately 4.52+/- acres of property located at 5320 South Washington Avenue, having Brevard County Parcel ID Number: 22-35-26-00-511; providing for severability; providing for repeal of conflicting ordinances; and providing for an effective date. The rezoning is without a concept plan. (This ordinance is a quasi-judicial item.)

# On July 2, 2025, the Planning and Zoning Commission recommended approval without the concept plan 4-0.

# C. Rezoning (REZ) No. 2-2025 - Brooks Landing Dog Park

Conduct the Public Hearing and Final Reading on Ordinance No. 26-2025 amending Ordinance No. 24-2019, amending the master plan and conditions associated with the Planned Development (PD) zoning district on approximately 3.00 acres, having Tax ID Number 3034198, located approximately 1,500 feet east of U.S. Highway 1 on the North side of Jay Jay Road, to include a dog park use; providing for severability, repeal of conflicting ordinances, and providing for an effective date. (This ordinance is a quasi-judicial item.)
