RESOLUTION

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF TEMPLE TERRACE, FLORIDA, APPROVING AND ADOPTING AN AMENDED WATER AND WASTEWATER RATE SCHEDULE WITH INCREASED RATES FOR WATER, IRRIGATION, AND WASTEWATER SERVICES; PROVIDING THAT THE REVISED RATES SHALL TAKE EFFECT OCTOBER 1, 2025; MAKING THE REVISED RATES AVAILABLE FOR INSPECTION IN THE OFFICE OF THE CITY CLERK; PROVIDING FOR CONFLICTS; PROVIDING AN EFFECTIVE DATE.

Whereas, Section 22-53 of the City Code of the Temple Terrace Code of Ordinances provides that the minimum monthly rates for water, irrigation, and wastewater service will be as reflected in the most recent Water, Irrigation, and Wastewater Rate Schedule adopted by the City Council; and

Whereas, Section 22-56 of the City Code of the Temple Terrace Code of Ordinances authorizes the City Council to set rates, fees, and charges for water, irrigation, and wastewater services by resolution; and

Whereas, after a review of the City's customer rates and fees for water, irrigation, and wastewater by City staff and a report thereof made to City Council, the City Council has determined that a rate increase of 5.0% is necessary and appropriate to accurately reflect the cost of providing water and wastewater services; and

Whereas, in accordance with Section 180.136, Florida Statutes, notice of the proposed rate increase was provided to residents through the City's utility billing process; and

Whereas, the City of Temple Terrace, Florida has the lawful authority to establish rates as set forth herein.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF TEMPLE TERRACE, FL that:

- 1. The Water, Irrigation, and Wastewater Rate Schedule, as attached hereto as Exhibit 1 and fully incorporated herein and made a part of hereof, is hereby approved and adopted.
- 2. The revised rates for water, irrigation, and wastewater services set forth in Exhibit 1 shall take effect on October 1, 2025.
- 3. The Water, Irrigation, and Wastewater Rate Schedule shall be maintained on file and available for inspection in the Office of the City Clerk.
- 4. All resolutions or parts of resolutions in conflict with any of the provisions of this Resolution are hereby rescinded.
- 5. This Resolution shall become effective immediately upon adoption.
