**\*RESOLUTION 81, 2025** – SITE PLAN APPROVAL AND MAJOR CONDITIONAL USE FOR COCONUT PALM PLAZA. A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF PALM BEACH GARDENS, FLORIDA, APPROVING A PLANNED UNIT DEVELOPMENT (PUD) SITE PLAN FOR COCONUT PALM PLAZA TO ALLOW A 38,500-SQUARE-FOOT MEDICAL OFFICE BUILDING, A 10,400-SQUARE-FOOT OFF-CAMPUS EMERGENCY DEPARTMENT FACILITY, AND A 3,650-SQUARE-FOOT CONVENIENCE STORE WITH A 1,321-SQUARE-FOOT RESTAURANT AND 16 FUELING STATIONS, AS WELL AS MAJOR CONDITIONAL USE APPROVAL FOR THE OFF-CAMPUS EMERGENCY DEPARTMENT USE, THE SUBJECT SITE BEING GENERALLY LOCATED SOUTHEAST OF THE INTERSECTION OF NORTHLAKE BOULEVARD AND COCONUT BOULEVARD, AS MORE PARTICULARLY DESCRIBED HEREIN; PROVIDING WAIVERS; PROVIDING CONDITIONS OF APPROVAL; PROVIDING AN EFFECTIVE DATE; AND FOR OTHER PURPOSES.
