If awarded, the estimated fiscal impact is \$400,000 - \$200,000 (revenue/expenditure - grant funded) and \$200,000 (expenditure - county match) and will be included in the Fiscal Year 2027 Budget request.

	The estimated fiscal impact is \$800 (expenditure) and is within, and will not exceed, the Fiscal Year 2026 Budget. Commission District 3.

The fiscal impact is \$733.20 (expenditure) and is within, and will not exceed, the Fiscal Year 2026 Budget.
