44 **Section 2:** That if any section, phrase, sentence or portion of this ordinance is for any  
45 reason held invalid or unconstitutional by any court of competent jurisdiction, such portion shall  
46 be deemed a separate, distinct and independent provision, and such holding shall not affect the  
47 validity of the remaining portions thereof.

48 **Section 3:** That all sections or parts of sections of the Code of Ordinances, all Ordinances  
49 or parts of Ordinances, and all Resolutions or parts of Resolutions in conflict herewith, be and the  
50 same are hereby repealed to the extent of such conflict.

51 **Section 4:** That this Ordinance shall not be codified.

52 **Section 5:** That this ordinance shall become effective immediately upon its final passage  
53 and adoption.
