**a. 04-07-2026 Commission Meeting Minutes**

Motion made by Commissioner Dwyer to approve the 04-07-2026 Commission Meeting Minutes as presented; seconded by Commissioner Smith.

**PUBLIC HEARING: FINAL READING**

**a. Ordinance 2026-05: Small Scale Comprehensive Plan Amendment for 45367-000-00**

Mayor Dobkowski read Ordinance 2026-05, Small Scale Comprehensive Plan Amendment for 45367-000-00, Title Only. Development Director Chancey reviewed the Ordinance, which was approved on first reading at the March, 17, 2026 Commission Meeting. The property, owned by E2 Farm, was annexed into the City in December 2025. It is located along US Hwy 441 and surrounded by agricultural and commercial uses. Currently served by well and septic, all existing structures will be removed for future development, including on-site drainage and part of a retail building.

This application amends the Future Land Use and Zoning Maps to assign City designations (Chart 1), rezoning from Marion County General Agriculture (A-1) to City Wholesale Business (B-5) and changing land use from Marion County Employment Center to City Commercial. The proposed designations are consistent with the intended use and compatible with surrounding properties.

Commissioner Dwyer asked when the city would find out what business will be coming in. DSD Chancey stated that their next step will be to submit a site plan, which will be occurring soon.

Commissioner Smith stated that he doesn't want to approve it without knowing what the business will be.

Commissioner Goldman remarked that the goal of the zoning change is to make the property consistent with the land around it. He further stated that the developer's agreement and site plan are the opportunities for the City to make specifications in writing. DSD Chancey stated that there is a study being done by FDOT and they will be putting in a light on Hwy 441.

Mayor Dobkowski stated this is a Public Hearing and asked if anyone in the audience had any comments. No one came forward.

Motion made by Commissioner Goldman to approve Ordinance 2026-05 on Final Reading, Title Only; seconded by Commissioner Livsey.

**b. Ordinance 2026-06: Annexation of 3924-021-010, 3924-021-011, 3924-021-049, and 3924-021-050**

Mayor Dobkowski read Ordinance 2026-06, Annexation of 3924-021-010, 3924-021-011, 3924-021-049, and 3924-021-050, Title Only. DSD Chancey stated the subject parcels are commercially zoned properties owned by Brian Ehlers Construction Company LLC. This application, initiated by the property owner, annexes the properties into the City of Belleview. The properties are surrounded by commercial and residential properties. The properties have convenient access to US HWY 441 and SE 70th Ave Rd. All four parcels are currently vacant. The ordinance was approved on first reading at the March 17, 2026 meeting.

Mayor Dobkowski stated this is a Public Hearing and asked if anyone in the audience had any comments. No one came forward.

Motion made by Commissioner Goldman to approve Ordinance 2026-06 on Final Reading, Title Only; seconded by Commissioner Dwyer.

**PUBLIC HEARING: FIRST READING**

**a. Ordinance 2026-08: Roll-up and Hurricane Shutters**

Mayor Dobkowski read Ordinance 2026-08, Roll-up and Hurricane Shutters, Title Only. DSD Chancey state that at the March 3<sup>rd</sup> and March 17<sup>th</sup> Commission meetings, the Commission discussed the city code (Sec.134-665), which prohibits shutters installed on the exterior of commercial buildings. As a result, staff was directed to bring back a proposed ordinance to allow certain at-risk businesses to be permitted to install exterior shutters for crime prevention. At-risk businesses include pharmacies, pawn shops, convenience stores, or other businesses deemed at risk by the Chief of Police.

The proposed ordinance also addresses storm shutters to be used temporarily in the event of a hurricane, tornado, or tropical storm watch has been declared for the area encompassing the city. Tracks for storm shutters are to be painted the same color as the exterior of the building.

Mayor Dobkowski stated this is a Public Hearing and asked if anyone in the audience had any comments. No one came forward.

Motion made by Commissioner Livsey to approve Ordinance 2026-07 on First Reading, Title Only with amendments discussed; seconded by Commissioner Goldman.

Commissioner Dwyer stated that based on the crime statistics from Chief Holland, he does not see a need to change to the code. Commissioner Smith agreed that three break-ins in five years out of 400 businesses inside the city does not warrant a change and further stated that they look unattractive and unwelcoming.

Mayor Dobkowski pointed out that the proposed ordinance does not allow all businesses to have shutters, only the at-risk businesses outlined in the code and ones designated by Chief Holland upon submittal of an exception.

Commissioner Goldman remarked that he researched other communities and found that most do not regulate shutters at all. As a small business owner, he feels the City should not impede people from protecting their businesses and prefers there be no restrictions at all. He commented that he liked the section that specified the shutters be the same color as the building. DSD Chancey clarified that the railing channel must be the same, but can amend the ordinance to require shutters be the same color as the building for the second reading.

Commissioner Smith asked what is to be done if graffiti is painted on the shutters. DSD Chancey stated there is code in place to address graffiti through Code Enforcement, but an amendment can be added to specify the amount of days before action is taken by the City. Attorney Landt explained that all businesses must follow the current timeline for removing graffiti from their buildings.

Attorney Landt said that if a business applies for an exception and Chief Holland determines it is not needed, the business owner can appeal to the City Commission. Mayor Dobkowski commented that she is in favor of any business requesting to have them, but noted that until last year, only five businesses had ever put up shutters and doesn't believe there will be a lot of applications.

Attorney Landt requested Commissioner Livsey request a friendly amendment to include the recommended changes regarding graffiti and the color of the shutters.

Commissioner Livsey agreed with the language of the friendly amendment and made the motion; seconded by Commissioner Goldman who accepted the friendly amendment.

# Public Hearing Final Reading Ordinance 2026-08

**BACKGROUND:**

At the March 3rd and March 17th Commission meetings, the Commission discussed the city code (Sec. 134-665), which prohibits shutters installed on the exterior of commercial buildings. As a result, staff was directed to bring back a proposed ordinance allowing certain at-risk businesses to install exterior shutters for crime prevention. At-risk businesses include pharmacies, pawn shops, convenience stores, or other businesses deemed at risk by the Chief of Police.

The Commission approved this Ordinance on First Reading at the April 21st meeting. It was approved with the amendment that the shutters be painted to match the wall to which they are to be affixed.

**AN ORDINANCE AMENDING CHAPTER 134, SECTION 134-665 REGARDING ROLLUP SHUTTERS; ESTABLISHING A PROCESS FOR APPROVAL OF CERTAIN EXTERIOR ROLLUP SHUTTERS; PROVIDING FOR DETERMINATION OF AT-RISK BUSINESSES; PROVIDING FOR APPEAL OF DECISIONS; AMENDING SECTION 134-666 REGARDING INSTALLATION OF STORM SHUTTERS; PROVIDING TIME LIMITS; PROHIBITING CERTAIN USES OF PLYWOOD; AND PROVIDING FOR AN EFFECTIVE DATE.**

**Whereas**, Chapter 134, Article V of the City Code provides for the regulation of roll-up shutters and storm shutters; and

**Whereas**, the City Commission finds that it is in the public interest to amend Section 134-665 to provide a process for approval of the use of exterior rollup shutters for certain at-risk businesses; and

**Whereas**, the City Commission finds that use of storm shutters should be limited as set forth below; and

**Whereas**, the City Commission finds that use of plywood should be limited as set forth below; and

**Whereas**, the City Commission finds that it is in the public interest to provide a process to appeal a decision regarding at-risk businesses.

**Now Therefore, Be It Ordained** by the City Commission of the City of Belleview, Florida that Chapter 134, Article V. Section 134-665 of the City Code is amended as to rollup shutters, which subsections shall read as follows:

**Sec. 134-665.** Roll-up shutters.

- a) Roll-up shutters for nonresidential uses shall be located interior to doors and windows in new construction.
- b) Roll-up shutters may be installed on the exterior of an existing nonresidential building for crime prevention by at-risk businesses.
  1. At-risk businesses include pharmacies, pawn shops, convenience stores, or other businesses deemed at risk by the Chief of Police.
  2. The Chief of Police or his designee shall provide written notice of the decision regarding an at-risk business within ten (10) days.
  3. Appeal of the decision of the Chief of Police regarding the determination whether a business is at risk shall be to the Belleview City Commission by written request filed with the City Clerk within ten (10) days of receiving Notice of the decision. Receipt of such Notice shall be deemed received two business days after being posted to the U. S. Mail directed to the address provided in the request for outside shutters.”

4. Shutters and mounting hardware must be painted to match the wall upon which they are affixed.

**Be It Further Ordained** by the City Commission of the City of Belleview, Florida, that Chapter 134, Article V. Section 134-666 of the City Code is amended as to storm shutters and use of plywood, which subsections shall read as follows:

**“Secs. 134-666. Storm shutters**

Storm shutters of any type allowed by the Florida Building Code may be used to temporarily secure a property, subject to the following limitations:

- (a) It shall be prohibited to cover any window or door opening with storm shutters unless a hurricane, tornado, or tropical storm watch has been declared for the area encompassing the city.
- (b) Storm shutters shall be removed within 30 days after the issuance of the hurricane, tornado, or tropical storm watch. The period for removal may be extended by order of the City Administrator during a declared state of emergency or if there is an active building permit for window or door replacement.
- (c) Shutters and tracks for removable panels must be painted to match the wall upon which they are affixed.
- (d) Permanently installed plywood panels installed over windows or doors are prohibited.
- (e) Installation of storm shutters requires a building permit.”

**BE IT FURTHER ORDAINED** that all ordinances or parts of ordinances in conflict with this ordinance are, to the extent of such conflict, repealed.

**BE IT FURTHER ORDAINED** that It is the intention of the City Commission that the provisions of this ordinance shall become and be made a part of the Code of Ordinances for the City of Belleview, Florida; that the sections of this ordinance may be renumbered or re-lettered to accomplish such intention; and that the word "ordinance" may be changed to "section," "article," or other appropriate designation.

**BE IT FURTHER ORDAINED** that this Ordinance shall become effective immediately upon adoption.

At the March 3, 2026 meeting Clay Waldron, proprietor of Bellevue Meats, came in front of the Commission to request an exception to the City's Fats, Oils, and Grease (FOG) policies. As directed by the Commission, staff carried out research regarding interceptor sizing and calculation factors. Ordinance 2026-11 clarifies when interceptors are required and updates the interceptor sizing calculation factors.

## ORDINANCE 2026-11

**AN ORDINANCE AMENDING CHAPTER 86, SECTION 225 OF THE BELEVUE CITY CODE REGARDING PROTECTING THE CITY SEWER FROM FATS, OILS, AND GREASE (F.O.G.); AMENDING SUB-SECTION 86.225(a)(1) TO CLARIFY WHEN INTERCEPTORS ARE REQUIRED AND AMENDING 86.225(a)(4) WITH UPDATED CALCULATION FACTORS FOR INTERCEPTOR SIZING AS PER FLORIDA ADMINISTRATIVE CODE 62-6.013(7)(d).; REPEALING ALL ORDINANCES IN CONFLICT; AND PROVIDING FOR AN EFFECTIVE DATE.**

**WHEREAS**, Chapter 86 of the City Code provides for the City wastewater system; and

**WHEREAS**, the City Commission finds that it is in the public interest to amend Chapter 86-225(a)(1) and 86-225(a)(4) to clarify when interceptors are required and to update the interceptor sizing calculation factors; and

**NOW THEREFORE, BE IT ORDAINED** by the City Commission that Chapter 86, Sub-Section 86-225(a)(1) of the City Code is hereby amended to read as follows:

- (1) Fats, oils, and grease (F.O.G.) interceptors required.
  - a. New Construction: Restaurants, cafes, coffee shops, smoothie and juice bars, lunch counters, take-outs, cafeterias, butcher shops, meat markets, food courts, bakeries, convenience stores, delicatessens, sub shops, bars, clubs, breweries, micro-breweries, cold dairy, frozen foodstuff, concession stands, sports arenas, commissary kitchens, hotel, motel, casinos, lounges, convention centers, hospitals, long term care facilities, factory, institutional, or school kitchens or other establishments that serve or prepare food where F.O.G. may be introduced to the sewer system shall install an outdoor F.O.G. gravity grease interceptor.
  - b. Retrofit of Existing Establishments: The Public Works Director may approve hydromechanical grease interceptors or automatic grease removal devices on a limited basis for facilities that:
    - i. Cannot install an outdoor gravity grease interceptor due to site constraints; or
    - ii. Do not cook or fry and have a 3-compartment sink rate for < 50 gallons per minute; or
    - iii. Can provide documented evidence of minimal F.O.G. generation such that a gravity grease interceptor is not required.

Approval shall be subject to review of the specific operations, fixtures, and anticipated discharge and may include conditions related to operation, maintenance, and monitoring. Approval may be revoked at any time if the

establishment discharges F.O.G. into the City's sewer system in a manner that causes or contributes to sanitary sewer overflows (SSOs) or increased line maintenance by the City, which would then require that an out-door, in-ground interceptor be installed. Any change in operations—including, but not limited to, the addition of cooking, hot food preparation, or expanding food processing—shall require a reevaluation of grease interceptor requirements.

**BE IT FURTHER ORDAINED** by the City Commission that Chapter 86, Sub-Section 86-225(a)(4) of the City Code is hereby amended to update the calculation factors as follows:

Restaurants: (S) X (GS) X (HR/12) X (LF) = effective capacity of grease interceptor in gallons

S = number of seats in the dining area

GS = gallons of wastewater per seat; use 25 gallons for ordinary restaurant, use 10 gallons for single service article restaurants.

HR = number of hours establishment is open

LF = loading factor: use 2.0 interstate highways, 1.5 other freeways, 1.25 recreational areas, 1.0 main highways, and 0.75 other roads.

Other type establishments with commercial kitchens: (M) X (GM) X (LF) = effective capacity of grease interceptor in gallons.

M = meals prepared per day

GM = gallons of wastewater per meal: use 5 gallons

LF = Loading Factor: use 1.00 with dishwashing and 0.75 without dishwashing.

**BE IT FURTHER ORDAINED** that all ordinances or parts of ordinances in conflict with this ordinance are to the extent of such conflict repealed.

**BE IT FURTHER ORDAINED** that it is the intention of the City Commission that the provisions of this ordinance shall become and be made a part of the Code of Ordinances for the City of Belleview, Florida; that the sections of this ordinance may be renumbered or re-lettered to accomplish such intention; and that the word "ordinance" may be changed to "section," "article," or other appropriate designation.

**BE IT FURTHER ORDAINED** that this Ordinance shall become effective immediately upon adoption.

To promote clarity and ensure regulatory consistency, staff requested direction regarding potential amendments to the code.

This ordinance will allow parking of accessory vehicles in front yards without a Special Exception. It will also limit accessory vehicle yard encroachment by no more than two (2) accessory vehicles; and prohibit accessory vehicles from intruding into the right-of-way and obscuring visibility.

**AN ORDINANCE AMENDING CHAPTER 134, ARTICLE V, DIVISION 2, SECTION 134-465 REGARDING YARD ENCROACHMENT BY ACCESSORY PARKING; REPEALING THE REQUIREMENT THAT ACCESSORY VEHICLE ENCROACHMENT IN THE FRONT YARD REQUIRE APPROVAL AS A SPECIAL EXCEPTION; LIMITING THE NUMBER OF ACCESSORY VEHICLES PERMITTED; PROHIBITING OBSTRUCTION OF VISIBILITY IN RIGHT OF WAY; AND PROVIDING FOR AN EFFECTIVE DATE.**

**Whereas**, Chapter 134, Article v, Division 2, Section 134-465 provides regulations regarding lot, yard, height, and other site regulations, including encroachment by accessory vehicle parking; and

**Whereas**, the City Commission finds that it is in the public interest to allow accessory parking in the front yard without requiring approval as a special exception; and

**Whereas**, the City Commission finds that it is in the public interest to allow yard encroachment by no more than two (2) accessory vehicles; and

**NOW THEREFORE, BE IT ORDAINED** by the City Commission of the City of Belleview, Florida, that Chapter 134, Article V, Division 2, Section 134-465 (8) of the City Code is amended regarding yard encroachment by accessory vehicles, which Sections shall read as follows:

**CHAPTER 134, ZONING,**

**ARTICLE V. SUPPLEMENTARY DISTRICT REGULATIONS**

**DIVISION 2. - LOT, YARD, HEIGHT, AND OTHER SITE AREA REGULATIONS**

**SEC. 134.465. - YARD ENCROACHMENTS.**

“(8) Accessory parking is permissible in the front, side, or rear yard. Accessory parking shall be limited to no more than one boat and one trailer, or a combination of two vehicles meeting the definition of accessory parking. Accessory parking shall not extend into the right-of-way in a manner that obstructs visibility.”

**BE IT FURTHER ORDAINED** that all ordinances or parts of ordinances in conflict with this ordinance are to the extent of such conflict, repealed.

**BE IT FURTHER ORDAINED** that It is the intention of the City Commission that the provisions of this ordinance shall become and be made a part of the Code of Ordinances for the City of Belleview, Florida; that the sections of this ordinance may be renumbered or re-lettered to accomplish such intention; and that the word "ordinance" may be changed to "section," "article," or other appropriate designation.

**WHEREAS**, the City of Belleview is vulnerable to the human and economic costs of natural, technological, and societal disasters, and the City Commissioners recognizes the importance of reducing or eliminating those vulnerabilities for the overall safety, health, and welfare of the community; and

**BACKGROUND:**

The City's code prohibits customers from paying by check for the lifetime of their account if they have accumulated three (3) NSF checks. An analysis of other Florida municipalities found that most do not have language in their code about check payment restriction after multiple NSF instances. Of the organizations that do place restrictions on the acceptance of checks, most allow checks after 12 or 24 months of good payment history.

There are currently 82 customers that are unable to pay via check or echeck per City code. There are currently 33 on the list that haven't had an NSF check in 24 months; some customers have not been able to pay via check for 10-20 years. Staff recommends a change in the code to allow customers with a period of good payment history to pay via check.

## Non-Sufficient Funds (NSF) Check Information

The City's code prohibits customers from paying by check for the lifetime of their account if they have accumulated three (3) NSF checks.

There are currently 82 customers that are unable to pay via check or echeck per City code. There are currently 33 on the list that haven't had an NSF check in 24 months. There are several customers that have not been able to pay via check for 10-20 years.

An analysis of other Florida municipalities found that most do not have language in their code about check payment restriction after multiple NSF instances. Of the organizations that do place restrictions on the acceptance of checks, most allow checks after 12 or 24 months of good payment history.

### **Staff Recommendations**

- Proposal 1
  - o Allow customers to utilize check payments after 24 months without a returned check AND disconnection for non-payment
- Proposal 2
  - o Allow customers to utilize check payments after 24 months without a returned check
  - o Require an additional 12 months if there is a disconnection for non-payment
- Proposal 3
  - o Allow customers to utilize check payments after 24 months without a returned check
  - o No restrictions if the customer has been disconnected
