BACKGROUND:

Ordinance 2026-11 was approved on first reading at the May 5, 2026, meeting. It clarifies when interceptors are required and updates the interceptor sizing calculation factors in the City's Fat, Oils, and Grease (FOG) policies.

ORDINANCE 2026-11

AN ORDINANCE AMENDING CHAPTER 86, SECTION 225 OF THE BELEVUE CITY CODE REGARDING PROTECTING THE CITY SEWER FROM FATS, OILS, AND GREASE (F.O.G.); AMENDING SUB-SECTION 86.225(a)(1) TO CLARIFY WHEN INTERCEPTORS ARE REQUIRED AND AMENDING 86.225(a)(4) WITH UPDATED CALCULATION FACTORS FOR INTERCEPTOR SIZING AS PER FLORIDA ADMINISTRATIVE CODE 62-6.013(7)(d).; REPEALING ALL ORDINANCES IN CONFLICT; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, Chapter 86 of the City Code provides for the City wastewater system; and

WHEREAS, the City Commission finds that it is in the public interest to amend Chapter 86-225(a)(1) and 86-225(a)(4) to clarify when interceptors are required and to update the interceptor sizing calculation factors; and

NOW THEREFORE, BE IT ORDAINED by the City Commission that Chapter 86, Sub-Section 86-225(a)(1) of the City Code is hereby amended to read as follows:

(1) Fats, oils, and grease (F.O.G.) interceptors required.

- a. New Construction: Restaurants, cafes, coffee shops, smoothie and juice bars, lunch counters, take-outs, cafeterias, butcher shops, meat markets, food courts, bakeries, convenience stores, delicatessens, sub shops, bars, clubs, breweries, micro-breweries, cold dairy, frozen foodstuff, concession stands, sports arenas, commissary kitchens, hotel, motel, casinos, lounges, convention centers, hospitals, long term care facilities, factory, institutional, or school kitchens or other establishments that serve or prepare food where F.O.G. may be introduced to the sewer system shall install an outdoor F.O.G. gravity grease interceptor.
- b. Retrofit of Existing Establishments: The Public Works Director may approve hydromechanical grease interceptors or automatic grease removal devices shall be subject to the following:
 1. Limited conditions:
 - i. Cannot install an outdoor gravity grease interceptor due to site constraints; or
 - ii. Do not cook or fry and have a 3-compartment sink rate for < 50 gallons per minute; or
 - iii. Can provide documented evidence of minimal F.O.G. generation such that a gravity grease interceptor is not required.

2. Review for Approval. Approval of a request to use hydromechanical grease interceptors or automatic grease removal devices
- i. The Public Works Director shall review the specific operation, fixtures, and anticipated discharge.
 - ii. The Public Works Director may also review operational conditions, maintenance, and monitoring.
 - iii. Approval may be revoked at any time if that discharges of F. O. G. from the establishment into the City Sewer System causes or contributes to sanitary sewer overflows (SSO's) or increases line maintenance by the City. Upon revocation of approval, an out-door, in ground interceptor shall be required.
 - iv. Upon a change in operations, including but not limited to the addition of cooking, hot food preparation, or expanding food processing, a reevaluation of the grease interceptor requirements shall be required.

BE IT FURTHER ORDAINED by the City Commission that Chapter 86, Sub-Section 86-225(a)(4) of the City Code is hereby amended to update the calculation factors as follows:

Restaurants: $(S) \times (GS) \times (HR/12) \times (LF)$ = effective capacity of grease interceptor in gallons

S = number of seats in the dining area

GS = gallons of wastewater per seat; use 25 gallons for ordinary restaurant, use 10 gallons for single service article restaurants.

HR = number of hours establishment is open

LF = loading factor: use 2.0 interstate highways, 1.5 other freeways, 1.25 recreational areas, 1.0 main highways, and 0.75 other roads.

Other type establishments with commercial kitchens: $(M) \times (GM) \times (LF)$ = effective capacity of grease interceptor in gallons.

M = meals prepared per day

GM = gallons of wastewater per meal: use 5 gallons

LF = Loading Factor: use 1.00 with dishwashing and 0.75 without dishwashing.

BE IT FURTHER ORDAINED that all ordinances or parts of ordinances in conflict with this ordinance are to the extent of such conflict repealed.

BE IT FURTHER ORDAINED that it is the intention of the City Commission that the provisions of this ordinance shall become and be made a part of the Code of Ordinances for the City of Belleview, Florida; that the sections of this ordinance may be renumbered or re-lettered to accomplish such intention; and that the word "ordinance" may be changed to "section," "article," or other appropriate designation.

BE IT FURTHER ORDAINED that this Ordinance shall become effective immediately upon adoption.

BACKGROUND:

On April 7, staff conducted a review of the applicable provisions of the City Code, noting that recreational vehicles are currently permitted to be parked within front yards, whereas accessory vehicles require approval through a Special Exception. On May 5, 2026, the Commission passed the Ordinance on first reading to promote clarity and ensure regulatory consistency.

This ordinance allows parking of accessory vehicles in front yards without a Special Exception. It also limits accessory vehicle yard encroachment by no more than two (2) accessory vehicles; and prohibit accessory vehicles from intruding into the right-of-way and obscuring visibility.

ORDINANCE 2026-12

AN ORDINANCE AMENDING CHAPTER 134, ARTICLE V, DIVISION 2, SECTION 134-465 REGARDING YARD ENCROACHMENT BY ACCESSORY PARKING; REPEALING THE REQUIREMENT THAT ACCESSORY VEHICLE ENCROACHMENT IN THE FRONT YARD REQUIRE APPROVAL AS A SPECIAL EXCEPTION; LIMITING THE NUMBER OF ACCESSORY VEHICLES PERMITTED; PROHIBITING OBSTRUCTION OF VISIBILITY IN RIGHT OF WAY; AND PROVIDING FOR AN EFFECTIVE DATE.

Whereas, Chapter 134, Article v, Division 2, Section 134-465 provides regulations regarding lot, yard, height, and other site regulations, including encroachment by accessory vehicle parking; and

Whereas, the City Commission finds that it is in the public interest to allow accessory parking in the front yard without requiring approval as a special exception; and

Whereas, the City Commission finds that it is in the public interest to allow yard encroachment by no more than two (2) accessory vehicles; and

Whereas, the City Commission finds that it is in the public interest to prohibit accessory vehicles from intruding into the right-of-way and obscuring visibility

NOW THEREFORE, BE IT ORDAINED by the City Commission of the City of Belleview, Florida, that Chapter 134, Article V, Division 2, Section 134-465 (8) of the City Code is amended regarding yard encroachment by accessory vehicles, which Sections shall read as follows:

CHAPTER 134, ZONING,

ARTICLE V. SUPPLEMENTARY DISTRICT REGULATIONS

DIVISION 2. - LOT, YARD, HEIGHT, AND OTHER SITE AREA REGULATIONS

SEC. 134.465. - YARD ENCROACHMENTS.

“(8) Accessory parking is permissible in the front, side, or rear yard. Accessory parking shall be limited to no more than one boat and one trailer, or a combination of two vehicles meeting the definition of accessory parking. Accessory parking shall not extend into the right-of-way in a manner that obstructs visibility.”

BE IT FURTHER ORDAINED that all ordinances or parts of ordinances in conflict with this ordinance are to the extent of such conflict, repealed.

BE IT FURTHER ORDAINED that It is the intention of the City Commission that the provisions of this ordinance shall become and be made a part of the Code of Ordinances for the City of Belleview, Florida; that the sections of this ordinance may be renumbered or re-lettered to accomplish such intention; and that the word "ordinance" may be changed to "section," "article," or other appropriate designation.

BE IT FURTHER ORDAINED that this Ordinance shall become effective immediately upon adoption.

ORDINANCE NO. 2026-09

AN ORDINANCE ANNEXING TO THE CITY OF BELLEVUE, FLORIDA, CERTAIN LANDS IN MARION COUNTY, FLORIDA, PURSUANT TO CHAPTER 171, FLORIDA STATUTES, PROVIDING FOR TERMS AND CONDITIONS OF SAID ANNEXATION AND DESCRIBING THE AREA TO BE ANNEXED, AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, a Petition for immediate annexation of the following parcel of land, lying and being in the unincorporated area of Marion County and lying contiguous to the City of Bellevue, Florida, has been filed with the City of Bellevue; and

WHEREAS, said land is comprised of **one (1) parcel, totaling 3.50** acres more or less; and

WHEREAS, said properties are more particularly described herein-below and is comprised of land lying and being in Marion County, Florida; and

WHEREAS, Marion County has submitted no objection to annexation by the City of Bellevue of the herein described lands; and

WHEREAS, Marion County has existing Comprehensive Plan Future Land Use (FLU) and Zoning designations on said lands as follows:

WHEREAS, the properties to be annexed will be subject to the City Comprehensive Plan Future Land Use designation and the City of Bellevue zoning classification most consistent with the existing classifications (unless otherwise requested by the property owner) as designated on the official maps of Marion County Florida; and

WHEREAS, the City of Bellevue believes it is in the public interest for said land to be annexed into the City in accordance with Section 171.044, Florida Statutes; and

WHEREAS, said unincorporated area to be annexed meets the standards of Section 171.042, Florida Statutes, and such required reports setting forth plans to provide urban services are on file with the City Engineer; and

WHEREAS, said unincorporated areas to be annexed meet the general standards of Subsection (1) and Subsection (2)(c) of Section 171.043, Florida Statutes.

NOW, THEREFORE, BE IT ORDAINED by the City Commission of the City of Belleview, Florida, as follows:

Section 1. The City Commission of the City of Belleview, Florida, in accordance with the powers given and granted to said City of Belleview in and by Chapter 171, Florida Statutes, does hereby extend the City limits of the City of Belleview so as to include therein the following described territory, which is adjacent thereto and more particularly described as follows:

The following described parcels of land owned by Belleview Propane Inc:

Commencing at a point 33.00 feet north, 00°00'09" W. of SW Corner of Lot 6-A of J. L. McGahagans Estate as recorded in Plat Book E. Page 44, Public Records of Marion County, Florida; said Point of Beginning going on the North Right-of-Way Line of an existing graded county road, (SE 100th Street); thence from the Point of Beginning thus described continue N. 00°00'09" W. along the West boundary of said Lot 6-A of J. L. McGahagan's Estate, said West boundary being the West boundary of the SE ¼ of Section 23, Township 16 South Range 22 East, a distance of 470.89 feet to a point that is S. 00°00'09" E. 450.00 feet from the NW corner of those lands as described in Official Records Book 481, Page 351, Public Records of Marion County, Florida; thence departing from said West boundary N. 75°47'05" E. a distance of 301.88 feet; thence S 01°33'04" a distance of 544.68 feet to a point on the aforesaid North Right-of-Way Line a distance of 307.36 feet to the Point of Beginning; all being in Marion County, Florida, containing 3.5 acres more or less, together with two mobile homes.

Said parcels of land also being depicted on the map attached hereto as Exhibit A.

Section 2. The properties to be annexed shall be subject to City taxes and debts in accordance with Section 171.061 Florida Statutes.

Section 3. No homestead located in said area shall be reduced in area because of its inclusion in the City Limits of the City of Belleview.

Section 4. The additional territory annexed shall retain the comprehensive plan future land use and zoning classifications existing at the time this ordinance is approved, as those classifications appear in the comprehensive plan and zoning ordinances of Marion County, Florida, until such time as the City of Belleview adopts a comprehensive plan future land use and zoning designation for the annexed property as described above.

Section 5. The comprehensive plan future land use and zoning designation adopted by the City for the additional territory annexed herein shall be based upon the City future land use and zoning district which is in compliance with its Comprehensive Plan and which is closest to the Marion County future land use and zoning classification in effect at the time of annexation or as otherwise requested by the property owner.

Section 6. All ordinances or parts of ordinances in conflict with this ordinance are to the extent of such conflict repealed.

Section 7. It is the intention of the City Commissioners and it is hereby provided that the provisions of this ordinance shall become and be made a part of the Code of Ordinances for the City of Belleview, Florida; that the sections of this ordinance may be renumbered or re-lettered to accomplish such intention; and that the word "ordinance" may be changed to "section," "article," or other appropriate designation.

Section 8. This Ordinance shall become effective immediately upon adoption.

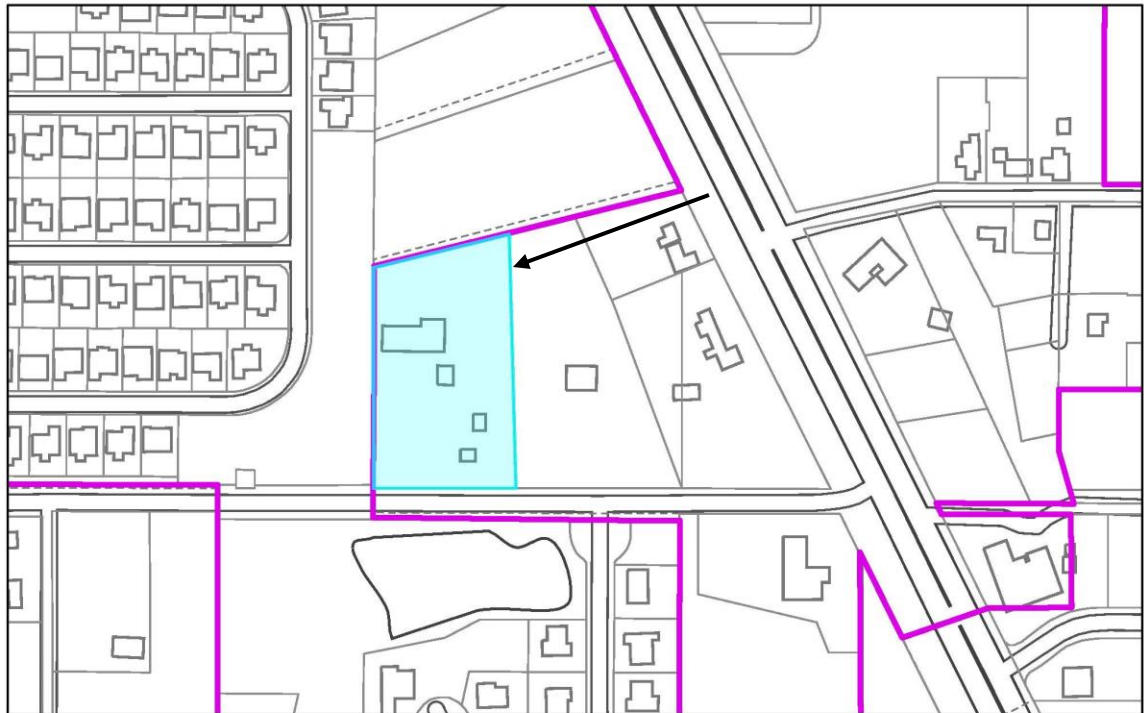

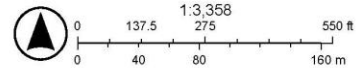

Schools – No impacts on Marion County schools will result from this application. Marion County School Board planners have been notified of this application.

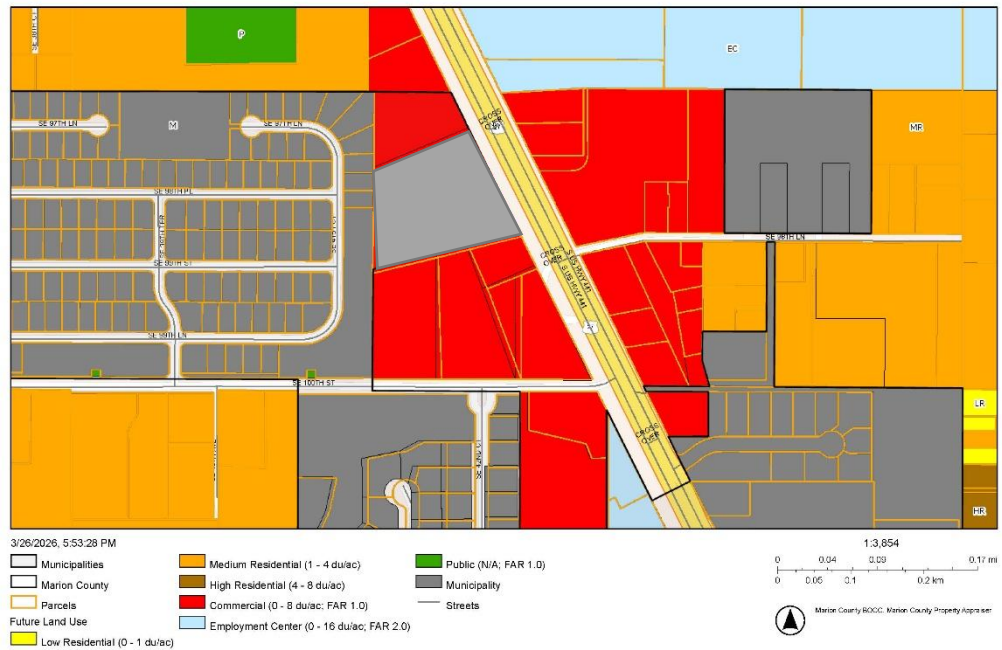

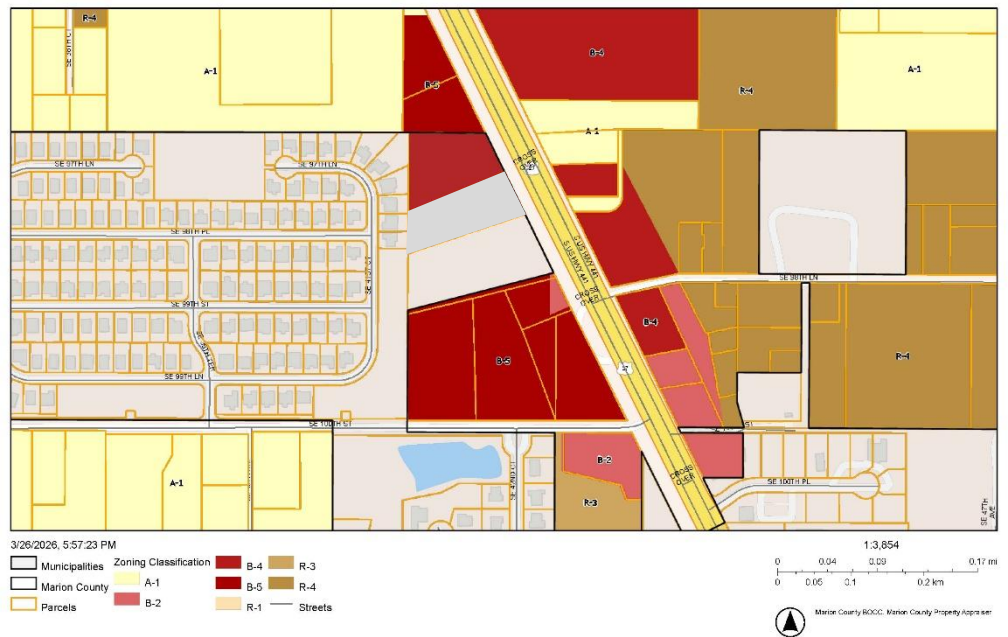
Utility Lines
