

ORDINANCE NO. C-26-34

AN ORDINANCE OF THE CITY OF FORT LAUDERDALE, FLORIDA, AMENDING THE UNIFIED LAND DEVELOPMENT REGULATIONS ARTICLE II. – ZONING DISTRICT REQUIREMENTS, MORE SPECIFICALLY SECTION 47-6.10.- LIST OF PERMITTED AND CONDITIONAL USES, COMMUNITY BUSINESS (CB) DISTRICT, AND SECTION 47-6.11. – LIST OF PERMITTED AND CONDITIONAL USES, BOULEVARD BUSINESS (B-1) DISTRICT; TO INCLUDE FORTUNE TELLERS, PSYCHIC READERS TO THE LIST OF PERMITTED AND CONDITIONAL USE TABLES FOR THE COMMUNITY BUSINESS (CB) DISTRICT AND BOULEVARD BUSINESS (B-1) DISTRICT, AND PROVIDING FOR CORRECTION OF SCRIVENER’S ERRORS, SEVERABILITY, REPEAL OF CONFLICTING ORDINANCE PROVISIONS, AND AN EFFECTIVE DATE.

WHEREAS, the City Commission of the City of Fort Lauderdale, Florida, desires to amend Article II – “Zoning District Requirements”, Section 47-6.10. - “List of permitted and conditional uses, Community Business (CB) District” and Section 47-6.11. – “List of permitted and conditional uses, Boulevard Business (B-1) District” of the City of Fort Lauderdale, Florida, Unified Land Development Regulations (“ULDR”) to include Fortune tellers, Psychic readers use to the list of Permitted and Conditional Use tables; and

WHEREAS, the Planning and Zoning Board, acting as the local planning agency, at its meeting of May 20, 2026 (PZ Case UDP-T25006), found that the proposed text amendments for Sections 47-6.10., and 47-6.11. of the ULDR are consistent with the City’s Comprehensive Plan and the Planning and Zoning Board recommended approval of said proposed text amendments to the City Commission; and

WHEREAS, the City Clerk notified the public of public meetings to be held before the City of Fort Lauderdale City Commission on Tuesday, August 18, 2026, at 6:00 P.M., or as soon thereafter as possible, and on Wednesday, September 2, 2026, at 6:00 P.M., or as soon thereafter as possible, at the Fort Lauderdale Police Department, Community Room #1004, located at 1300 West Broward Boulevard, Fort Lauderdale, Florida, for the purpose of hearing any public comment to said amendments to the ULDR;

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COMMISSION OF THE CITY OF FORT LAUDERDALE, FLORIDA:

SECTION 3. CODIFICATION AND SCRIVENER'S ERRORS. The City intends that this Ordinance will be made part of the Code of Ordinance; that sections of this Ordinance can be re-numbered or re-lettered to accomplish codification and, regardless of whether this Ordinance is ever codified, the Ordinance can be re-numbered or re-lettered, and typographical errors that do not affect the intent can be corrected with the authorization of the City Manager, or his or her designee, without the need for a public hearing.

SECTION 4. That if any clause, section, or other part of this Ordinance shall be held invalid or unconstitutional by any court of competent jurisdiction, the remainder of this Ordinance shall not be affected thereby, but shall remain in full force and effect.

SECTION 5. That all ordinances or parts of ordinances in conflict herewith are hereby repealed to the extent of such conflict.

SECTION 6. That this Ordinance shall be in full force and effect immediately after final passage and adoption.
